## **INDEPENDENT AUDITOR'S REPORT**

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Florida Sheriffs Youth Ranches, Inc. Employees' Pension Plan & Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report,

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

**1. Description of Plan:**

The following description of Florida Sheriffs Youth Ranches, Inc. Employees' Pension Plan & Trust (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

*General*

The Plan, established on February 1, 1964, is a defined contribution plan covering all full-time employees of Florida Sheriffs Youth Ranches, Inc. (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

*Eligibility*

Employees who are age 20 ½ or older and, effective January 1, 2024, have reached 60 days of service and are eligible to participate in the Plan, except union employees and non-resident aliens. Eligible employees may participate the first day of the month following the date the employee satisfies the Plan's eligibility requirements. Effective January 1, 2024, the Plan has an automatic enrollment provision (3% salary deferral with an annual 1% increase on the first day of the Plan year until reaching a maximum of 5%) whereby employees must elect out of the Plan if they do not wish to participate.

Employees who are age 20 ½, have completed one year of service with 1,000 hours for a year of crediting service, and are still employed at the end of the Plan year are eligible for any discretionary nonelective contributions for the Plan year, which may include a profit-sharing contribution.

*Contributions*

Each year participants may elect to contribute up to 100% of their annual compensation, as defined by the Plan, up to the maximum allowable under the Internal Revenue Code ("IRC"). In addition, employees who have attained age 50 by the end of the Plan year may make catch-up contributions up to limits defined by the IRS. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Company makes a safe harbor matching contribution equal to 100% of a participant's contribution up to 3% of eligible compensation plus 50% of the participant's contributions over 3% of eligible compensation up to 5%, subject to certain Plan limitations. The Company may also make additional discretionary nonelective contributions to the Plan. These contributions are allocated using a pro rata formula which is based on the ratio of the participant's qualifying compensation in relation to total compensation of all qualifying participants. No discretionary nonelective contributions were made in 2024.

*Participant Accounts*

Each participant's account is credited with the participant's contributions, allocations of Company contributions, and participant earnings. Participant earnings are based on an allocation of Plan earnings respective to each participant's account balances and investment selections. Any related administrative expenses based on participant earnings or account balances are deducted from the participant's account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested balance.

**1. Description of Plan (Continued):**

*Vesting*

Participants are immediately 100% vested in their elective deferrals, including catch-up contributions and rollover contributions from other plans, plus actual earnings thereon, as well as Company safe harbor matching contributions plus actual earnings thereon.

Vesting in the Company's discretionary nonelective contributions plus actual earnings thereon is based on years of continuous service with 1,000 hours for a year of crediting service. Participants are 100% vested in discretionary nonelective contributions after three years of service. All employer contributions become fully vested in the event of death, disability, or after reaching normal retirement age while under the Company's employment.

*Forfeited Accounts*

Forfeitures of non-vested participant balances may be used to pay Plan expenses and reduce future employer contributions. At December 31, 2024 and 2023, there were no forfeited non-vested account balances, and no forfeitures were used to pay Plan expenses or reduce employer contributions during 2024.

*Investment Options*

Participants may direct the investment of their account balances into various investment options offered by the Plan. The Plan currently offers a variety of mutual funds and a guaranteed investment contract as investment options for participants.

*Notes Receivable from Participants*

Participants may borrow from their accounts at a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and must be repaid in level payments through payroll deductions over a five-year period, except for loans for the purchase of a principal residence which may be repaid over a reasonable period that may be longer than five years. The loans bear interest at the prime rate as published by the Wall Street Journal plus one percentage point.

*Benefits Paid to Participants*

On termination of service due to death, disability, retirement or other reasons, a participant may elect to receive a lump-sum distribution equal to the value of the participant's vested interest in their account in accordance with Plan provisions. In-service withdrawals are allowed for participants who attain the age of 59 ½. Additionally, under certain circumstances of financial hardship, the participant is allowed to withdraw funds from the Plan. In-service and hardship withdrawals are subject to a minimum of \$500.

Account balances that are under \$7,000 will be automatically distributed upon termination of service as a lump sum without the consent of the participant.

**1. Description of Plan (Continued):**

*Administrative Expenses*

In accordance with Plan provisions, the Company or the Plan may pay administrative expenses of the Plan. Recordkeeping and other administrative services expenses are paid by the Plan and allocated to participant accounts. Plan expenses charged for transactions that are participant specific are deducted from the respective participant account.

Management fees and operating expenses charged to the Plan for investments in mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction in the investment return for such investments.

**2. Summary of Accounting Policies:**

*Basis of Accounting*

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

*Use of Estimates*

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition*

Investments are presented at fair value, except fully benefit-responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements. Contract value is the relative measurement attribute for that portion of the net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of investments are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded as earned on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. Realized gains and losses on the sales of securities are reported on the average cost method.

*Notes Receivable from Participants*

Notes receivable from participants are reported at amortized principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent notes receivable from participants are reclassified as distributed based upon the terms of the Plan document. The loans are secured by the balance in the participants' accounts.

**2. Summary of Accounting Policies (Continued):**

*Payment of Benefits*

Benefits are recorded when paid.

*Risks and Uncertainties*

The Plan invests in a combination of investment securities which are exposed to various risks, such as interest rates, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

**3. Fair Value Measurements:**

Financial Accounting Standards Board, Statement of Accounting Standards Codification Topic 820 ("ASC 820"), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date

Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly

Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable

In many cases, a valuation technique used to measure fair value includes inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy. The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

*Mutual funds:* The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

**4. Investment Contract with Insurance Company:**

The Plan invests in a fixed account group annuity contract with Great-West Life & Annuity Insurance Company (“GWI”) as of December 31, 2024 and 2023. The guaranteed investment contract is fully benefit-responsive, and as such contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed interest contract. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Contract value of the guaranteed investment contract was \$1,284,672 and \$1,197,651 at December 31, 2024 and 2023, respectively. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The guaranteed minimum interest rate credited to the contract is 0.10%. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include but may not be limited to the following: 1) complete or partial termination of the Plan, 2) the establishment or activation of, or material change in, any Plan investment fund, or 3) an amendment to the Plan or a change in the administration or operation of the Plan, including offering a competing fund (a fund with similar investment strategies and assets as the investment contract) without the approval of GWI. The guaranteed interest contract permits contract termination with sufficient notice or with other violations of the contractual terms.

**5. Information Certified by Custodians:**

Investments, except the guaranteed investment contract, included in the statements of net assets available for benefits as of December 31, 2024 and 2023, and the dividend and interest income and net appreciation in fair value of investments included in the statement of changes in net assets available for benefits for the year ended December 31, 2024, have been derived from information certified as complete and accurate by Empower Trust Company, LLC (“Empower”), custodian, in accordance with 29 CFR 2520.103-5(c) of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

The guaranteed investment contract included in the statements of net assets available for benefits as of December 31, 2024 and 2023, and the dividend and interest income and net appreciation in fair value of investments included in the statement of changes in net assets available for benefits for the year ended December 31, 2024, have been derived from information certified as complete and accurate by Empower Annuity Insurance Company of America, custodian, in accordance with 29 CFR 2520.103-5(c) of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

**6. Parties-in-Interest Transactions:**

Empower is the trustee, custodian, and recordkeeper for the Plan. Empower manages the GWI guaranteed investment contract; therefore, transactions involving these parties qualify as party-in-interest transactions permitted under provisions of ERISA. Fees paid to Empower entities, which are subsidiaries of GWI, by the Plan for recordkeeping and investment management services amounted to \$28,778 for the year ended December 31, 2024.

OneDigital Investment Advisors LLC (“OneDigital”) provides investment management and advisory services to the Plan. Accordingly, transactions with these companies qualify as party-in-interest transactions. During 2024, the Plan paid OneDigital \$12,895 for investment advisory services.

Included in the Plan assets are notes receivable from participants. At December 31, 2024 and 2023, notes receivable from participants amounted to \$98,251 and \$144,551, respectively. For the year ended December 31, 2024, interest income related to notes receivable from participants amounted to \$9,288. These transactions qualify as party-in-interest transactions permitted under provisions of ERISA.

**7. Plan Termination:**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants will become 100 % vested in their accounts.

**8. Tax Status:**

The Plan obtained a determination letter on November 14, 2022, in which the IRS stated that the Plan was designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and tax counsel believe the Plan is currently being operated in compliance with the applicable requirements of the IRS.

Management has evaluated the Plan's tax positions and concluded that the Plan had taken no uncertain tax positions that require recognition of liability (or asset) in the accompanying financial statements. With few exceptions, the Plan is no longer subject to income tax examination by the U.S. federal, state, or local tax authorities for years before 2021.

**9. Subsequent Events:**

Management has evaluated subsequent events through September 25, 2025, the date the financial statements were available to be filed, and has determined that there were no material events requiring recognition or disclosure.
