Independent Auditor's Report

To the Plan Administrator

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of DRB Enterprises, LLC 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

Note 1 - Description of Plan

The following description of the DRB Enterprises, LLC 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of DRB Enterprises, LLC (the "Company") and its affiliates except non-resident alien employees, leased employees, interns, seasonal employees who have worked less than 1,000 hours and all consultants as well as any employee who is included in a unit of employees covered by a collective bargaining agreement by the Company. An employee becomes eligible on the date they first perform an hour of service as an eligible employee. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

On November 1, 2018, the Plan was formally amended to allow the employees of Fielding Homes, LLC that was acquired on November 1, 2018, by the Company to enter the Plan immediately.

On April 15, 2020, the Plan was formally amended to allow the employees of DRB Group Eastern Shore, LLC that was established on April 15, 2020, by the Company to enter the Plan immediately.

On December 1, 2020, the Plan was formally amended to allow the employees of DRB Group Alabama, LLC and DRB Group Georgia, LLC that were acquired on December 1, 2020, by the Company to enter the Plan immediately.

On April 1, 2023, the Plan was formally amended to allow the employees of DRB Group Florida, LLC that were acquired on April 1, 2023, by the Company to enter the Plan immediately.

On March 1, 2024, the Plan was formally amended to allow the employees of Biscayne Homes, LLC, to enter the Plan immediately on March 1, 2024, for purposes of the Safe Harbor Matching Contributions if they have otherwise satisfied the plan's eligibility requirements as of this date counting prior service with Biscayne Homes, LLC or Biscayne Homes Realty, LLC.

On July 1, 2024, the Plan was formally amended to allow the employees of Biscayne Homes Realty, LLC, to enter the Plan immediately on July 1, 2024, for purposes of the Safe Harbor Matching Contributions if they have otherwise satisfied the plan's eligibility requirements as of this date counting prior service with Biscayne Homes, LLC or Biscayne Homes Realty, LLC.

Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Effective August 1, 2021, the Plan has been amended to allow Roth contributions. Participants direct the investment of contributions into various investment options offered by the Plan.

The Company contributes a safe harbor matching contribution of 100% of the first 5% of compensation that a participant contributes to the Plan. Additional amounts may be contributed at the Company's discretion, both limited to defined amounts by the Internal Revenue Service ("IRS") limitations. In order to receive this safe harbor matching contribution, an employee must be 21 years of age and have completed one year of service. For the year ended December 31, 2024, the Company made safe harbor matching contributions of \$2,447,901. The Company may contribute a profit-sharing contribution in its sole discretion for employees who have completed at

least 1,000 hours of service during the Plan year and are employed as of the last day of the Plan year. In order to receive this profit-sharing contribution, an employee must be 21 years of age and have completed one year of service. During 2024, no such profit-sharing contribution was made. Contributions are subject to certain IRS limitations.

Participant accounts

Each participant's account is credited with the participant's contributions and Company's contributions, as well as allocations of Plan earnings. Participants' accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions and the employer safe harbor matching contribution plus actual earnings thereon. A participant is 20% vested in the employer profit sharing contribution after one year of service is completed and vests an additional 20% per year until full vesting after five years.

Investment options

Based on the participants' elections, contributions and income are invested in investment funds offered through John Hancock Life Insurance Company (U.S.A.). Contributions must be made in whole percentages and allocations can be changed at any time.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years or up to 30 years for the purchase of a primary residence. A participant may only have one loan outstanding at any one time. The loan is secured by the balance in the participant's account. As of January 1, 2018, the loan interest rate was set at 1% above the prime rate. At December 31, 2024, the interest rate on outstanding loans varied between 3.25% and 9.50%. Principal and interest are paid through payroll deductions.

Payment of benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a 10-year period. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

Forfeited accounts

At December 31, 2024 and 2023, there were no forfeited nonvested accounts. These accounts, if any, would be used to restore forfeitures, reduce Company contributions or to pay reasonable plan expenses.

Note 2 - Summary of significant accounting policies

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosures of contingent asset and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, Custodian and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of benefits

Benefits are recorded when paid.

Expenses

All direct expenses of the Plan, Custodian, Plan administrator and Investment Fiduciary or any other person will be paid or reimbursed by the Company.

Subsequent events

The Plan has evaluated subsequent events through September 23, 2025, the date the financial statements were available to be used.

Note 3 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board issued Accounting Standards Codification 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;

- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value estimate.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Pooled separate accounts: Valued using net asset value ("NAV"), which is based on the fair value of the underlying assets of the account.

The following tables set forth by level, within the fair value hierarchy, the Plan's investments at fair value as of December 31, 2024 and 2023. Classification within fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

Note 4 - Related party transactions and party-in-interest transactions

Certain Plan investments are managed by John Hancock Life Insurance Company (U.S.A.) ("John Hancock"). John Hancock is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. During the audit period, the Plan paid recordkeeper fees of \$4,618 to John Hancock.

Note 5 - Plan termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right to discontinue its matching contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participating employees will become 100% vested in their accounts.

Note 6 - Tax status

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust have been designed in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified and the related trust is exempt.

Generally accepted accounting principles require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 - Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8 - Certified investments

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments and notes receivable from participants held at December 31, 2024 and 2023, and investment income and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023 that are disclosed in the accompanying financial statements and supplemental schedule, were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by John Hancock, the custodian of the Plan.
