**NOTE 1 – DESCRIPTION OF PLAN**

The following description of the Dynatrace Inc 401(k) Plan (Plan) provides only general information. The Plan document should be referred to for a more complete description of the Plan's provisions.

General: The Plan was established on January 1, 2019. The Plan covers all full-time and part-time U.S. employees of the Dynatrace LLC ("Company" or "Dynatrace"); which includes any parent, direct or indirect subsidiary, brother-sister corporation or division of the Company, who have completed one hour of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Dynatrace has entered into a trust agreement with Fidelity Management Trust Company (Fidelity) appointing Fidelity to act as trustee of the Plan.

Participant Contributions: Participants in the Plan may elect to defer up to 90% of their pre-tax pay each pay period, and up to 90% of their after-tax pay each pay period, with a combined maximum limit of 85% for investment in the Plan. A Roth 401(k) component is also available.

The Plan includes an automatic enrollment feature, wherein unless an active participant elected otherwise, they were deemed to have elected an automatic pre-tax contribution of 5% in the Plan with an automatic increase of 1% for the first seven years of participation. The automatic pre-tax contribution is effective as soon as administratively possible 30 days after the first day of employment.

The amount of pre-tax and Roth deferral contributions for each participant is limited to \$23,000 for the 2024 calendar year, based on the applicable provisions of the Internal Revenue Code. Participants who reach age 50 during the calendar year and are making the maximum Internal Revenue Service pre-tax contribution may make additional pre-tax "catch-up" contributions in accordance with the provisions of Code Section 414(v). The maximum annual catch-up contribution is \$7,500 for the 2024 calendar year.

The Company contributed a matching contribution to the Plan for active participants an amount equal to 50% of active participant's contribution not in excess of 6%. The Company may also make special discretionary contributions. A participant must be employed on the last day of Plan year to be eligible. No special discretionary contribution has been made for the year ended December 31, 2024. Participants are immediately vested in their own contributions and Employer matching contributions. Participants are fully vested in any special discretionary contributions after six years of service.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions, (b) Plan earnings (losses), net of investment management fees, and (c) forfeitures of employer contributions, and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Forfeited Accounts: As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$11,152 and \$21,205, respectively. These accounts may be allocated to remaining participants in the same manner as employer discretionary contributions or used for employer discretionary matching contributions or Plan administrative expenses.

Notes Receivable from Participants: Participants may have only one outstanding loan at any time. The maximum loan amount is equal to the lesser of \$50,000 or 50% of the participant's vested balance minus the highest outstanding loan balance in the past 12 months. Generally, loan terms range from 6 to 60 months. The loans are secured by the balance in the participant's account. Interest is paid quarterly at 1% above the Prime Interest Rate. Principal and interest is paid ratably through semi-monthly payroll deductions for salaried employees and via Fidelity's loan coupon service for hourly employees, terminated employees, and rehires.

Payment of Benefits: On termination of service due to death, disability, retirement, or other reasons, a participant may request to receive a lump-sum amount equal to the value of the participant's vested interest in the account. Benefit payments from merged plans shall be payable in such other forms as were permitted under the terms of the merged plan from which they were transferred.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the plan agreement to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions and earnings thereon.

Administrative and Investment Management Expenses: Loan origination fees and loan maintenance fees associated with notes receivable from participants are paid by the participants. Plan's record keeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses of the Plan. Quarterly recordkeeping expenses of the Plan are paid using the Plan forfeiture account. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan. All other expenses of the Plan are paid by the Company.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the period.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity and credit risks. Market risks include global events, like the COVID-19 pandemic. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 3 – CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the trustee of the Plan, Fidelity Management Trust Company.

**NOTE 4 – FAIR VALUE MEASUREMENTS**

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

*Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2:* Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

*Level 3:* Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Self-directed brokerage accounts – Accounts primarily consist of mutual funds and common stock that are determined by obtaining quoted prices on nationally recognized securities exchange (Level 1 inputs).

Collective Trusts: The fair values of participation units held in the collective trusts are based on the net asset values per unit as reported by the fund managers. The collective trusts provide for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement.

**NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. Certain Plan investments are mutual funds managed by Fidelity Investments, an affiliate of the Plan trustee, and a collective trust managed by Fidelity Management Trust Company. These transactions and the Plan's payment of fees to Fidelity Investments, Fidelity Management Trust Company, and Fidelity Investments Institutional, the recordkeeper to the Plan, and Strategic Advisors, Inc., advisors to the Plan, qualify as party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions.

**NOTE 6 – TAX STATUS**

The Plan adopted a prototype plan document at the inception of the Plan. The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the prototype Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code. While the Plan has been amended since the receipt of the determination letter, the Plan Administrator believes the Plan is designed and is currently being operated in accordance with applicable provisions of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by the Department of Labor or Internal Revenue Service, however, there are currently no audits for any tax periods in progress.

**NOTE 7 – RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500**

The following is a reconciliation of net assets available for benefits per the financial statements at December 31, 2023 to the Form 5500:

**NOTE 1 – DESCRIPTION OF PLAN**

The following description of the Dynatrace Inc 401(k) Plan (Plan) provides only general information. The Plan document should be referred to for a more complete description of the Plan's provisions.

General: The Plan was established on January 1, 2019. The Plan covers all full-time and part-time U.S. employees of the Dynatrace LLC ("Company" or "Dynatrace"); which includes any parent, direct or indirect subsidiary, brother-sister corporation or division of the Company, who have completed one hour of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Dynatrace has entered into a trust agreement with Fidelity Management Trust Company (Fidelity) appointing Fidelity to act as trustee of the Plan.

Participant Contributions: Participants in the Plan may elect to defer up to 90% of their pre-tax pay each pay period, and up to 90% of their after-tax pay each pay period, with a combined maximum limit of 85% for investment in the Plan. A Roth 401(k) component is also available.

The Plan includes an automatic enrollment feature, wherein unless an active participant elected otherwise, they were deemed to have elected an automatic pre-tax contribution of 5% in the Plan with an automatic increase of 1% for the first seven years of participation. The automatic pre-tax contribution is effective as soon as administratively possible 30 days after the first day of employment.

The amount of pre-tax and Roth deferral contributions for each participant is limited to \$23,000 for the 2024 calendar year, based on the applicable provisions of the Internal Revenue Code. Participants who reach age 50 during the calendar year and are making the maximum Internal Revenue Service pre-tax contribution may make additional pre-tax "catch-up" contributions in accordance with the provisions of Code Section 414(v). The maximum annual catch-up contribution is \$7,500 for the 2024 calendar year.

The Company contributed a matching contribution to the Plan for active participants an amount equal to 50% of active participant's contribution not in excess of 6%. The Company may also make special discretionary contributions. A participant must be employed on the last day of Plan year to be eligible. No special discretionary contribution has been made for the year ended December 31, 2024. Participants are immediately vested in their own contributions and Employer matching contributions. Participants are fully vested in any special discretionary contributions after six years of service.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions, (b) Plan earnings (losses), net of investment management fees, and (c) forfeitures of employer contributions, and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Forfeited Accounts: As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$11,152 and \$21,205, respectively. These accounts may be allocated to remaining participants in the same manner as employer discretionary contributions or used for employer discretionary matching contributions or Plan administrative expenses.

Notes Receivable from Participants: Participants may have only one outstanding loan at any time. The maximum loan amount is equal to the lesser of \$50,000 or 50% of the participant's vested balance minus the highest outstanding loan balance in the past 12 months. Generally, loan terms range from 6 to 60 months. The loans are secured by the balance in the participant's account. Interest is paid quarterly at 1% above the Prime Interest Rate. Principal and interest is paid ratably through semi-monthly payroll deductions for salaried employees and via Fidelity's loan coupon service for hourly employees, terminated employees, and rehires.

Payment of Benefits: On termination of service due to death, disability, retirement, or other reasons, a participant may request to receive a lump-sum amount equal to the value of the participant's vested interest in the account. Benefit payments from merged plans shall be payable in such other forms as were permitted under the terms of the merged plan from which they were transferred.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the plan agreement to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions and earnings thereon.

Administrative and Investment Management Expenses: Loan origination fees and loan maintenance fees associated with notes receivable from participants are paid by the participants. Plan's record keeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses of the Plan. Quarterly recordkeeping expenses of the Plan are paid using the Plan forfeiture account. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan. All other expenses of the Plan are paid by the Company.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the period.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity and credit risks. Market risks include global events, like the COVID-19 pandemic. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 3 – CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the trustee of the Plan, Fidelity Management Trust Company.

**NOTE 4 – FAIR VALUE MEASUREMENTS**

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

*Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2:* Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

*Level 3:* Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Self-directed brokerage accounts – Accounts primarily consist of mutual funds and common stock that are determined by obtaining quoted prices on nationally recognized securities exchange (Level 1 inputs).

Collective Trusts: The fair values of participation units held in the collective trusts are based on the net asset values per unit as reported by the fund managers. The collective trusts provide for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement.

Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. Certain Plan investments are mutual funds managed by Fidelity Investments, an affiliate of the Plan trustee, and a collective trust managed by Fidelity Management Trust Company. These transactions and the Plan's payment of fees to Fidelity Investments, Fidelity Management Trust Company, and Fidelity Investments Institutional, the recordkeeper to the Plan, and Strategic Advisors, Inc., advisors to the Plan, qualify as party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions.

**NOTE 6 – TAX STATUS**

The Plan adopted a prototype plan document at the inception of the Plan. The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the prototype Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code. While the Plan has been amended since the receipt of the determination letter, the Plan Administrator believes the Plan is designed and is currently being operated in accordance with applicable provisions of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by the Department of Labor or Internal Revenue Service, however, there are currently no audits for any tax periods in progress.
