**1. Description of Plan**

The following description of Cullum Mechanical Construction, Inc. 401k Retirement Savings and Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all employees of the Cullum Mechanical Construction, Inc. (the "Company") who have been employed by the Company a minimum of sixty consecutive calendar days in order to make elective deferrals and have completed one year of service in order to receive an allocation of non-elective contributions and matching contributions. Participants must be at least eighteen years old to receive an allocation of non-elective contributions and matching contributions. Participants may enter the Plan on the first day of the month after which the participant meets the Plan's eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and has received a favorable determination letter from the Internal Revenue Service.

**Contributions**

Each year, participants may contribute an elected amount of pretax annual compensation or after-tax ROTH contributions, as defined in the Plan. Participants who are age fifty or older by the end of the year are eligible to make an additional catch-up contribution to the Plan. With the Trustee's consent, participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the plan.

The Plan has implemented an automatic enrollment provision. Eligible employees without a salary deferral election on file are automatically enrolled in the Plan with a deferral rate equal to six percent of the participant's eligible compensation.

The Company may contribute on behalf of each participant a matching contribution or non-elective contribution to be determined each year by the Board of Directors. Company contributions are invested into the investment options elected by the participant. For the plan year ended December 31, 2024, the Company elected to make a discretionary contribution to the plan in the amount of \$375,000. The Company did not make a non-elective contribution for the year ended December 31, 2024.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of the Company's contribution and Plan earnings and charged with an allocation of administrative expenses. Allocations of Company contributions are based on a match of participant deferrals. Allocations of Plan earnings and administrative expenses are based on account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their elective contributions plus actual earnings thereon. Vesting in the Company's discretionary contribution plus actual earnings thereon is based on years of credited service. A participant vests according to the following schedule:

<u>Years of Service</u>	<u>Vesting Percentage</u>
Less than two years	0%
More than two years, less than three years	20%
More than three years, less than four years	40%
More than four years, less than five years	60%
More than five years, less than six years	80%
More than six years	100%

**Investment Options**

Upon enrollment in the Plan, a participant may direct employee contributions into any of the available investment options offered under the Plan. The Plan currently offers various mutual funds, a money market account and a common collective trust fund as investment options for participants. Participants may change their investment options as often as permitted under the investment vehicles chosen by the participant.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Participant loans are valued at their unpaid principal balances, plus all accrued but unpaid interest. The loans are secured by the balance in the participant's account and bear interest at prime rate plus 2%. The interest rate on outstanding participant loans at December 31, 2024 ranged from 3.25% - 9.50%. Principal and interest is paid ratably through weekly payroll deductions.

**Payment of Benefits**

On termination of service due to death, disability or retirement, a participant may elect to receive benefits in either a lump-sum amount equal to the value of the participant's interest in his or her account or monthly over certain annuity options. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Participants may also request hardship distributions for reasons specified in the plan document.

**Forfeitures**

Forfeiture amounts are used by the Plan to pay administrative expenses of the Plan. Any remaining forfeitures may be used to reduce any employer contributions to the Plan. Forfeitures generated for the years ended December 31, 2024 and 2023 totaled \$12,949 and \$17,523, respectively. There were \$0 and \$4,278 of unused forfeitures at December 31, 2024 and 2023, respectively. Forfeitures and associated account earnings totaling \$17,423 were utilized during 2024 to pay administrative expenses of the Plan.

## **2. Summary of Significant Accounting Policies**

### **Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting.

### **Use of Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the Plan's investment advisors and custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded for tax purposes. Deemed distributed loans continue to be reported in the Plan's financial statements until the participant has reached a distributable event.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

### **Subsequent Events**

The Plan has evaluated subsequent events through July 23, 2025, the date the financial statements were available to be issued.

**New Accounting Pronouncements**

On December 29, 2022, the SECURE 2.0 Act of 2022 was signed into law. This act contains provisions that go into effect at various times starting in the 2023 year and ending in 2033. The deadline for adopting any required plan amendments pursuant to the SECURE 2.0 Act is December 31, 2026; however, plans must be operated in accordance with the effective date of each new provision. Management has reviewed the provisions effective for 2024 and continues to monitor and adjust operations in accordance with provisions as they become effective. As of December 31, 2024, no formal Plan amendments have been made to adopt SECURE 2.0 Act provisions. Management has determined that the Plan was in compliance with all applicable provisions for the year ended December 31, 2024.

**4. Fair Value Measurements**

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Basis of Fair Value Measurement**

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2 Inputs to the valuation methodology include

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment, and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. Common Collective Trust Funds**

The common collective trust funds held by the Plan consist entirely of the Gaillard Stable Return Fund C (formerly Wells Fargo Stable Value Fund C) (the Fund). At December 31, 2024 and 2023 the Fund has invested all of its assets in Gaillard Stable Return Fund Core, a collective trust fund established under the Allspring Collective Investment Trust which is governed by the Allspring Collective Trust Declaration of Trust. The value of this investment is based on the underlying unit value reported by Gaillard Stable Return Fund Core. As of December 31, 2024 and 2023 respectively, the Fund held a 25.26% and 24.03% ownership interest in Gaillard Stable Return Fund Core.

The Gaillard Stable Return Fund Core invests in investment contracts and security-backed contracts. An investment contract is a contract issued by a financial institution to provide a stated rate of return to the buyer of the contract for a specified period of time. A security-backed contract has similar characteristics as a traditional investment contract and is comprised of two parts: the first part is a fixed-income security or portfolio of fixed-income securities; the second part is a contract value guarantee (wrapper) provided by a third party. Wrappers provide contract value payments for certain participant-initiated withdrawals and transfers, a floor crediting rate, and return of fully accrued contract value at maturity.

There are several risks specific to investment contracts. One of the primary risks involved is credit risk of the contract issuer. Credit risk for security-backed contracts includes risk arising from the potential liability of the issuer to meet the terms of the contract wrapper and the potential default of the underlying fixed-income securities. Secondly, liquidity is limited because of the unique characteristics of investment contracts and the absence of an actively traded secondary market. Interest rate risk is also present because rates may be fixed with these products.

The Gaillard Stable Value Fund C is fully-benefit responsive and has been reported in the Statement of Net Assets Available for Benefits at contract value. A reconciliation of fair value to contract value for the plan years ended December 31, 2024 and 2023 is as follows:

**6. Unallocated Asset Holdings**

For the 2021 plan year, the Company funded employer contributions to the plan totaling \$250,000 prior to the end of the plan year. These funds remained in a suspense account within the Plan until the final calculation for the allocation of the employer contribution was completed in 2022 and funds were allocated out to plan participants. While held in suspense, the funds accumulated interest income. At December 31, 2024 and 2023 the Plan held \$2,990 and \$2,905, respectively, of unallocated assets. These assets are included in the Plan's common collective trust fund account balance reported in the Statement of Net Assets Available for Benefits.

**7. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the individual participant account statements and the Statement of Net assets Available for Benefits.

**8. Related Party and Party-in-Interest Transactions**

The Company provides certain accounting, administrative and investment management services to the Plan for which no fees are charged.

**9. Tax Status**

Effective January 1, 2021, the Plan was restated to adopt a prototype plan offered by Ascensus Trust Company. The Internal Revenue Service has determined and informed Ascensus by a letter dated June 30, 2020, that the plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the plan is qualified and tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the notes to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**10. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the plan to discontinue its contributions at any time and to terminate the plan, subject to plan provisions and ERISA. In the event of plan termination, participants would become 100% vested in the company contributions portion of their account.
