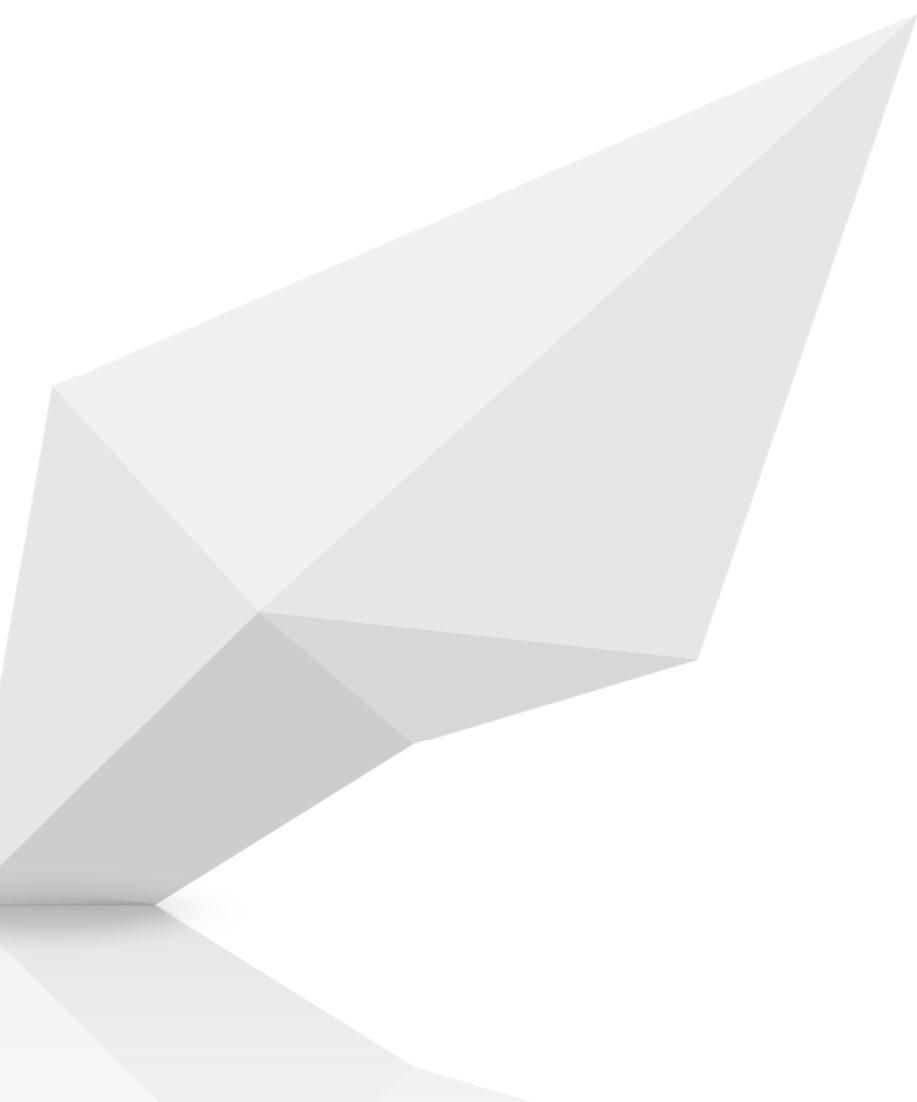

### Note 1: Description of Plan

The following description of the Health Center Partners 403(b) Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan originally effective May 1, 1998. The Plan has been amended throughout the years to comply with tax legislation and most recently amended effective January 1, 2024. The Plan is intended to satisfy all of the requirements for a qualified retirement plan under Section 403(b)(7) of the Internal Revenue Code (IRC) and similar tax laws. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan administrator is responsible for the oversight of the Plan.

#### Eligibility

Employees of Health Center Partners of Southern California (the "Employer") are eligible to participate in the deferral and match components of the Plan immediately unless they are part of an excluded class.

#### Contributions

The Plan provides for employee pre-tax or Roth contributions up to a maximum of 100% of the annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Service ("IRS"). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants are enrolled in the Plan at 3%, unless they affirmatively elect a different salary deferral rate. Annually, the automatic deferral rate increases by 1%. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Employer may make a discretionary matching contribution as determined and authorized by the Board of Directors of the Employer. For the year ended December 31, 2024, the Employer matched elective deferrals at a rate of 50% up to 6% of the participant's eligible compensation. Total Employer matching contributions in 2024 were \$364,969. In addition, the Employer can elect to contribute a discretionary non-elective contribution as determined by the Board of Directors. For the year ended December 31, 2024, there was no Employer discretionary non-elective contribution.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan.

#### Participant Accounts

Each participant's account is credited with the participant's contributions, Employer discretionary matching contributions, Employer discretionary non-elective contributions, and allocations of plan earnings (losses) and is charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Note 1: Description of Plan (Continued)

#### Vesting

Participants immediately vest in their voluntary contributions plus actual earnings thereon. Vesting in the Company's discretionary matching contributions and discretionary non-elective contributions portion of a participant's accounts is based on the numbers of years of service.

Company's matching and discretionary non-elective contributions vest according to the following schedule:

<u>Years of Service</u>	<u>Employer Contributions</u>
Less than 1 year	0 %
1 year but less than 2 years	0 %
2 years but less than 3 years	50 %
3 years or more	100 %

Participants are considered to have completed one year of service for the purpose of vesting upon the completion of 1,000 hours of service at any time during 12 consecutive months.

#### Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan interest is determined at the time the loan is taken out and is paid back to the participant's accounts. The notes are secured by the balance in the participant's account and bear interest rates ranging from 4.25% - 9.50%, which are rates that commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest is paid ratably throughout payroll deductions.

#### Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive either a lump-sum distribution equal to the value of the participant's vested interest in his or her account, or a direct rollover to another eligible retirement plan. The Plan allows for in-service distributions if a participant reaches age 59 1/2 and hardship distributions subject to Plan provisions. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan administrator will authorize the benefit payments without the participant's consent. If the balance of the terminated participant's account is between \$1,000 and \$5,000, the Plan Sponsor may authorize that the benefit payment be rolled into an individual retirement account in the participant's name.

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses.

### **Note 1: Description of Plan (Continued)**

#### **Forfeitures**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$9,253 and \$79,007, respectively. These accounts will be used to reduce future Plan contributions or to pay administrative expenses of the Plan in accordance with the plan document. Also, during the year ended December 31, 2024, Plan contributions were reduced by \$89,350 from forfeited nonvested accounts.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### **Use of Estimates**

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

#### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value except for fully benefit-responsive investment contracts (FBRICs). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

FBRICs are reported at contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

#### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### Subsequent Events

The Plan has evaluated subsequent events through September 29, 2025, which is the date the financial statements were available to be issued.

### Note 3: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

### Note 4: Fully Benefit-Responsive Investment Contracts

The Plan entered into guaranteed investment contracts with Lincoln National Life Insurance Company ("Lincoln") and Empower Annuity Insurance Company of America ("Empower"). Empower and Lincoln maintain the contributions in a general account. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based a formula established by the contract issuer but may not be less than 1%. The crediting rate is reviewed on a semi-annual basis for resetting. The guaranteed investment contracts do not permit Empower or Lincoln to terminate the agreements prior to the scheduled maturity date.

These contracts meet the fully benefit-responsive investment contract criteria and therefore, are reported at contract value. Contract value, as reported to the Plan by Lincoln and Empower, represent contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due in accordance with the FBRICs is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Generally, there are not any events that might limit the ability of the Plan to transact at contract value with the issuers. In addition, there are not any events that allow the issuers to terminate the contracts with the Plan and settle at amounts different than contract value.

### **Note 5: Information Prepared and Certified by the Custodians**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments, fully benefit-responsive contracts, and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest income on notes receivable from participants, and interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower Annuity Insurance Company of America, Empower Trust Company, LLC, and Lincoln National Life Insurance Company, the Custodians of the Plan.

### **Note 6: Party-In-Interest Transactions**

Certain Plan investments were managed by Empower Annuity Insurance Company of America, Empower Trust Company, LLC and Lincoln National Life Insurance Company, the Custodians of the Plan. Therefore, the investment transactions qualify as party-in-interest transactions. Empower Retirement, LLC is the record-keeper, as defined by the Plan and also qualifies as party-in interest, which is exempt from the prohibited transaction rules. Fees incurred and paid for investment and administrative services were \$35,853. Certain fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather a direct payment.

Notes receivable from participants qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

### **Note 7: Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company's contributions.

### **Note 8: Tax Status**

The Plan is placing reliance on an opinion letter dated March 31, 2017, received from the Internal Revenue Service on the volume submitter plan indicating that the Plan is qualified under Section 401 of the IRC and is therefore not subject to tax under the current income tax law. The volume submitter plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

### **Note 9: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
