We have performed an audit of the financial statements of MFS Supply, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

MFS Supply, LLC 401(k) Plan

1 Description of Plan

The following description of the MFS Supply, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General:

The Plan, which began January 1, 2008, is a defined contribution plan covering all employees of MFS Supply, LLC and Seyear Management, LLC (together the “Company”) who meet the eligibility and service requirements. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan was amended and restated as of January 1, 2024 to update certain plan definitions.

In April 2024, the Company changed service providers of the third party administrator.

Eligibility:

All employees, other than union, part time and non-resident alien employees of the Company who complete two months of service and are 18 years old are eligible to participate in the Plan.

Contributions:

Employee Contributions - Participants may elect a portion of their compensation from 1% to 90% to be contributed to the Plan by the Company. The Plan also allows for employee Roth contributions. Effective August 1, 2022, the Plan was amended and restated to add an automatic enrollment feature for new hires where 4% of compensation is contributed to the Plan. Catch-up contributions are allowed to be made by participants

Employer Contributions - During 2024 and 2023, the Company made contributions to each eligible participant's account by matching elective deferrals for the plan year in the amount of 50% up to the first 4% of employee deferrals.

Employer Discretionary Contributions - The Company may also make additional contributions. Such additional contributions, if any, shall be allocated to each participant in proportion to his or her compensation for the calendar year. The Plan also allows for qualified non-elective contributions. There were no discretionary contributions made in 2024 or 2023.

Rollover contributions from other Plans are also accepted, providing certain specified conditions are met.

Contributions are subject to limitations on annual additions and other limitations imposed by the Internal Revenue Code, as defined in the Plan agreement.

MFS Supply, LLC 401(k) Plan

1 Description of Plan, Continued

Participants' Accounts:

Each participant's account is credited with the participant's elective contributions, employer matching contributions, employer discretionary contributions, earnings, and losses thereon.

Vesting:

All participants are 100% vested in elective deferrals, qualified non-elective contributions and rollover contributions made to the Plan.

Vesting in the employer contributions and discretionary contributions is based on years of service. A participant is vested as follows:

<u>Years of Service</u>	<u>Vested %</u>
1	33.33%
2	66.66%
3	100%

Forfeitures:

Forfeitures due to termination from the Plan before a participant is 100% vested shall be used for reducing future matching contributions or to pay for Plan expenses. Forfeitures of \$11,870 (2024) and \$26,500 (2023) were used to reduce employer contributions or pay Plan expenses. As of December 31, 2024 and 2023, ending forfeitures were \$18,179 and \$3,932, respectively.

Notes Receivable from Participants:

Loans are permitted under certain circumstances and are subject to limitations. Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loans are repaid over a period not to exceed five years with exceptions for the purchase of a primary residence.

Loans are valued at unpaid principal plus accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

The loans are secured by the balance in the participant's account and bear interest at rates established by the Trustee. Principal and interest are paid ratably through payroll deductions.

Other Plan Provisions:

Normal retirement age is 65, however, a participant may elect early retirement on or after age 59-1/2.

1 Description of Plan, Continued

Payment of Benefits:

Upon termination of service by reason of separation of service, retirement, death or total and permanent disability, a participant receives a lump sum amount equal to the value of his or her account. Benefits are recorded when paid.

Hardship Withdrawals:

Hardship withdrawals are permitted in accordance with Internal Revenue Service guidelines.

Investment Options:

Upon enrollment in the Plan, a participant may direct any contributions to any of the investment options offered by the Plan.

2 Summary of Significant Accounting Policies

Basis of Accounting:

The Plan's transactions are reported on the accrual basis of accounting.

Contributions:

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Valuation of Investments:

Investments are stated at fair value. Marketable securities are reported at fair market value as of the balance sheet date. Fair market values represent quoted market prices or, if quoted market prices are not available, estimated fair values as determined by the Plan's investment broker. The fair values of the collective trust funds are based on the underlying net asset values of the funds. The fair value of the guaranteed investment contract is the sum of participant contributions to the fund plus interest at a stated rate (contract value approximate fair value).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments purchased and sold as held during the year.

Use of Estimates:

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

NOTES TO FINANCIAL STATEMENTS

2 Summary of Significant Accounting Policies, Continued

Administrative Fees:

Administrative expenses of the Plan are paid by either the Plan or the Company.

Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

Risks and Uncertainties:

The Plan's investments include investments in mutual funds, collective trust funds, and a guaranteed interest account with varying degrees of risk, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the Statement of Net Assets Available for Plan Benefits.

Subsequent Events:

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements.

Subsequent events have been evaluated through September 8, 2025, which is the date the financial statements were available to be issued.

3 Tax Status

On June 30, 2020, the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended, however, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more-likely-than-not would not be sustained upon examination by applicable taxing authorities. The Plan Administrator has analyzed tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. However, currently no audits for any tax periods are in progress.

4 Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- * Quoted prices for similar assets or liabilities in active markets.
- * Quoted prices for identical or similar assets or liabilities in inactive markets.
- * Inputs other than quoted prices that are observable for the asset or liability.
- * Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs that are unobservable inputs for the asset or liability.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds:

The fair value of the mutual funds is based on quoted market prices.

Collective Trust Funds:

The fair values of the collective trust funds are based on net asset value as calculated by dividing the total fair value of the assets of the funds, less its liabilities, by the total number of units outstanding. The collective trust funds consist of separate funds with differing investment objectives. The funds hold investments in units of the underlying funds. The funds sell new units and repurchase outstanding units on a daily basis and there are no unfunded commitments. The funds have the ability to redeem their investments in the portfolio funds at net asset value without restrictions. The funds require the Plan sponsor to provide a five-day written notice for any withdrawals which may exceed \$1 million.

Guaranteed Interest Account:

The fair value of the guaranteed interest account is based on the sum of participants contributions plus interest at a stated rate (contract value approximates fair value). The fair value is expressed in units. Participants can transact with the fund on a daily basis and there are no unfunded commitments. The guaranteed interest account is classified in the Level 2 category of the valuation hierarchy.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.
