Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Eucon Corporation Retirement Benefit Program, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Eucon Corporation Retirement Benefit Program's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Eucon Corporation Retirement Benefit Program and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Notes to Financial Statements

Note 1 – Plan Description

The following description of the Eucon Corporation Retirement Benefit Program (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General – The Plan is a 401(k) salary deferral and profit sharing plan covering substantially all employees of related companies and subsidiaries of Eucon Corporation (Company) who are eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Subsidiaries and related companies included in the Plan are as follows:

- Atlas Sand and Rock, Inc.
- DeAtley Crushing Company
- Eucon Corporation
- M.A. DeAtley Construction, Inc.

Effective July 1, 2023, the Plan was amended and restated, switching from an individually designed plan to a pre-approved prototype plan. There were no significant changes to the Plan related to eligibility, contributions, vesting, or distributions.

Eligibility – Employees of the Company are eligible for elective deferrals upon reaching the age of 19 and after completing 90 days of service in which at least 250 hours are worked.

To become a participant eligible to receive employer profit sharing and matching contributions, an employee must complete one year of service and attain age 19. After the employee meets eligibility requirements, each subsequent year the employee must complete at least 1,000 hours of service during each Plan year and be employed as of the last day of the Plan year to be eligible to receive any employer contributions.

Employees are eligible to receive a prevailing wage contribution on the first date of employment, provided they work on state or federal prevailing wage jobs and are not covered by a collective bargaining agreement. Additionally, excluded employees are those who are a Native American Tribal member employed through a Tribal Employment Rights Office as a nonbenefits worker or a temporary employee hired for a pre-established period, for completion of a specific project, or for vacation relief.

Contributions – Participants may elect to contribute between 1% and 100% of eligible compensation to the Plan each year. Participants who have reached age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan maintains an automatic enrollment feature for all eligible participants. Any eligible employee who does not complete a salary reduction agreement or an opt-out form by their eligibility date will be automatically enrolled in the Plan. The employee is automatically enrolled with a deferral rate of 3%. This rate increases in increments of 3% on July 1 of each new year until it reaches a maximum deferral rate of 6%.

Participants may direct the investment of their account balances into various investment options offered by the Plan. The Plan currently offers various mutual funds and money market funds as investment options for participants.

The Company may elect to make discretionary matching and profit sharing contributions to the Plan. The Company matched 100% of employee contributions up to 6% of annual plan compensation. Matching contributions totaled \$924,317 during the year ended December 31, 2024. Profit sharing contributions are allocated to participants in the same proportion as a participant's compensation bears to the total of all participants' compensation. There were no elective profit sharing contributions made during the year ended December 31, 2024.

The employers also make contributions to eligible employees who worked on prevailing wage jobs equal to the total amount allowed under state or federal prevailing wage law and the Plan document. Prevailing wage contributions totaled \$312,190 during the year ended December 31, 2024.

The difference between the employer contributions noted above and what is represented in the statement of changes in net assets, is due to forfeitures of \$70,605 used to reduce employer matching contributions.

Contributions are subject to regulatory limitations.

Participant accounts – Each participant's deferral account is credited with: (a) the participant's contribution and (b) its share of net income (loss) attributable to the deferral account. A participant's deferral account shall be fully vested and nonforfeitable at all times. Each participant's profit sharing and matching account is credited with an allocation of: (a) the Company's contribution, (b) Plan earnings and/or losses, and (c) administrative expenses. Each participant's rollover account is credited with: (a) the rollover contributions made on his or her behalf and (b) its share of the trust's net income attributable to the rollover accounts. The benefit entitled to each participant is the vested portion of their account.

Vesting – Participants are fully vested in their voluntary contributions and prevailing wage contributions plus actual earnings. Vesting in Company matching and profit-sharing contributions is based on years of service with increases in increments of 20% per year after the second year until fully vested after six years.

Notes receivable from participants – Participants are allowed to borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes are secured by the balance in the participant's account and bear fixed, reasonable rates of interest, as determined by the Plan administrator. The maximum note term is five years unless the note term qualifies as a home loan, in which case the term of the note is not to exceed 30 years. Principal and interest are repaid ratably through weekly payroll deductions. As of December 31, 2024, the rates of interest on outstanding loans ranged from 4.25% to 9.50%, with various maturity dates through February 2037.

Payment of benefits – Upon termination of employment due to death, disability, or retirement, the participant's Plan interest becomes 100% vested, even if they otherwise would have a vested interest less than 100%. Normal retirement age under the Plan is 65.

The Plan permits in service benefit payments on voluntary participant contributions and earnings thereon after a participant attains age 59½.

If the participant terminates employment before retirement, and if their vested account balance, excluding rollover contributions, does not exceed \$5,000, the Plan does not permit the participant to receive a distribution in any form other than a lump sum.

If the participant's account balance, excluding rollover contributions, exceeds \$5,000, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or installment payments over a specified period of time, not exceeding life expectancy or the joint life expectancy of the participant and his/her designated beneficiary.

Forfeitures – The forfeited balances of terminated participants' nonvested accounts will be used to offset employer matching contributions for the Plan year in which the forfeitures occur. During the year ended December 31, 2024, forfeitures used to reduce employer matching contributions totaled \$70,605. As of December 31, 2024 and 2023, there were no unused forfeited nonvested amounts.

Note 2 – Significant Accounting Policies

Basis of accounting – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America using the accrual basis of accounting.

Accounting estimates – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the use of estimates and assumptions that may affect certain amounts and disclosures in the financial statements. Accordingly, actual results could differ from those estimates.

Investment valuation – Investments are stated at fair value. The Plan's custodian, Matrix Trust Company, certifies the fair market value of investments at December 31, 2024 and 2023. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (exit price) in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Income recognition – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation in the fair value of investments consists of both the realized gains or losses and unrealized appreciation and depreciation of those investments.

Notes receivable from participants – Notes receivable from participants are measured at amortized cost, which represents the unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable from participants are recorded as distributions upon the occurrence of a distributable event, based on the terms of the Plan agreement.

Payment of benefits – Benefits are recorded when paid.

Administrative expenses – Administrative expenses related to operating and maintaining the Plan are paid by the Company. Certain investment and transaction fees are paid by participants in the Plan.

Subsequent events – Subsequent events are events or transactions that occur after the statements of net assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statements of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan’s financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statements of net assets available for benefits but arose after the statements of net assets available for benefits date and before the financial statements are available to be issued.

As of January 1, 2025, M.A. DeAtley Construction, Inc. will no longer be a Participating Employer in the Plan. This amendment is effective January 1, 2025.

The Plan has evaluated subsequent events through September 11, 2025, which is the date the financial statements are available to be issued.

Note 3 – Investments

Nonparticipant-directed investments – Investments in the Plan are participant-directed, except for certain employer contributions into a trust, which are invested as directed by a fund manager. After eligibility requirements, as discussed in Note 1, are met, employer contributions become participant directed and are allocated to participant accounts. Note 4 – Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

Basis of Fair Value Measurement –

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques should maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies (mutual funds) – Valued using the net asset value (NAV) provided by the fund administrator. These funds are required to publish their daily NAV and to transact at that price. The funds held by the Plan are deemed to be actively traded. The NAV is a quoted price in an active market and is classified within Level 1 of the valuation hierarchy. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission.

Money market – The money market deposit account is a deposit in an interest-bearing cash account. The cost approximates fair value.

Note 5 – Tax Status

The Plan document is a prototype standardized defined contribution plan that received a favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, which stated that the Plan, as then designed, was in accordance with applicable sections of the IRC. Although the Plan has been restated and amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

In accordance with guidance on accounting for uncertainty in income taxes, management has evaluated the Plan's tax positions and does not believe that the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. It is reasonably possible that, given the level of risk associated with investment securities, changes in the near term could materially affect participants' account balances and the amounts reported in the financial statements.

Note 7 – Information Certified by the Custodian

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Matrix Trust Company, custodian of the Plan, has certified to the completeness and accuracy of:

- Investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.

- Net appreciation in the fair value of investments and interest and dividends reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments reflected on the supplemental schedule of assets (held at end of year), excluding notes receivable from participants.

Note 8 – Party-in-Interest Transactions

Plan investments include money market funds managed by Matrix Trust, the custodian of the Plan; and therefore, transactions with this entity qualify as exempt party-in-interest transactions. The Plan holds notes receivable from participants, which qualify as party-in-interest transactions.

Note 9 – Plan Termination

Although it has not expressed any intention to do so, the Company has the right to terminate the Plan and discontinue its contributions at any time. If the Plan is terminated, amounts allocated to participants' accounts become fully vested.
