1. Description of Plan

The following description of the Great Bowery, Inc. 401(k) Profit Sharing Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

a. General

The Plan is a defined contribution plan more commonly known as a 401(k) plan covering substantially all employees of Great Bowery Inc. 401(k) Plan (the “Company”) and its wholly owned subsidiaries who have met certain requirements as to age and length of service as laid out in the Plan Document. The Plan was established on January 1, 2008 and was amended on January 1, 2021. The Plan is subject to the provisions of the Employees Retirement Income Security Act of 1974 (ERISA). The Board of Trustees oversees governance of the Plan. The Plan's Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Trustees.

b. Eligibility

Employees are eligible to participate in the Plan once they have reached age 21 and completed 90 days of service. Automatically excluded employees are those covered under a collective bargaining agreement (i.e., union employees) and non-resident aliens who do not receive compensation from any U.S. sources.

c. Contributions

Participants may contribute up to 100% of the participant's annual compensation, as defined by the Plan, not to exceed \$23,000 and \$22,500 in 2024 and 2023, respectively. The annual base salary for purposes of the Plan is limited by the Internal Revenue Code (“IRC”) to \$345,000 and \$330,000 for the year ended December 31, 2024 and 2023, respectively. A participant may also rollover amounts representing distributions from other qualified contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to \$7,500 and \$7,500 in 2024 and 2023, respectively.

c. Contributions (continued)

The Plan is a Safe Harbor plan. The Company will contribute a safe harbor matching contribution in an amount equal to 100% of the employee contribution not in excess of 3% of the employee's compensation, plus 50% of the matched employee contribution in excess of 3% of their compensation but not to exceed 5% of the employee's compensation. Matching contributions were \$353,433 and \$406,899 for the years ended December 31, 2024 and 2023, respectively.

The Company, in its sole discretion, may make a profit-sharing contribution to the Plan. Participants are eligible to receive profit sharing contributions after 1,000 hours of service during the Plan years. No profit-sharing contribution was made in 2024 and 2023.

d. Participants Accounts

Each participant's account is credited with the participant's contributions, Company matching contributions, Plan earnings, and withdrawals, and charged with an allocation of investment gains or losses, and administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transaction, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

e. Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service. A participant is 100% vested in employer safe harbor matching funds immediately and 100% vested in profit sharing funds after six years of credited service or at the normal retirement date. Upon disability or death, participants become fully vested.

f. Notes Receivable from Participants

The Plan permits participants to borrow from their fund accounts up to the lesser of \$50,000 or 50% of the vested balance. The notes are secured by the balance in the participant's account and bear interest at the prime rate plus 1% which is commiserate with local prevailing rates. Principal and interest are paid ratably through payroll deductions and notes must be fully repaid within five years. Participant notes are valued at their outstanding principal balance plus accrued and unpaid interest.

g. Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive benefits by a lump-sum amount equal to the value of the participant's vested interest in their account in cash, by a joint and survivor annuity, a life annuity made over the remaining life of the participant or payments made over the life of the participant and a designated beneficiary.

h. Forfeited Accounts

Non-vested portions of a participant's account balance will be forfeited when the participant receives a distribution of the entire vested benefits. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$11,131 and \$5,488 respectively. The forfeited amounts are transferred to a holding account until they are used to first pay any plan expenses, then if any forfeitures remain, they will reduce participating employers' matching contributions. For the year ended December 31, 2024 and 2023 there were no forfeitures used during the Plan year.

i. New Authoritative Pronouncements and Legislation

On December 29, 2022, the Consolidated Appropriations Act of 2023 was signed into law, which includes the package of retirement provisions referred to as "SECURE 2.0." These provisions continue the themes and reforms that began with the 2019 SECURE Act, focusing on getting more participants into the retirement system and finding ways for them to accumulate more assets. These changes have various effective dates starting in 2023 and forward. Since the provisions include both required and optional elements, the Plan administrator will determine the optional provisions to elect.

2. Summary of Accounting Policies

a. Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America, except that benefits paid to Plan participants are recorded on a cash basis.

b. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of certain assets and liabilities and changes therein and, disclosure of contingent assets and liabilities. Accordingly, the actual amounts could differ from those estimates.

c. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

d. Notes Receivable from Participants

Notes receivable from participants is measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. The Plan had outstanding notes receivable from participants with principal balances totaling \$12,664 and \$36,963, as of December 31, 2024 and 2023, respectively.

e. Contributions

Contributions from participants are recorded when the Company makes payroll deductions, Employer matching contributions are calculated, funded and recorded at the same time in which the Company makes payroll deductions. Contributions receivable represent amounts not yet deposited into the participants' individual accounts.

f. Payment of Benefits

Benefit payments to participants are recorded when paid.

g. Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

h. Date of Management's Review of Subsequent Events

The company has evaluated events occurring subsequent to December 31, 2024 through September 15, 2025, the date on which the financial statements were available to be issued.

3. Information Prepared and Certified by Custodian

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus Trust Company ("Ascensus"), the trustee of the Plan.

4. Fair Value Measurements

Fair Value Measurements in accordance with current accounting standards, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

4. Fair Value Measurements (continued)

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Mutual funds are valued at quoted market prices in an exchange and active market and are classified as Level 1 investments.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

6. Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the Determination Letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than now would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Related-Party and Party-in-Interest Transactions

At December 31, 2024 and 2023, the Plan held units in various mutual funds managed by Ascensus Trust Company ("Ascensus"), the trustee of the Plan. These transactions qualify as allowable party-in-interest transactions under the provisions of ERISA. Ascensus provides certain administrative services to the Plan as compensation of managing investments.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

9. Forfeitures

During the years ended December 31, 2024 and 2023, the Plan Sponsor made excess contributions of \$10,157 and \$7,374, respectively. These amounts were identified as excess contributions and are reflected as a reduction of investments on the accompanying Statements of Net Assets Available for Benefits. The excess contributions remained in the Plan as of year-end and are expected to be returned to the plan sponsor in accordance with applicable regulations.
