1. DESCRIPTION OF THE PLAN

The following description of Control Solutions, Inc. 401(k) Plan ("Plan") provides only general information. Participants should refer to the legal Plan document for a more complete description of the Plan's provisions.

General

The Plan was originally effective on November 1, 1994, and was amended and restated on October 1, 2021, to conform to new tax laws and regulations. The Plan is a qualified retirement plan of Control Solutions, Inc. ("Company") to provide employees with the opportunity to save for retirement on a tax-advantaged basis. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Bonide Products LLC is another employer who has adopted the provisions of the Plan.

Eligibility

The Plan allows employees to participate in the Plan when they have completed 1 month of service and have attained age 18. Part-time, temporary, seasonal, or reclassified employees are excluded from the Plan.

Contributions

Participants may elect to reduce their compensation by a specific percentage or dollar amount and have that amount contributed to the Plan as an elective deferral. There are two types of elective deferrals: pre-tax deferrals and Roth deferrals. Total deferrals in any taxable year may not exceed a dollar limit which is set by law. Participants at least age 50 or will attain age 50 before the end of a calendar year may elect to defer additional amounts called catch-up contributions. The Plan includes an automatic deferral feature in which the Company will automatically withhold a portion of a participant's compensation from their pay each payroll period and contribute that amount to the Plan as a pre-tax 401(k) deferral unless the participant makes a contrary election. The amount to be automatically withheld from the participant each payroll period will be equal to 3% of their compensation. Participants may revoke or make modifications to their salary deferral elections.

The Plan is referred to as a safe harbor 401(k) plan. In order to maintain safe harbor status, the Company will make a safe harbor matching contribution equal to 100% of the participant's salary deferrals that do not exceed 3% of their compensation plus 50% of the participant's salary deferrals between 3% and 5% of their compensation. In addition, the Company may make a discretionary contribution to the Plan. There were no discretionary employer contributions to the Plan in 2024.

Participants may also be permitted to deposit into the Plan distributions they have elected from other plans and certain IRAs as rollover contributions.

Participant Accounts

Participants direct the investment of their entire interest in the Plan in any of several investment securities. Participants can change their investment options among the various investment securities either through direct transfers from one security to another or by changing the percentage of future contributions allocated among the investment securities.

Each participant's account is credited with the participant's contribution, rollover contributions, employer contributions, and allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are always 100% vested in their participant contributions, rollover contributions, safe harbor contributions, and actual earnings thereon. Participants are vested in employer discretionary contributions based on years of service. Participants begin vesting at 20% after one year of service, increasing 20% each year thereafter, with the participant 100% vested after five years of service.

Notes Receivable from Participants

Only active participants in the Plan may request a loan. The minimum loan amount that a participant may request is \$1,000. The maximum loan amount that a participant may request is \$50,000 or 50% of their vested account balance, whichever is less. The \$50,000 is reduced by the highest loan balance during the past 12 months minus the loan balance on the date a new loan is made. The number of loans a participant may have outstanding at one time is two. The loan will have a term of twelve to sixty months unless it is a principal residence loan, in which the terms are sixty-one to three hundred sixty months. All loans are secured by the balance in the participant's account and bear interest at 1.0% over the prime rate published in the Wall Street Journal on the first business day of the month before the loan is originated.

Participant Withdrawals

Participants may receive a distribution of the vested portion of some or all of their accounts in the Plan when they terminate employment with the Company. If the vested account balance exceeds \$5,000, the participant's consent is required to distribute the account. If the vested account balance does not exceed \$5,000, the Plan will distribute the account without the participant's consent. If the amount of the distribution exceeds \$1,000, and the participant does not elect to receive or roll over the distribution, the distribution will be directly rolled over to an IRA.

Participants may be entitled to receive an in-service distribution. Generally, a participant may receive a distribution from certain accounts prior to termination of employment provided they have attained age 59½ or incurred a financial hardship.

Forfeitures

If a participant terminates employment before being fully vested, then the non-vested portion of the terminated participant's account balance remains in the Plan and is called a forfeiture. Forfeitures may be used to pay Plan expenses and used to reduce employer contributions. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$1,046 and \$368, respectively.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the Company to make estimates and assumptions that the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expense when they are incurred.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through September 19, 2025, the date the financial statements were available to be issued. See Note 10 for discussion of subsequent events.

3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual Funds: Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

4. GROUP ANNUITY CONTRACT

The Plan holds a traditional fully benefit-responsive investment contract with Empower Annuity Insurance Company of America ("Empower") totaling \$805,695 for 2024 and \$943,666 for 2023. Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Empower is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with Empower. The crediting rate is reviewed on a quarterly basis for resetting. The average yield earned by the Plan was 1.41% for 2024.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct withdrawals or transfers of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on Empower's ability to meet its financial obligations. Empower's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with Empower. However, no events are probable of occurring that might limit the ability of the Plan to transact at contract value with Empower that also would limit the ability of the Plan to transact at contract value with participants.

In addition, certain events allow Empower to terminate the contract with the Plan and settle at an amount different from contract value. The Plan has evaluated such events and has determined that no such events are deemed to be probable of occurring.

5. CERTIFIED INVESTMENT INFORMATION

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends, interest, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by the Company and agreed to or derived from information certified as complete and accurate by both Empower and Empower Trust Company, LLC, qualified institutions.

6. TAX STATUS

The Plan has adopted a pre-approved plan which obtained its latest opinion letter dated November 14, 2022, in which the Internal Revenue Service (“IRS”) stated that the pre-approved plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the opinion letter, the Company believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

GAAP requires the Company to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. PLAN TERMINATION

Although the Company intends to maintain the Plan indefinitely, the Company reserves the right to terminate the Plan at any time. Upon termination, no further contributions will be made to the Plan and all amounts credited to participants’ accounts will become 100% vested. The Company will direct the distribution of participants’ accounts in a manner permitted by the Plan as soon as practicable.

8. RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Empower. Empower is the custodian of the Plan and, therefore, these transactions qualify as party-in-interest transactions. In addition, the Plan provides for notes receivable from participants, which are party-in-interest transactions that are exempt from the prohibited transaction rules.

9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits. As of December 31, 2024 and 2023, there were two investments that represent a concentration of greater than 10% of the Plan’s net assets available for benefits.

10. SUBSEQUENT EVENTS

Effective April 1, 2025, the Plan was amended and restated. This restatement modified the existing participation agreement to allow Alligare, LLC as a participating employer. The Plan was further amended to implement an increase of the mandatory cash-out limit to \$7,000 under SECURE 2.0.
