Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Brighton Center 403(b) Employer–Sponsored Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Responsibilities of Management for the Financial Statements

NOTE A – SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation: The financial statements of Brighton Center 403(b) Employer–Sponsored Plan (“Plan”) are prepared on the accrual basis of accounting in accordance with U.S. generally accepted accounting principles.

Recognition of Income: The basis of investments held by the Plan is adjusted annually to closing market values and unrealized gains and losses are recorded as part of this adjustment. Realized gains and losses on investments are computed using adjusted basis. Security transaction expenses are considered in computing realized gains and losses on investments. Interest income from the interest accumulation account is recognized as it is earned and credited to the account.

Investments: Investments in mutual funds, held in pool separate accounts, are carried at the current fair. Purchases and sales of securities are recorded on a trade–date basis. Dividends are considered in the fair value determination. Gains and losses (realized and unrealized) are reported in net appreciation in fair value of investments in the statement of changes in net assets available for benefits.

Investments in the guaranteed interest accounts are held in the general accounts of American United Life Insurance (AUL) and Mutual of America (MOA), are carried at contract value. The contracts are fully benefit–responsive.

Participants’ Notes Receivable: Participants' notes receivable are stated at their unpaid principal balance plus any accrued interest. Interest is recognized as accrued. An allowance was not required at either year end. If a participant ceases to make a note repayment and Plan administrator deems the participant note to be in default, the note balance is reduced and a benefit payment to the participant is recorded.

Benefit Payments: Benefits are recorded when paid.

Subsequent Events: Subsequent events have been evaluated by management through the date of the independent auditor's report. Material subsequent events, if any, are disclosed in a separate footnote to these financial statements.

Use of Estimates: The preparation of financial statements in conformity with U. S. generally accepted accounting principles requires estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities at the date of financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Concentration of Credit Risks: The Plan invests in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the statement of net assets available for benefits.

NOTE B – DESCRIPTION OF THE PLAN

The following description provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan, established September 1, 2003 and restated on October 15, 2013, covering virtually all employees of Brighton Center ("Sponsor"). Employees must be 21 years of age, but there is no minimum service requirement to make salary reduction contributions. The Plan is for the exclusive benefit of its participants and their beneficiaries. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Secure 2.0 Act: The Securing a Strong Retirement Act (SECURE 2.0 Act) was signed into law on December 29, 2022, and includes mandatory and optional provisions with varying effective dates in 2024 and later. The Organization is evaluating the provisions and has not amended the Plan as of the date of these financial statements.

Contributions: Participants may contribute up to 100% of their compensation either on a pretax or after-tax Roth basis, subject to the limitations of IRC section 402(g). Participants may also contribute amounts representing distributions ("rollovers") from other qualified defined benefit or contribution plans. The Sponsor matches 100% of the first 4% of a participant's eligible compensation.

Participant Accounts: Each participant's account is credited with their contribution and allocations of a) the Plan Sponsor contributions, b) Plan earnings, and c) charged with an allocation of administrative expenses. Allocations are based on the participant's earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are always 100% vested in their voluntary contributions and any earnings thereon. Vesting in Sponsor matching contributions is based on years of service as follows:

Less than two years	0%
2 years	100%

Forfeitures: Forfeitures are retained in the Plan and may be used to pay for administrative expenses allocated to the remaining participants or considered as employer contributions. For the years ended August 31, 2024 and 2023, forfeitures of \$10,897 and \$4,460 were used to offset the Plan Sponsor matching contributions.

Payment of Benefits: Payment of the vested account balance is immediate when the participant reaches normal retirement age, dies, or terminates employment. If the total vested account balance is less than \$5,000, the participant will receive a single lump sum payment. If the vested account balance is equal to or greater than \$5,000, various payment options are available and are described more fully in the Plan agreement. Hardship withdrawals are available subject to certain limitations.

Expenses of the Plan: The Plan's administrative expenses are paid by either the Plan or the Plan Sponsor, as allowed for in the Plan document.

NOTE C – INVESTMENTS CERTIFIED BY THIRD PARTY (unaudited)

As permitted by Department of Labor CFR 2520.103–8, plan investments and participants' notes receivable at August 31, 2024 and 2023 and the net appreciation on investments and earnings on participants' notes for the years then ended, were certified, and held by America United Life Insurance Company (AUL) and Mutual of America (MOA), the Custodians of the Plan, and were not audited by the independent auditor.

NOTE D – TRANSACTIONS WITH PARTIES-IN-INTEREST

The Plan includes certain investments managed by AUL and MOA, the Plan Custodians. Therefore, these transactions qualify as party-in-interest transactions. Fees paid for legal, accounting and other services rendered by parties-in-interest were based on customary and reasonable rates for such services. The Plan's administrative expenses are paid either by the Plan or the Plan Sponsor as allowed for in the Plan document.

NOTE E – INCOME TAX STATUS

Management has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service dated November 22, 2017, stating that the form of the pre-approved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the pre-approved plan document, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore believes the Plan is qualified.

NOTE F – GUARANTEED INTEREST ACCOUNTS

The Plan has benefit-responsive guaranteed interest contracts, AUL Stable Value Fund and MOA Interest Accumulation Account, held in the general accounts of AUL and MOA with a balance of \$252,437 and \$50,303 at August 31, 2024 and \$353,562 and \$49,123 at August 31, 2023. The accounts are credited with earnings at the current interest rate and charged for participant withdrawals and administrative expenses. The guaranteed interest contract issuers are contractually obligated to repay the principal and specified interest rate that is guaranteed to the Plan.

Because the guaranteed interest contract is fully benefit-responsive, it is stated at contract value, the amount the participant would receive if they were to initiate permitted transactions under the Plan. There are no reserves against contract value for credit risk of the contract issuers or otherwise. Contract value represented contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no events that would limit the ability of the Plan to transact at contract value with the issuer.

NOTE G – FAIR VALUE MEASUREMENTS

In accordance with U.S. generally accepted accounting principles, the Plan utilizes a fair value hierarchy that prioritizes the inputs for the valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets
 - quoted prices for identical or similar assets or liabilities in inactive markets
 - inputs other than quoted prices that are observable for the asset or liability
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means
 - if the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE G – FAIR VALUE MEASUREMENTS – continued

There have been no changes in the methodologies used, nor transfers between levels. The following is a description of the valuation methodologies used for assets measured at fair value:

Pooled separate accounts: Valued at the market value of the underlying investment.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
