NOTE 1 - DESCRIPTION OF THE PLAN

The Tilden-Coil Constructors, Inc. 401(k) Profit Sharing Plan (the Plan) is a defined contribution plan providing retirement income, disability, termination and death benefits to eligible employees. The Plan was adopted effective January 1, 1987. The Plan is sponsored and administered by Tilden-Coil Constructors, Inc. (the Company). Illig Construction Company is an affiliated employer to the Plan. The Plan consists of a tax deferred savings program (401(k)) and a discretionary contribution profit sharing program. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Effective January 1, 2022, the Plan was amended and restated.

A summary of the Plan's major provisions follows. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

Eligibility and Participation

Employees are eligible to participate in the Plan after attaining 21 years of age and completing three months of service, based on elapsed time, or 500 hours of service during three consecutive applicable 12-month periods. Eligibility requirements for the employer profit sharing contributions is one year of service, defined as at least 1,000 hours of service. Entry dates are the first day of the month coinciding with or next following the date that eligibility requirements are met. The Plan excludes non-resident aliens, leased employees, and employees who are part of a collective bargaining agreement.

Contributions

A participant may elect to defer any eligible wages, subject to Internal Revenue Service limitations, up to 100% of total compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company provides matching contributions of 100% of the participants contributions, subject to 3% of eligible compensation. Matching contributions totaled \$549,165 and \$450,664 for the years ending December 31, 2024 and 2023, respectively.

The Company may also make profit sharing contributions. Profit sharing contributions were made to the Plan of \$2,070,835 and \$1,858,585, for the years ended December 31, 2024 and 2023, respectively.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's contribution, (b) plan earnings, and (c) charged with an allocation of administrative expenses and plan losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in salary deferrals and rollover contributions. Vesting in the employer contributions is based on years of service according to the following schedule:

Payment of Benefits

The Plan provides for the payment of benefits to the participant or beneficiary at retirement, death, disability or termination of employment. Participants terminating their employment with the Company or attaining age 59 1/2 are entitled to withdraw all or a portion of their vested account balance. Hardship distributions are allowed under plan provisions. Benefits under the Plan shall be distributed solely from the assets of the Trust.

Participants who separate from service and have vested account balances of \$1,000 or less will automatically have their account balances distributed either by direct payment to the individual or as a direct rollover to an individual retirement plan (IRA). If a participant's vested balance exceeds \$5,000, the participant may elect to receive a distribution in the form of a single lump sum payment of partial withdrawals or installments.

Notes Receivable from Participants

In accordance with the plan document, participants are not allowed to borrow funds from their accounts.

Forfeited Accounts

Forfeitures will occur after an employee has a five year break in service or upon distribution of the participant's vested account balance. Forfeitures can be used to pay plan expenses or reduce employer contributions. During the year ended December 31, 2024, no forfeitures were used to reduce employer contributions or to pay plan expenses. For the years ended December 31, 2024 and 2023, the forfeiture account balance was \$211,781 and \$121,284, respectively.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles in the United States (U.S. GAAP) requires management to make estimates and assumptions that may affect the reporting amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from such estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisor and asset custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Cash and Cash Equivalents

The Plan considers highly liquid investments with an original maturity of three months or less to be cash and cash equivalents.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. If expenses are paid using the Plan's assets, then expenses are generally allocated among the accounts of all participants in the Plan and are included in administrative expenses.

Subsequent Events

The Plan has evaluated subsequent events through September 26, 2025, the date the financial statements were available to be issued and concluded there were no events that require recording or disclosure in the financial statements as of December 31, 2024.

NOTE 3 - INFORMATION CERTIFIED BY THE CUSTODIAN

Management, for the years ended December 31, 2024 and 2023, has elected to have the audit of the Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for reporting and Disclosure under ERISA. Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company (the asset custodian of the Plan).

NOTE 4 - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2: Inputs to the valuation methodology include: (1) quoted prices for similar assets or liabilities, (2) quoted prices for identical or similar assets or liabilities in inactive markets, (3) inputs other than quoted prices that are observable for the asset or liability, and (4) inputs that are derived principally from the corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Pooled Separate Accounts: Valued at net asset value (NAV) of shares held by the Plan at year end. The NAV of pooled separate accounts is based upon the market value of the underlying investments and observable inputs. The NAV of pooled separate accounts is classified within Level 2 of the valuation hierarchy because the NAV's unit price is quoted on a private market that is not active; however, the unit price is based on underlying investments which are traded on an active market.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY

The Plan has an investment option within a group annuity contract, Stable Value Fund. The fund's subaccount is invested into John Hancock Stable Fund Collective Investment Trust, which is considered fully benefit responsive and honors eligible redemptions at \$1 per unit. The guaranteed annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to never be less than zero percent. The crediting rate is determined based on the earnings of the underlying assets in the entire portfolio compared to the minimum interest crediting rate, as stated in the contract, and the prevailing market conditions.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by John Hancock Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The value in the Stable Value Fund at December 31, 2024 and 2023 is \$1,676,750 and \$1,958,688, respectively.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the Plan's ability to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including partial or total plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestures or spin offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, and (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

NOTE 6 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan. Certain investments are shares of mutual funds managed by John Hancock Life Insurance Company in pooled separate accounts. The Company paid certain administrative expenses of the Plan; including recordkeeping and audit fees. These transactions qualify as party in interest transactions for which a statutory exception exemption exists.

The Plan maintains a Plan Expense Reduction Account (PERA) to offset certain administrative expenses. The PERA is funded through revenue sharing arrangements with the Plan's investment providers. For the year ended December 31, 2024, a withdrawal credit of \$24,129 was applied from the PERA to offset administrative expenses. The PERA balance as of December 31, 2024 and 2023, was \$29,350 and \$21,337, respectively. Use of PERA funds is restricted to payment of Plan administrative expenses as approved by the Plan Administrator. The Plan accounts for the PERA as an asset of the Plan until a withdrawal is made to pay Plan expenses.

Certain administrative functions are performed by officers and employees of the Company. No officer or employee receives compensation from the Plan for these services.

NOTE 7 - PLAN TERMINATION

Although the Company has not expressed any intent to do so, it has the right under the plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer profit sharing contributions.

NOTE 8 - TAX STATUS

The Company adopted a Non-Standardized Defined Contribution Pre-Approved Plan sponsored by Third Party Administrators. The Internal Revenue Service has determined and informed the Trustee by a favorable opinion letter dated June, 30, 2020, that the Volume Submitter Plan is designed in accordance with the applicable sections of the Internal Revenue Code (the Code). The Non-Standardized Defined Contribution Pre-Approved Plan opinion letter is being relied on by the Plan. The plan has been restated since receiving the opinion letter. However, plan management believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code, and therefore, believes that the Plan is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principals generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

NOTE 10 - DELINQUENT EMPLOYEE DEFERRAL TRANSMITTALS

During the years ended December 31, 2024 and 2023, the Plan Sponsor failed to remit to the Plan's custodian employee contributions totaling \$60 and \$41,400, respectively, within the period prescribed by Department of Labor regulations. Delays in remitting contributions to the custodian was due to administration errors and the Plan Sponsor is in the process of calculating the required corrective contribution for lost earnings on the employee contributions that were remitted late.
