### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

### (1) Description of Plan

The following description of the Stradley, Ronon, Stevens & Young, LLP Retirement Plan I (formally Stradley, Ronon, Stevens & Young, LLP Retirement Plan) (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution retirement plan covering substantially all employees and self-employed individuals (partners) of Stradley, Ronon, Stevens & Young, LLP (the Sponsor), except associates and other attorneys that the Sponsor treats as employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The plan administrator is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Under the provisions of the Plan, each nonattorney employee and salaried partner whose social security number ends in an odd number as well as each equity partner are eligible for the allocation of the Sponsor's contribution, as defined below.

Those nonattorney employees and salaried partners whose social security numbers end in an even number are eligible to participate in the affiliated Stradley, Ronon, Stevens & Young, LLP Retirement Plan II for the purpose of sharing in the allocation of the Sponsor contributions.

#### **Eligibility**

A nonattorney employee or partner is eligible to participate in the Plan for purposes of making elective deferrals and sharing in the allocation of the Sponsor contributions on the first of the month following completion of one hour of service and attainment of age 21. Only nonattorney employees and salaried partners whose social security numbers end in an odd number and each equity partner are eligible for the allocation of the Sponsor's contribution.

#### **Contributions**

Each year, participants may contribute up to 100% of pre-tax annual compensation as defined by the Plan up to the maximum limits of the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

**(1) Description of Plan, Continued**

***Contributions, Continued***

For each calendar year, the Sponsor shall contribute an amount of its net income, as follows:

- For each equity partner who is a partner on the last day of such year, one-half of an amount equal to earned income not exceeding the IRC annual compensation limit, multiplied by a percentage that ranges from 7.00% to 13.75%, depending on the partner's gross earned income.
- For each eligible salaried partner whose social security number ends with an odd number and who is a partner on the last day of such year, an amount equal to earned income not exceeding the IRC annual compensation limit, multiplied by a percentage that ranges from 7.00% to 13.75%, depending on the partner's gross earned income.
- For each eligible participant whose social security number ends with an odd number and who is a nonattorney employee on the last day of such year, 5% of the participant's compensation from the Sponsor for such year up to the social security taxable wage base in effect for the year, plus an additional 8.00% of compensation that exceeds the social security taxable wage base in effect for that year.
- If an individual is both a partner and an employee during the year, the amount of such individual's integrated earned income and integrated compensation shall be determined by adjusting the social security taxable wage base to reflect the individual's earned income as a partner and the individual's compensation as an employee.
- In addition, certain employees employed on the last day of the year in which the Plan is top-heavy will receive the required minimum top-heavy contribution equal to 3.00% of earned income or compensation. This contribution will only be made if and to the extent a participant does not receive the required minimum contribution from the regular sponsor contribution.

The Plan includes an automatic enrollment provision whereby substantially all newly eligible employees, excluding partners, hired on or after January 1, 2019, are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rates set initially at 6% of eligible compensation and increased annually in July by 1% up to a maximum of 12%.

***Participant Accounts***

Each participant's account is credited with the participant's contribution and allocations of the Sponsor's contributions and plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or losses, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**(1) Description of Plan, Continued**

***Investment Options***

The Plan is self-directed by the individual participants. Participants may elect to invest their account in mutual funds, common stock, money market accounts, brokerage accounts, and other securities of their choosing.

***Vesting***

A participant's interest in all elective deferral contributions and the earnings or losses thereon shall at all times be fully vested and nonforfeitable. With respect to vesting of the Sponsor's contributions, a participant who had attained age 21 and completed at least two years of service prior to July 1, 2012 is fully vested in those contributions and the earnings and losses thereon. All other participants must satisfy a three year cliff vesting requirement.

***Notes Receivable from Participants***

Upon proper written application, the plan administrator may permit loans to participants from their accounts. The total of any outstanding loan or loans to a participant may not exceed the lesser of \$50,000 or 50% of the participant's vested account balance. Loans are secured by either 50% of the participant's vested account balance or by a mortgage on the participant's principal or second residence. The loan must be repaid over a period not exceeding five years and must be amortized in level payments made not less frequently than quarterly over the term of the loan, including interest at the prime lending rate as of the loan date. The interest rates on the loans range from 3.25% to 8.50%. Principal and interest are paid ratably through payroll deductions.

***Payment of Benefits***

Upon retirement, disability or death, participants are entitled to their vested interest in their account balance, payable in a single lump-sum payment or in installments over a certain period not exceeding the participant's life expectancy or the joint life expectancy of the participant and his or her spouse.

***Forfeitures***

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$191,407 and \$389, respectively. The Sponsor has the option to use forfeitures to reduce employer contributions to the Plan or to pay administrative expenses of the Plan. For the year ended December 31, 2024, employer contributions and plan administration expenses were reduced by \$21,016 and \$30,000, respectively, from forfeited nonvested accounts.

### (2) Summary of Significant Accounting Policies

#### ***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### ***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### ***Investment Valuation and Income Recognition***

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisor and trustees. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Contributions***

Contributions from plan participants are recorded in the year in which the employee contributions are withheld from compensation.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

#### ***Payment of Benefits***

Benefits are recorded when paid.

**(2) Summary of Significant Accounting Policies, Continued**

***Expenses***

Certain expenses of maintaining the Plan are paid directly by the Sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and certain participant brokerage accounts are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

***Subsequent Events***

The Plan has evaluated subsequent events through September 29, 2025, the date the financial statements were available to be issued.

**(3) Financial Information Certified by a Qualified Institution**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental Schedule H, Line 4i – Schedule of Assets (Held at End of Year), including investments at fair value and notes receivable from participants at December 31, 2024 and 2023 and net appreciation in fair value of investments, interest and dividends and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank, a qualified institution.

**(4) Fair Value Measurements**

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include
  - quoted prices for similar assets or liabilities in active markets;
  - quoted prices for identical or similar assets or liabilities in inactive markets;

(4) Fair Value Measurements, Continued

- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered investment companies, exchange-traded funds, unit investment trusts, real estate investment trusts, and money market accounts:* Valued at the daily closing price as reported by the fund. Registered investment companies, exchange-traded funds and unit investment trusts held by the Plan are open end investments that are registered with the Securities and Exchange Commission. These investments are required to publish their daily net asset value (NAV) and to transact at that price. Registered investment companies, exchange-traded funds, unit investment trusts, real estate investment trusts, and money market accounts held by the Plan are deemed to be actively traded.

*Common collective trust funds:* Valued at the NAV of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liability. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

*Corporate bonds and U.S. government and agency securities:* Valued based on current yields available on identical or comparable securities issued. When quoted prices are not available for identical or similar securities, the investment is valued under a discounted cash flows approach that maximizes observable inputs, such as current yields of similar investments, but includes adjustments for certain risks that may not be observable, such as credit and liability risks.

*Common and preferred stock and other assets:* Valued based on quoted market prices or based on the most recent transactions if these stocks are not publicly traded.

### (5) Related Party Transactions and Party-In-Interest Transactions

Certain plan investments are shares of a money market fund managed by Charles Schwab Bank. Charles Schwab Bank is a trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments.

### (6) Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

### (7) Tax Status

The Plan uses a pre-approved plan document sponsored by Schwab Retirement Plan Services, Inc. (Schwab Retirement). Schwab Retirement received an opinion letter from the Internal Revenue Service (IRS) dated September 21, 2020, which states that the pre-approved plan document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan's administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

#### (7) Tax Status, Continued

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### (8) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### (9) Transfer of Assets to/from Affiliated Plans, Net

The Sponsor maintains two affiliated plans that cover substantially all employees and self-employed individuals (partners) of Stradley, Ronon, Stevens & Young, LLP. Funds are transferred between plans when changes occur to an employee's status. During 2024, \$320,001 was transferred into the Plan from the Stradley, Ronon, Stevens and Young, LLP 401(k) Plan.

#### (10) Nonexempt Transactions

In 2023, the Plan had delinquent participant contributions totaling \$6,557. The delinquent contributions were in connection with an off-cycle payroll period. These employee contributions were withheld from participants' pay but were not remitted to the Plan's trust within the timeframe required by the Department of Labor under plan asset rules. The delinquent employee contributions were remitted to the Plan's trust during the following regularly scheduled payroll period; however, the related lost earnings had not yet been remitted to the Plan as of December 31, 2023. During 2024, the delinquent participant contributions were corrected. The related lost earnings on the delinquent contributions were contributed in the 1st quarter of 2024. The related excise taxes were paid to the IRS in the 1st quarter of 2024.
