## INDEPENDENT AUDITORS' REPORT

To the Administrator of the

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed the audits of the financial statements of the PHX Holdings Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the PHX Holdings Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520-103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

### Note 1 - Description of plan:

The following description of the PHX Holdings Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The plan sponsor is PHX Holdings, LLC (PHX). The Plan is a defined contribution plan covering substantially all employees of PHX, Phoenix Stamping Group, LLC, Partworks, LLC, Precision Partners, LLC, and GTC Machining, LLC (collectively the Company, Plan Sponsor, or Plan Administrator). See plan amendments below.

The Plan's eligibility requirements are as follows: eligible employees must be at least 21 years of age and complete 90 days of service to participate in the Plan. The Plan Sponsor provides for discretionary matching contributions which are available to all participating employees. Employees must complete 90 days of service and be employed on the last day of the Plan year, with limited exceptions, to be eligible for employer profit-sharing contributions. Plan entry is immediate upon attainment of eligibility requirements. The Plan has an automatic enrollment feature whereby eligible employees are enrolled in the Plan at a deferral rate of 4% unless they opt out of deferrals or choose another deferral percentage. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Plan amendment

The Plan was amended on January 1, 2024, with a retroactive effective date of January 1, 2021, to remove Precision Partners, LLC as a participating entity.

The Plan was amended on January 1, 2024 to modify the eligible compensation definition used by the Plan. In addition to the previously existing compensation exclusion, phone allowances, relocation bonuses, referral bonuses, signing bonuses, and employee awards were also excluded from eligible compensation.

During 2024, self-certification provisions pertaining to hardship distributions were added to the Plan.

The Plan was amended on June 21, 2024, with a retroactive effective date of January 1, 2023, to allow for participants to modify contribution elections each payroll period.

### Note 1 - Description of plan - continued:

#### Contributions

Participants may contribute amounts up to current Internal Revenue Service (IRS) limitations through payroll deductions. Participants who have attained age 50 before the end of the Plan year are permitted to make catch up contributions. The Company provides a discretionary employer matching contribution equal to 50% of each participant's deferral contribution up to a maximum of 4% of eligible compensation contributed, as defined. The Company also has the option to provide a discretionary employer profit-sharing contribution. There was no discretionary employer profit-sharing contribution for the 2024 Plan year.

The Plan also has a Roth contribution provision which gives participants the option of contributing amounts to their individual Roth accounts which are maintained separately from pre-tax contributions. Participants may direct both employee and employer contributions to any of the Plan's fund options. Participants may change their investment options daily.

#### Participant accounts

Each participant's account is credited with the participant's contributions, the Company's matching contributions, an allocation of the Company's profit-sharing contribution, if any, Plan expenses, and Plan earnings.

Allocations of profit-sharing contributions are based on eligible compensation as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant's account.

#### Forfeited accounts

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$20,008 and \$2,756, respectively, and are included in the stable value fund investment. During the year ended December 31, 2024, \$64,670 of forfeitures were used to reduce employer contributions to the Plan. During the year ended December 31, 2024, there were no forfeitures were used to pay Plan expenses.

#### Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Participants vest in the Company's matching and profit-sharing contributions as shown in the schedule below:

Participants are immediately vested upon termination of the Plan, upon reaching the normal retirement age of 65, or upon disability or death while an employee of the Company. Forfeitures of terminated participants' non-vested accounts may be used by the Plan for the payment of Plan expenses or to reduce employer contributions.

Payment of benefits

A participant is entitled to a distribution of the vested value of his or her account upon termination of service, disability, death, or retirement. Participants are required to take distributions as lump-sum payments, with the exception of required minimum distributions. In-service withdrawals of a participant's vested account balance, excluding Roth contributions, are permitted in cases of proven financial hardship. If a participant's account balance is less than \$7,000 upon termination of service, a distribution of the participant's account may be made in a single lump-sum cash distribution.

Notes receivable from participants

The Plan does not allow for participant notes.

Administrative expenses

Administrative expenses of the Plan are paid by either the Company or the Plan, as determined by the Plan Sponsor. The Company absorbs a portion of the administrative expenses of the Plan. Fees charged for recordkeeping, investment advisory, processing distributions, and other account transaction fees, are charged directly to the accounts of participants.

### Note 2 - Summary of significant accounting policies:

#### Basis of accounting

The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

#### Stable value fund

Investment contracts are reported at contract value as contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents the cost plus contributions made under the contract plus interest at the contract rate less withdrawals and administrative expenses.

The Plan invests in the Transamerica Stable Value Core Account Fund investment. This investment is considered to be fully benefit-responsive, and thus is reportable at contract value. Generally, participants may withdraw assets from the Transamerica Stable Value Core Account Fund without restrictions. Transamerica may impose a hold period at the contract level in the event of a full contract discontinuance or partial contract discontinuance. The investment's interest rate is set semi-annually on January 1 and July 1. There is no stated minimum or maximum interest rate for this investment. Participants are able to redeem their monies from this investment on a daily basis. There are no unfunded commitments related to this investment.

#### Investment valuation and income recognition

The Plan's mutual fund and insurance company general account investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. These investments are valued at fair value based on a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2     Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;  
Quoted prices for identical or similar assets or liabilities in inactive markets;  
Inputs other than quoted prices that are observable for the asset or liability;  
Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3     Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Shares of registered investment company funds (mutual funds) are valued at the net asset value of shares held by the Plan at year-end by obtaining quoted prices on nationally recognized securities exchanges. These investments are actively traded.

The insurance company general account is valued at cost, which approximates fair value. The monies in held in this investment are included in the general assets of Transamerica. This account holds EBA monies received under this Plan's arrangement with Transamerica. Participants are not allowed to invest in this account.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make certain estimates that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

#### Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

#### Payment of benefits

Benefits are recorded when paid.

#### Subsequent events

The Plan has evaluated subsequent events through September 30, 2025, which is the date these financial statements were available to be issued. All subsequent events, if any, requiring recognition as of December 31, 2024, have been incorporated into these financial statements.

#### Note 3 - Investments and information certified by the custodian:

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation in the fair value of investments, interest and dividends, and other income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the custodians. Reliance Trust Company was the custodian and provided the certification of the Plan's investments held at December 31, 2023. Reliance Trust Company also certified the net appreciation in the fair value of investments, interest and dividends, and other income for the period from January 1, 2024 through June 30, 2024. Transamerica Trust Company certified the net appreciation in the fair value of investments, interest and dividends, and other income, with the exception of the stable value investment, for the period from July 1, 2024 through December 31, 2024. Transamerica Financial Life Insurance Company certified the contract value as of December 31, 2024, and the interest and dividends related to the stable value investment for the year ended December 31, 2024.

#### Note 4 - Party-in-interest transactions:

The custodian and its affiliates perform services for the Plan, sell products to the Plan, and manage and maintain certain investments of the Plan for which fees are charged to the Plan. The Plan pays a portion of the administrative expenses. Such transactions, while considered party-in-interest transactions under ERISA, are specifically exempt from the prohibited transaction rules.

The Plan has a services agreement with Transamerica Retirement Services Corp. whereby the Plan receives revenue from contract asset charge fees related to investments of the Plan which is placed into an Expense Budget Account (EBA). The funds in the EBA can either be allocated to participants or used to offset amounts owed to the Plan's service providers for administrative and other services provided to the Plan. 2024, the Plan received \$40,919 of EBA credits associated with the services agreement which are included in other income on the statement of changes in net assets available for benefits. As of December 31, 2024 and 2023, the Plan had available \$4,125 and \$3,669, respectively, of these monies for payment of future expenses. The EBA is included in the insurance company general account investment as of December 31, 2024 and 2023. During the year ended December 31, 2024, \$40,490 of the Plan's expenses were paid out of the EBA and are included in administrative expenses on the statement of changes in net assets available for benefits.

#### Note 5 - Plan termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants' accounts will become fully vested.

#### Note 6 - Tax status:

The underlying prototype plan has received an opinion letter from the IRS dated June 1, 2021 stating that the form of the Plan is qualified under Section 401(a) of the Internal Revenue Code (IRC), and therefore, the related trust is tax-exempt. The Plan Administrator has determined that it is eligible to and has chosen to rely on the current IRS prototype plan opinion letter. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan Administrator has indicated that it will take the necessary steps to bring the Plan's operations into compliance with the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for Plan years prior to 2021.
