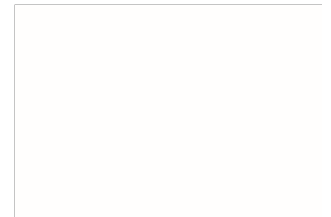

INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees
Union of California State Workers 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.




Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.



Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Other Matters - Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplemental information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

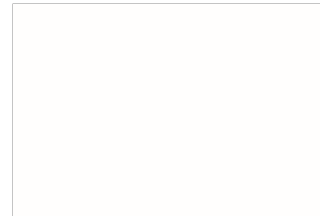

NOTES TO FINANCIAL STATEMENTS

YEARS ENDED DECEMBER 31, 2024 AND 2023


NOTE 1. DESCRIPTION OF THE PLAN

The following description of the Union of California State Workers 401(k) Plan (the Plan), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan was established on April 1, 2012 and is a defined contribution 401(k) plan. The Plan covers all employees of the Union of California State Workers (dba SEIU Local 1000) (the Union) who meet the eligibility requirements of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration - The Union, as the Plan sponsor, is the administrator of the Plan, and as such, carries out the duties imposed under ERISA. The Union has delegated certain responsibilities for the operation and administration of the Plan. Reliance Trust Company is the appointed custodian of the Plan's assets (the Trustee). Recordkeeping and technical assistance is provided by Standard Retirement Services, a subsidiary of StanCorp Financial Group, Inc. Investments in stable value funds are held by Standard Insurance Company, which is also a subsidiary of StanCorp Financial Group, Inc.; therefore, the related transactions are party-in-interest transactions. However, such transactions are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

Contributions - Participants may contribute, by salary reduction, a portion of their annual wages before bonuses and overtime. This amount is limited by the Internal Revenue Service (IRS) to a maximum dollar amount per year. Participants may also contribute



amounts representing distributions from other qualified defined benefit or defined contribution plans. Effective October 2014, the Plan was amended to provide matching contributions at the discretion of the employer. All contributions are processed and remitted to the Plan by the Union.

Investment Options - Upon enrollment in the Plan, a participant may direct contributions in any of several investment alternatives offered through the Trustee and can elect the amount of contributions to be placed in each investment account.

Participant Accounts - Each participant's account is credited with the participant's contributions and allocation of Plan earnings. Earnings are allocated by fund based on the ratio of a participant's account invested in a particular fund to all participants' investments in that fund. The vested balance in a participant's account is the benefit to which the participant would be entitled upon termination or retirement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.



NOTE 1. DESCRIPTION OF THE PLAN (CONTINUED)

Money invested in the guaranteed account is credited with interest based on a monthly declared interest rate, and at the end of the year on a composite interest rate. All other investments will change in value from time to time due to investment gains or losses.

Vesting - Participants are immediately vested in their salary deferral contributions plus actual earnings thereon. Participants are 100% vested in employer matching contributions after three years of service.

Corrective Distributions - Represents amounts paid to participants for contributions in excess of amounts allowed by the IRS. As of December 31, 2023, the Plan had accrued corrective distributions of \$5,138. This amount was remitted to the applicable participants prior to March 15, 2024. No such amounts were recorded as of December 31, 2024.


Payment of Benefits - Upon retirement, termination, disability, or death, a participant can elect to be paid in a lump-sum amount or an annuity. Lump-sum distributions can be directly rolled over into a traditional individual retirement account (IRA) or other qualified plans or paid directly to the participant in a single lump sum.

Forfeitures - Upon termination of employment and distribution of account balances, nonvested portions of participant accounts are forfeited. During the years ended December 31, 2024 and 2023, these forfeitures were used to reduce the administrative expenses. The forfeiture balance was \$-0- for both years ended December 31, 2024 and 2023.

Termination of the Plan - Although it has not expressed any intent to do so, the Union has the right to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, the full value of each participant's account shall become fully vested and non-forfeitable.

Costs of Administration - The Union pays certain administrative expenses and maintains the Plan's records.

Notes Receivable from Participants - Upon approval from the Plan administrator, participants may receive loans from the Plan which are limited to the vested portion of the participants' salary deferral accounts. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant's loan fund. Loans are fully secured by the participant's account balance and bear interest at a rate commensurate with local prevailing rates, which is determined at loan origination. Loans are subject to a minimum of \$1,000 and a maximum of the 50% of the account balance to a maximum of \$50,000. Generally, all loans must be repaid within five years from the date of the loan, unless proceeds are used for the acquisition of the participant's personal residence, for which the repayment period is up to fifteen years. Principal and interest is paid ratably



through biweekly payroll deductions. A loan may become a taxable distribution if it is not repaid under the terms set forth in the loan agreement.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Plan are prepared using the accrual method of accounting in conformity with U.S. generally accepted accounting principles. Under this basis, revenue is recognized when earned and expenses are recognized when incurred.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.


Investment Valuation and Income Recognition - The Plan's investments in mutual funds are stated at fair value based on public prices available in active markets. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are reported on a trade-date basis. Interest income is reported on the accrual basis. Dividends are reported on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. The Plan's investments in stable value funds are stated at contract value which is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts. Contract value is the amount participants would receive from transactions under the terms of the Plan.

Notes Receivable from Participants - Participant loans are valued at their unpaid principal balance plus accrued interest. Interest income is recorded on an accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the loan to be in default, the participant loan balance is reduced, and a deemed distribution of the loan is recorded.

Contributions - Employee contributions are recorded in the period payroll deductions are made. Matching contributions, if elected, from the Union, are recorded in the period when the related employee contributions are recorded.

Payment of Benefits - Benefit claims are recorded as expenses when they have been approved for payment and paid by the Plan.

NOTE 3. INCOME TAX STATUS



The Plan has adopted the Standard Retirement Services, Inc. Defined Contribution Volume Submitter, which received a favorable opinion letter from the IRS on March 31, 2008 for that type of plan. The letter stated that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan administrator believes that the Plan is designed and is currently being operated in compliance with applicable requirements of the IRC.

NOTE 3. INCOME TAX STATUS (CONTINUED)

Accounting standards provide consistent guidance for the accounting for uncertainty in income taxes recognized in an entity's financial statements and prescribe a threshold of "more likely than not" for recognition and derecognition of tax positions taken or expected to be taken in a tax return. The Plan performed an evaluation of uncertain tax positions for the years ended December 31, 2024 and determined that there were no matters that would require recognition in the financial statements. As of December 31, 2024, the statute of limitations for 2021 through 2023 remains open with the U.S. federal jurisdiction and the various states and local jurisdictions in which the Plan files returns.

NOTE 4. INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information certified by the Trustee for 2024 and 2023, except for comparing such information certified by the Trustee to information included in the Plan's financial statements and supplemental information. The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified as complete and accurate by the Trustee.

NOTE 5. INSURANCE CONTRACT

The investment in the Standard Stable Asset A includes a fully benefit-responsive insurance contract with Standard Retirement Services (Standard), which is available through a rider to Standard Insurance Company's Group annuity contract. As described in Note 2, because the stable value contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of net assets available for benefits attributable to the stable value contract. Contract value, as reported to the Plan by Standard, represents the sum of all benefits owed to participants in that fund, and is equal to contributions

NOTE 5. INSURANCE CONTRACT (CONTINUED)

made, less withdrawals and administrative expenses, plus interest credited. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Although unlikely to occur, certain events may limit the ability of the Plan to transact at contract value with Standard. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the Standard's ability to meet its contractual obligations, which may be affected by future economic and regulatory developments.

The Standard may terminate the contract with 30 days' advance notice to the contract owner for reasonable cause, which includes the contract owner's failure to abide by state or federal law, failure to render performance necessary to comply with terms of the contract, failure to maintain assets of at least \$25,000, plan disqualification, and failure to adopt the Plan in a reasonable period of time.

NOTE 6. INVESTMENTS MEASURED AT FAIR VALUE

Accounting standards provide the framework for measuring fair value which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.



Level 2 Inputs to the valuation methodology include other significant observable inputs including:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NOTE 6. INVESTMENTS MEASURED AT FAIR VALUE (CONTINUED)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

NOTE 7. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Reliance Trust Company and StanCorp Financial Group, Inc. are each a party-in-interest as defined by ERISA. Certain plan investments are managed by Reliance Trust Company. Additionally, the Plan has invested in a stable value fund held by Standard Insurance Company, which is a subsidiary of StanCorp Financial Group, Inc. The Union as Plan sponsor provides certain administrative services to the Plan. The cost of the administrative services are not readily determinable. Additionally, as discussed in Note 1, participants may borrow from their fund accounts. These transactions are party-in-interest transactions specifically exempt from prohibition under ERISA.

NOTE 8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

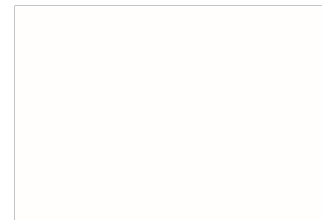

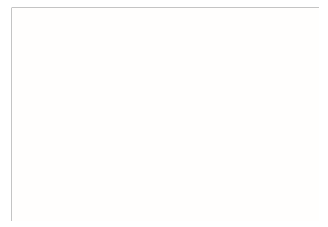
