1. Plan Description

The following description of the IXL Learning, Inc. 401(k) Profit Sharing Plan and Trust Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General

The Plan was established on January 1, 2004, amended in October 2021, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan administrator is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

On September 2, 2022, the Company entered a Merger Agreement to acquire Emmersion Learning, Inc. (“Emmersion”) under which the Company acquired 100% of the shares of Emmersion. Emmersion is a Delaware corporation focusing on language assessment using AI technology. Effective March 31, 2023, Emmersion 401(k) Plan is merging into the IXL Learning Inc. 401(k) Profit Sharing Plan and Trust, serviced by T. Rowe Price. Total value of transferred investments was approximately \$0.4 million for 30 accounts of Emmersion 401 (k) Plan.

On March 1, 2023, the Company entered a Merger Agreement to acquire Teacher Synergy LLC under which the Company acquired 100% of the shares of Teacher Synergy LLC. Effective August 25, 2023, Teacher Synergy LLC 401(k) Plan is merging into the IXL Learning Inc. 401(k) Profit Sharing Plan and Trust, serviced by T. Rowe Price. Total value of transferred investments was approximately \$14 million for 373 accounts of Teacher Synergy LLC 401 (k) Plan.

On March 29, 2024, IXL Learning, Inc. entered a Purchase Agreement to acquire Dictionary.com, LLC. (“Dictionary.com”) under which the Company acquired 100% of the shares of Dictionary.com. Dictionary.com’s employees were signing up with the 401K Plan of Rock Holdings, Inc., a Michigan corporation (“Seller Owner”). Their 401K assets were still with Seller Owner’s 401K plan and were not merged into the IXL Learning, Inc. 401(k) Profit Sharing Plan and Trust Plan.

On August 1, 2024, IXL Learning, Inc. entered a Purchase Agreement to acquire Carson-Dellosa Publishing LLC. (“Carson Dellosa”) under which the Company acquired 100% of the shares of Carson Dellosa. As a result of the acquisition, Carson Dellosa’s 401 (k) Plan will be merged into the IXL Learning, Inc. 401(k) Profit Sharing Plan and Trust Plan around January 1, 2025. Total value of transferred investments is approximately \$10 million for 147 accounts of Cason Dellosa 401 (k) Plan.

Eligibility

The Plan is a defined contribution plan covering all full-time and part time employees of IXL Learning, Inc. (the “Company” or “Plan Sponsor”) who are age 18 or older. Employees may enroll on the first day of hire or afterwards. Eligibility excludes leased employees and residents of Puerto Rico.

Contributions

Each year, participants may elect to contribute up to 100% of their eligible compensation, on a pretax or post tax basis, as defined by the Plan, up to the maximum amount allowed by law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may make discretionary matching contributions on the employee's behalf, and the amount of matching contribution, if any, is determined every year by the Plan Sponsor. In 2024, the Company made a discretionary matching contribution as determined by the Company's Plan Sponsor that is equal to 50% of the employee's contribution up to 6% of the employee's base earnings and 25% of contributions made between 6% to 10% of the employee's base earnings, or a maximum of 4% of the employee's base earnings.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions as well as the Company's contributions plus actual earnings thereon.

Notes Receivable - Participant Loans

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, less the highest outstanding loan balance in the previous twelve months, or 50% of their account balance. Loan terms may not exceed five years unless the loan is used to purchase a participant's principal residence, in which case repayment must be made within ten years. Loans are secured by the participant's account and bear interest at 4.25% to 9.50%, which is commensurate with local prevailing rates. Principal and interest are paid ratably through semimonthly payroll deductions.

Payment of Benefits

On termination of service, upon attainment of age 59½, death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum payment in cash or in installment payments. Hardship distributions are permitted if certain criteria are met. The vested account balances of terminated participants are automatically distributed if the vested account balance does not exceed \$1,000. The vested account balance of terminated participants is automatically rolled over to an individual retirement account established if the vested account balance is between \$1,000 and \$5,000.

Forfeitures

Forfeitures, if any, will be used to reduce future employer matching and nonelective contributions.

Administrative Expenses

Expenses for auditing the Plan are paid directly by the Plan sponsor. Investment and Trustee administration fees are paid by the Plan.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits. As a result, the value of such investments may have declined from year-end values, and the decline could be material.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the amounts reported of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could materially differ from those estimates.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Notes Receivable – Participants Loans:

Notes from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of

December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Risks and Uncertainties

The Plan invests in investment securities. Investment securities are exposed to various risks such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

3. Tax Status

The Plan was adopted under a prototype plan sponsored by the Trustee. The Internal Revenue Service (IRS) has determined and informed the Company, by letter dated February 21, 2019, that the Plan is designed in accordance with the applicable sections of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The federal annual returns of the Plan are subject to examination by the Internal Revenue Service, generally for three years after they are filed.

4. Plan Termination

Although it has not expressed any intent to do so, the Plan sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, the participants will become 100% vested in the aggregate value of their individual account regardless of whether their vesting years of service are sufficient to make them 100% vested under the vesting schedule.

5. Investment Information Certified by the Plan's Trustee

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, the T. 6. Fair Value Measurements

FASB Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosure* defines fair value, establishes a framework for using fair value to measure assets and liabilities, and expands disclosures about fair value measurements. This framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels

of the fair value hierarchy under ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024:

Mutual Funds and money market funds: Mutual funds represent investments with various investment managers. The fair value of these investments are determined by reference to the fund's underlying assets, which are principally marketable equities and fixed income securities. Shares held in mutual funds traded on national securities exchanges are valued at the net asset value as of December 31, 2024.

Common Collective Trusts: Common collective trust funds represent interests in pooled investment vehicles designed typically for collective investment of employee benefit trusts. The fair values of these investments are determined by reference to the NAV per unit provided by the fund managers as the basis for current transactions.

Self-Directed Accounts: Accounts primarily consist of mutual funds and cash equivalents that are valued on the basis of readily determinable market prices. Other assets are valued annually based on proprietary information.

The fair value hierarchy method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Participants may choose to invest in funds held by the Plan Trustees, T. Rowe Price. These transactions qualify as related party transactions. Fees paid by the Plan to the Trustee for investment management and trust services were \$121,517 and \$106,845 years ended December 31, 2024 and 2023, respectfully.

T. Rowe Price has provided certain administrative services to the Plan pursuant to Recordkeeping Service Agreements (the “Agreements”) between the Company and T. Rowe Price. T. Rowe Price is the custodians as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. T. Rowe Price receives revenue from mutual fund service providers for services they provide to the funds. This revenue is used to offset certain amounts owed to T. Rowe Price for its administrative services to the Plan.

If revenue received by T. Rowe Price from such mutual fund service providers exceeds the amount owed under the Agreement, T. Rowe Price will remit the excess to the Plan’s trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. The Plan Sponsor makes a payment to T. Rowe Price for administrative expenses not covered by revenue sharing.

9. Risks and Uncertainties

The Plan holds various investment instruments, including mutual funds. Investments, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

10. Subsequent Events

Subsequent events were evaluated through September 9, 2025, which is the date the financial statements were available to be issued. Based on that evaluation, the Plan has determined that the following subsequent events have occurred that would require adjustment to or disclosure in the financial statements.
