### **Report on the Audit of the Financial Statements**

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Kinross Gold Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Kinross Gold Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Kinross Gold Retirement Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### (1) Description of the Kinross Gold Retirement Plan

#### (a) *General*

The Kinross Gold Retirement Plan (the Plan) is a defined contribution plan sponsored by Kinross Gold USA, Inc. (the Company) established effective January 1, 1989 and most recently restated effective July 15, 2022, which covers substantially all employees of the Company and certain related employers that have adopted the Plan. It is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). Participants who have attained age 18 become eligible for participation on the first day of the month on or after their date of hire for purposes of elective deferral contributions. Participants must have completed three months of service to be eligible for employer matching contributions and six months of service to be eligible for employer additional contributions. The Plan is designed and operated to be a “safe harbor” plan under the Internal Revenue Code of 1986, as amended (IRC) Section 401(k)(12). The Company serves as the Plan administrator. Principal Life Insurance Company is the record-keeper and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, a qualified institution, is the custodian of the Plan. Plan participants should refer to the Plan document for a more complete description of the Plan’s provisions.

#### (b) *Contributions*

Participants may elect to contribute on a tax-deferred basis from 1% to 50% of eligible compensation not to exceed \$23,000 in 2024 and \$22,500 in 2023. Eligible employees who reach age 50 during the plan year also may elect to make “catch-up” contributions not to exceed \$7,500 in 2024 and 2023. Each payroll period the Company makes matching contributions equal to 100% of participant deferral contributions up to 6% of eligible compensation, as well as additional contributions equal to 4% of participants’ eligible compensation.

The Plan offers automatic enrollment, whereby an eligible employee is automatically enrolled in the Plan to contribute 3% of the employee’s eligible compensation as pre-tax elective deferrals when the employee becomes eligible to participate in the Plan, unless he or she elects otherwise.

#### (c) *Participant Accounts*

Each participant’s account is credited with the participant’s deferral contributions and employer matching and additional contributions and charged with applicable administrative fees. Earnings (losses) credited to each participant’s account reflect actual earnings (losses) of each particular investment in which the participant’s account is allocated.

#### (d) *Investment Direction*

Participants are responsible for the investment direction of their individual accounts in any of the investment options made available by the Plan. If a participant does not make an election as to how the Plan should invest their contributions, the Plan will invest such contributions into the Principal Lifetime Collective Investment Trust (CIT) Tier II with the year closest to the year in which the participant will attain age 65.

#### (e) *Vesting*

Participants are immediately 100% vested in all Plan contributions and the earnings thereon.

### **(f) Payment of Benefits**

Each participant is entitled to a lump-sum payment or annuity payments of vested benefits in the Plan upon severance from employment, retirement, or death. In addition, a participant may withdraw benefits from the Plan in certain hardship situations, upon attaining age 59-1/2, and from his or her rollover account generally at any time.

### **(g) Notes Receivable from Participants**

Participants are permitted to borrow up to 50% of their account balances up to a maximum of \$10,000 per participant. Principal and interest repayments are paid ratably through payroll deductions. Notes receivable from participants bear interest at a fixed rate equal to the Wall Street Journal Prime Rate plus 2% (or such other commercially reasonable rate as determined by the Plan administrator from time to time). As of December 31, 2024, interest rates ranged from 5.25% to 10.50% with maturity dates through December 2028. Notes receivable from participants are secured by the participants' accounts.

### **(h) Administrative Expenses**

Participants pay the costs of administering the Plan through a flat fee of \$44 per year with additional fees for certain participant-level services. Certain administrative expenses of the Plan are paid by the Company.

## **(2) Summary of Significant Accounting Policies**

### **(a) Basis of Presentation**

The accompanying financial statements of the Plan have been prepared on an accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) and under the requirements of ERISA, and they present the net assets available for benefits and changes in those net assets.

### **(b) Use of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions from net assets during the reporting period. Actual results could differ from those estimates.

### **(c) Investment Valuation and Income Recognition**

Investments in pooled separate accounts (PSAs) and the Principal Lifetime CITs are stated at the net asset value (NAV) of the units held by the Plan. Mutual funds are valued at the daily closing price as reported by the fund. The Plan's investment in the Principal Stable Value Z Fund (PSVF), a Common Collective Trust (CCT), is stated at fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. The net appreciation or depreciation in fair value of investments (net realized and unrealized gains and losses) is reflected in the accompanying statements of changes in net assets available for benefits and is determined as the difference between the market value at the beginning of the year (or date purchased during the year) and the selling price or year-end market value.

### **(d) Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Defaulted participant notes receivable are taxable distributions based upon the terms of the Plan document and applicable Treasury Regulations. No allowance for credit losses have been recorded as of December 31, 2024 or 2023.

### **(e) Payment of Benefits**

Benefits are recorded when paid.

### **(f) Fair Value Measurements**

U.S. GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under U.S. GAAP are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different estimate of fair value at the reporting date.

The Plan's investments in PSAs and the Principal Lifetime CITs are stated at NAV. These investments are transacted at NAV on a daily basis, and as such are considered to have a readily determinable fair value. The PSAs and the Principal Lifetime CITs held by the Plan are deemed to have observable inputs and are classified as Level 2.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are classified as Level 1.

The PSVF is a stable value fund whose underlying portfolio is composed primarily of fully benefit-responsive investment contracts. Since the Plan indirectly holds the fully benefit-responsive investment contracts through beneficial ownership of this CCT, the Plan is not required to value its investment in this CCT at contract value in accordance with Part 1 of FASB ASU No. 2015-12. Accordingly, the Plan's investment in this CCT is reported at fair value. The Plan values this CCT based on the evaluation of the net assets of this CCT, whereby the assets and liabilities of this CCT are valued based on each underlying investment within this CCT, incorporating valuations that consider the evaluation of sale transactions with third parties, expected cash flows and market-based information. Participant transactions such as purchases and sales may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner. Having considered the nature of the portfolio of this underlying CCT, its ability to liquidate its underlying investments and other restrictions on the disposition of this investment, the PSVF is classified as Level 2.

### **(g) Changes in Fair Value Levels**

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. ### **(3) Information Certified by the Plan's Custodian**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the custodian has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- a) Investments and notes receivable from participants as shown in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023;
- b) Investment income and interest on notes receivable from participants as shown in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023; and
- c) The schedule of assets (held at end of year) as of December 31, 2024, as shown in the accompanying supplemental schedule.

### **(4) Income Taxes**

The Plan was most recently restated effective July 15, 2022, using the Principal Non-Standardized Pre-Approved Plan (with minor modifications), which received an Internal Revenue Service (IRS) opinion letter dated June 30, 2020, in which the IRS stated that the pre-approved plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan administrator believes that the Plan is designed and operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **(5) Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA.

### **(6) Party-in-Interest Transactions**

The Plan engages in transactions involving the acquisition and disposition of investment funds with Principal Trust Company who is a party-in-interest with respect to the Plan. These transactions are covered by an exemption from the "prohibited transactions" provision of ERISA and the IRC. The Plan also allows for loans to participants, which qualify as exempt party-in-interest transactions.

### (7) Risks and Uncertainties

The Plan invests in certain PSAs, mutual funds and CCTs. Investments, in general, are exposed to various risks, such as significant world events, interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the value of investments will occur in the near term.

The Plan provides participants the ability to invest in various investment securities, which may, in turn, invest in securities with contractual cash flows, such as asset-backed securities, collateralized mortgage obligations, and commercial mortgage-backed securities, and could potentially include securities backed by subprime mortgage loans. The value, liquidity, and related income of those securities are sensitive to changes in economic conditions, including real estate value, delinquencies or defaults, or both, and may be adversely affected by shifts in the market's perception of the issuers and changes in interest rates.
