INDEPENDENT AUDITOR'S REPORT

To the Trustees

Opinion

We have audited the accompanying financial statements of Pacific Northwest Employers Life, Health Insurance Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of Pacific Northwest Employers Life, Health Insurance Trust as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. 1. Plan Description

The following description of Pacific Northwest Employers Life, Health Insurance Trust (the Trust) provides only general information. Participants should refer to the Trust Agreement for a more complete description of the Trust's provisions.

General

The Trust exists for the exclusive benefit of participating employers' covered employees and their eligible dependents and beneficiaries. The Trust was established September 1, 1953 and provides for the investment and administration of contributions from participating employers and covered employees and provides such employees and their dependents and beneficiaries with benefits. The benefits provided include fully insured hospital, medical, surgical, vision, dental, life, and disability benefits. Employees must meet certain eligibility requirements in order to be covered by the Trust. Retired and terminated employees may also continue benefit coverage under provisions of the Consolidated Omnibus Budget Reconciliation Act (COBRA) of 1985. The Trust is subject to the provisions of the Employee Retirement Income Security Act (ERISA). The Trustees oversee the governance of the Trust.

Insured Benefits

The Trust offers covered members' hospital, medical, surgical, and vision coverage with HealthNet under a group insurance arrangement which is pool-rated. Dental benefits are provided by pool and experience-rated insurance contracts with Oregon Dental Service dba Delta Dental Plan of Oregon (ODS) and Willamette Dental Insurance (Willamette Dental). Life and disability benefits are provided through experience-rated group insurance contracts with The Standard Insurance Company (The Standard). Premiums for insured benefits are paid from the assets of the Trust.

Experience-Rated Contracts

Certain insurance contracts are subject to experience rating adjustments. Experience ratings (calculated as the difference between premiums paid and the total of claims paid and fees charged by the insurance company) are determined by the insurance company in the following year and may result in a premium surplus or deficit. Future premium rates paid may be impacted by the accumulated experience gains and losses incurred by the affected insurance company.

Contributions

Employers and participants contribute specified amounts to the Trust based on applicable monthly premiums for their respective benefit elections.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Trust are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Cash and Cash Equivalents

For purposes of financial statement presentation, the Trust considers all highly liquid investments purchased with a maturity of three months or less to be cash equivalents.

Payment of Benefits

Premiums paid by the Trust are recorded as premium payments in the accompanying statements of changes in net assets available for benefits.

Experience-Rated Contracts and Refunds

For experience-rated contracts, premium surpluses are recorded as a receivable from the insurance company. Refunds due as of the financial statements date have been reported as a receivable, with the offset being netted against claims paid.

Premium Stabilization Reserve

The Trust is required to maintain a premium stabilization reserve with some insurance companies, which can be drawn against to reduce future premium payments when premiums paid to the insurance companies exceed the total of claims paid and other charges. The premium stabilization reserve has been included as an asset of the Trust until such amounts are used to pay premiums. The reserve is non-forfeitable should the insurance contracts terminate.

Administrative Expenses

Expenses of maintaining the Trust are paid from Trust assets, including an administrative fee paid to the Trust Administrator, professional fees for consulting, and other professional services.

Recent Accounting Standard Adopted

On January 1, 2023, the Plan adopted Accounting Standards Update (ASU) 2016-13 Financial Instruments - Credit Losses (Topic 326): *Measurement of Credit Losses on Financial Instruments*, and all related amendments (ASC 326), which replaced the incurred loss methodology for recognizing credit losses with an expected loss methodology that is referred to as the current expected credit loss (CECL) methodology. CECL requires an estimate of lifetime expected credit losses to be recognized for financial assets based on historical experience, current conditions, and reasonable and supportable forecasts, and for the financial assets to be presented at the net amount expected to be collected on the statements of net assets available for benefits. The financial assets held by the Trust that are subject to ASC 326 is contributions receivable and experience refund receivable.

2. Summary of Significant Accounting Policies, continued

The Trust adopted ASC 326 effective January 1, 2023. There was no impact to the financial statements as a result of adopting this standard.

3. Cash and Cash Equivalents

Cash and cash equivalents consist of funds deposited in a local depository noninterest-bearing checking account and an interest-bearing money market account. Balances in these accounts are currently insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000. At times, balances at a financial institution by the Trust may exceed \$250,000, which represents a credit risk to the Trust as any portion of the deposits in excess of this amount is not subject to federal insurance. There were no account balances in excess of this insured limit as of December 31, 2024 and 2023. Included in cash and cash equivalents is interest bearing cash of \$109,071 and \$83,603 as of December 31, 2024 and 2023.

4. Contributions Receivable

Contributions receivable are recorded at the amount the Trust expects to collect on balances outstanding. The Trust Administrator closely monitors outstanding balances and records an allowance for credit losses for amounts it may be unable to collect. There was no allowance for credit losses at December 31, 2024 and 2023.

The Trust receives insurance payments from participating employers in advance which are recorded with prepaid contributions on the statements of net assets available for benefits. At December 31, 2024 and 2023, there were \$3,127 and \$2,638 contributions due to the Trust from the participating employers but not yet transferred from Cascade Employers Association, Inc. (Cascade).

5. Experience Refund Receivable

Each year, experience-rated insurance contracts are analyzed by the insurer for claims experience and possible experience refunds, and an amount is provided as an experience refund to be received by the Trust. This amount is recorded as a receivable at December 31, with the offset being netted against claims paid. Experience refund receivables were \$24,411 and \$33,889 at December 31, 2024 and 2023, respectively.

6. Reserves Held with Insurance Companies

Some insurance contracts held by the Trust require a deposit or claim reserve against which the insurance company can apply possible future losses in excess of current premiums. Similarly, some insurance companies hold premium stabilization reserves which may be used to reduce future premium payments. Until these reserves are used to pay premiums, they are considered Trust assets. Changes in the balance of these reserve accounts are netted with current year premium payments made to insurance companies. The Trust's balance of deposits and reserves held with insurance companies at December 31, 2024 and 2023 was \$38,689 and \$89,053, respectively.

It is possible that upon termination of an experience-rated contract the Trust would not receive the full amount of the reserves held at the time of termination. At this time, the Trust has no plans to terminate any of its experience-rated contracts. The amount held as a stabilization reserve with Moda Health in connection with ODS includes \$7,643 and \$11,913, which was not considered available to the Trust at December 31, 2024 and 2023, respectively.

7. Related Party and Party-in-Interest Transactions

Cascade is the agent for the insurance companies providing benefits under the Trust. As the agent, Cascade received commissions from the insurance companies in the amount of \$107,156 and \$133,499 for the years ended December 31, 2024 and 2023, respectively.

In addition to commissions received, Cascade charges participating employers a 2 percent assessment on insurance premiums. This assessment is disclosed on monthly invoices and in the participation agreement that is signed upon enrollment. The assessment is not considered an expense of the Trust and is never received by the Trust. This assessment totaled \$30,816 and \$39,031 for the years ended December 31, 2024 and 2023, respectively.

Cascade charges a monthly fee of \$2,500 for administrative and various other services provided. For years ended December 31, 2024 and 2023, the Trust paid a service fee to Cascade of \$30,000.

All of the Trust's related party and party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

8. Plan Termination

Although they have not expressed any intention to do so, the Trustees have the right under the Trust to modify the benefits provided to, and contributions required of, participants and to terminate the Trust subject to the provisions of ERISA. In the event of termination of the Trust, remaining assets will be used to continue the Trust until all Trust assets have been used to provide benefits to covered employees or to liquidate the Trust and distribute assets to a successor fund to provide benefits to covered employees. No assets of the Trust may revert to any employer or the Administrator or be used for purposes other than for the exclusive benefit of the covered employees, dependents and beneficiaries.

9. Tax Status

The Trust is intended to qualify pursuant to Section 501(c)(9) of the Internal Revenue Code (IRC) and, accordingly, the Trust and Plan's net income are exempt from federal and state income taxes. The Trustees believe the Trust and the Plan, as amended, continue to qualify and to operate in accordance with applicable provisions of the IRC.

9. Tax Status, continued

U.S. GAAP requires the Trustees to evaluate tax positions taken by the Trust and recognize a tax liability (or asset) if the Trust has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Trust is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

10. Concentration – Major Provider of Insurance Benefits

The Trust offers insurance benefits for covered participants through HealthNet, ODS, Willamette Dental, and The Standard. The Trust purchased 93 percent of all insurance benefits provided from HealthNet during the years ended December 31, 2024 and 2023.

Each year HealthNet reevaluates the relationship with the Trust and provides rates to renew insurance coverage for covered employers. If HealthNet chooses to not renew coverage or to increase rates to a level such that the Trust cannot provide competitive quotes, the Trust operations and its ability to continue to provide affordable insurance benefits for covered employers would be impacted.

11. Subsequent Events

Management evaluates events and transactions that occur after the statement of net assets available for benefits date as potential subsequent events. Management has performed this evaluation through the date of the independent auditor's report.

Subsequent to year end, the amount paid to Cascade by the Trust for administrative and various other services increased to \$3,500 monthly.
