## INDEPENDENT AUDITOR'S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Columbia 401(k) Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

#### **Note 1 - Description of the Plan**

The following description of the Columbia 401(k) Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### General

The Plan is a defined contribution plan covering all employees of Columbia Trailer Co., Inc. dba Columbia Corporation (the Company) who are age 18 or older. The Plan provides participants with a salary deferral option pursuant to Section 401(k) of the Internal Revenue Code (IRC). The Plan engages Reliance Trust Company (Custodian) to hold and invest Plan assets and execute Plan transactions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

##### Contributions

A participant may elect to contribute up to the maximum allowed under the IRC, which was \$23,000 in 2024, each year instead of receiving that amount in cash. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions of \$7,500 in 2024. Participants may also contribute amounts representing distributions from other qualified plans (rollover). The amount deferred will not be subject to income tax until it is actually distributed to the participant. The amount deferred is, however, subject to Social Security tax at the time of deferral. The participant may change their deferral election each pay period.

The Company contributed a safe harbor match in 2024 to all participants in an amount equal to 100% of deferrals that do not exceed 3% of eligible compensation, plus 50% of deferrals between 3% and 5% of eligible compensation, which is automatically 100% vested. The Company contributed a non-elective discretionary profit sharing contribution to the Plan in 2024 which consisted of 2% of participant compensation for all eligible employees. The safe harbor match and discretionary profit sharing contributions are only allocated to employees who have completed one year of service, defined as twelve months credited with at least 1,000 hours of service.

##### Investment Elections

Participants direct the investment of their contributions into various investment options offered by the Plan. Participants have the opportunity to change their investment combinations on a daily basis.

##### Participant Accounts

Each participant's account is credited with the participant's contributions and employer safe harbor matching contributions as well as allocations of the Company's profit sharing contributions and Plan investment earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on account balances, or specific participant transactions, as defined by the Plan Agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### Vesting

Participants are immediately vested in their voluntary contributions, employer safe harbor match, and profit sharing contributions plus actual earnings thereon.

##### Payment of Benefits

Upon termination of service due to death, disability or retirement a participant may elect to receive either a lump-sum amount equal to the value of their account or an annuity as specified by the Plan. For termination of service for other reasons, a participant may receive the value of the vested interest in their account as a lump sum distribution. Vested account balances less than \$7,000 upon termination may be distributed without the Participant's consent in a lump-sum. Participants may also elect to take in-service or hardship withdrawals subject to the terms of the Plan document and Internal Revenue Service (IRS) regulations.

##### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### **Note 2 - Summary of Significant Accounting Policies**

##### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### Investments Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies using the information provided by the Plan's Custodian and third-party administrator. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### Payments of Benefits

Benefits are recorded when paid.

##### Expenses

Certain Plan expenses are deducted from participant accounts or investment income, and the remainder of Plan expenses are paid by the Company. Fees associated with processing a transaction for an individual account are deducted directly from the participant's account. Investment related expenses are included in the net appreciation in fair value of investments.

##### Subsequent Events

The Plan has evaluated subsequent events through September 24, 2025, which is the date the financial statements were available to be issued.

##### Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **Note 3 - Information Certified by Custodian**

The Plan's investments are held by Reliance Trust Company, the Custodian of the Plan. Investment decisions are made at the direction of the participants. The investments are credited for earnings thereon and charged for withdrawals and expenses as charged by the Custodian. The Plan Administrator has obtained a certification from the Custodian as of December 31, 2024 and 2023 and for the year ended December 31, 2024, that the following information provided to the Plan Administrator by the Custodian is complete and accurate:

- Investments, at fair value
- Investments, at contract value
- Net appreciation in fair value of investments
- Interest and dividends

#### Note 4 - Fair Value Measurements

Fair value is the price that would be received from selling an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. When determining the fair value measurements for assets and liabilities required to be recorded at fair value, the Plan considers the principal or most advantageous market in which it would transact and considers assumptions that market participants would use when pricing the asset or liability, such as inherent risk, transfer restrictions, and risk of nonperformance.

The Plan follows a fair value hierarchy to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. A financial instrument's categorization within the fair value hierarchy is based upon the lowest level of input that is significant to the fair value measurement. Three levels of inputs may be used to measure fair value:

Level 1 - quoted prices in active markets for identical assets or liabilities.

Level 2 - inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 - unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

*Registered Investment Companies (Mutual Funds):* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded.

*Common Collective Trusts (CCT):* CCTs invest in a variety of guaranteed investment contracts, domestic stocks, international stocks, mutual funds, bonds and other securities. The majority of the underlying securities have observable level 1 quoted pricing inputs. While the underlying asset values are generally based on publicly quoted prices, the NAV of each individual CCT is not valued using publicly quoted prices.

#### Note 4 - Fair Value Measurements, continued

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. The inputs used for valuing securities are not necessarily an indication of the risk associated with investing in those securities.

The following table summarizes investments for which fair value is measured using the NAV per share practical expedient. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

#### Note 5 - Stable Asset Fund

The Plan holds a fully benefit-responsive investment contract with Standard Insurance Company (Standard). Standard maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan by the Standard. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The Stable Asset Fund issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The contract value of the investment was \$58,033 at December 31, 2024 (\$128,602 at December 31, 2023).

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting. The major credit rating of the Stable Asset Fund is A1 as of December 31, 2024, as reported by Moody's.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment may apply. The Plan Administrator does not believe any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The Stable Asset Fund does not permit the Standard to terminate the agreement prior to the scheduled maturity date without reasonable cause, which includes the contract owner's failure to abide by state or federal law, failure to render performance necessary to comply with the terms of the contract, failure to maintain assets of at least \$25,000, Plan disqualification, or failure to adopt the Plan in a reasonable period of time.

#### Note 6 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

#### **Note 7 - Tax Status**

The IRS has determined and informed the Plan's volume submitter sponsor by an opinion letter dated June 30, 2020, that the Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA plan sponsored by Standard Retirement Services Inc., which has been adopted by the Plan, is acceptable pursuant to section 401 of the IRC and in compliance with the applicable requirements of the IRC. The Plan has not requested its own determination letter from the IRS. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 8 - Party-in-Interest Transactions**

Plan investments include shares of collective trust funds managed by Reliance Trust Company and a Stable Asset Fund contract with Standard Insurance Company. Reliance Trust Company is the Custodian and Standard Insurance Company is an affiliate of The Standard, the Plan's third-party administrator. The Plan paid \$27,241 of recordkeeping fees to The Standard in the year ended December 31, 2024. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

#### **Note 9 - Delinquent Employee Deferral Transmittals**

During the year ended December 31, 2024, the Plan Sponsor failed to transmit to the Plan participant contributions within the time period described in 29 CFR 2510.3-102. The total amount of delinquent contributions for the year then ended was \$13,060. As of the date of the issuance of the December 31, 2024, financial statements, all contributions for the delinquent 2024 contributions have been remitted. The remaining lost earnings are in the process of being remitted. Additionally, \$42,078 of late remittances related to year ended December 31, 2023 were fully corrected during the year ended December 31, 2024
