## **INDEPENDENT AUDITOR'S REPORT**

To the Administrative Committee of the  
Drum Workshop, Inc. 401(k) Profit Sharing Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the accompanying financial statements of Drum Workshop, Inc. 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits – modified cash basis as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits – modified cash basis for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Drum Workshop, Inc. 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, which was certified by Reliance Trust Company, the custodian of the Plan (the "Custodian"), is complete and accurate.

### **Opinion**

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.
- the information in the financial statements referred to above related to assets held by and certified to by the Custodian, a qualified institution, agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Drum Workshop, Inc. 401(k) Profit Sharing Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Basis of Accounting**

As described in Note 1, the financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements, as a whole, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

**1. Plan description and summary of significant accounting policies**

***General***

Drum Workshop, Inc. (the “Company”) sponsors the Drum Workshop, Inc. 401(k) Profit Sharing Plan (the “Plan”). The following description provides only general information about the Plan. Participants should refer to the Plan document for a more complete description of the Plan provisions. The Plan is a qualified contributory defined contribution and profit-sharing plan that provides retirement, death, and disability benefits for eligible employees of the Company. The Plan covers all employees 21 years and older who have completed three months of eligible service, as defined in the Plan document. The Plan is subject to the Employee Retirement Income Security Act of 1974 (“ERISA”).

***Basis of accounting***

The Plan’s financial statements are prepared using a modified cash basis of accounting, which is a special purpose framework other than accounting principles generally accepted in the United States of America (“GAAP”). This basis of accounting is consistent with that used by the Plan’s third-party administrator and custodian and is permitted under ERISA. Under this basis, certain receivables and payables (such as employee contributions receivable, interest and dividends receivable, and excess contributions payable) are not reflected until cash is received or disbursed. Users should be aware of these differences when comparing to financial statements prepared in accordance with GAAP.

***Administration of plan assets and a change in the trustee***

Reliance Trust Company (the “Custodian”) continues to serve as the custodian of the Plan’s assets. Through June 28, 2024, the Custodian also served as the trustee of the Plan. Effective June 29, 2024, Transamerica Trust Company succeeded the Custodian as the trustee. Accordingly, references to the “Trustee” in these financial statements refer to the Custodian for periods prior to June 29, 2024, and to Transamerica Trust Company thereafter. The Trustees are both qualified institutions under ERISA Section 103(a)(3)(C).

The Plan does not compensate certain Company officers or employees involved with Plan administration for such services. Certain administrative expenses and fees, including certain Trustee fees, recordkeeping, accounting fees, and advisory fees, are paid directly by the Plan and total \$65,078 for the year ended December 31, 2024. The Company pays other administrative expenses, including auditing and legal fees.

***Use of estimates***

The Plan administrator must make estimates and assumptions that affect certain reported amounts of the Plan assets, liabilities, changes in net assets, and disclosures as of the date of the financial statements. Accordingly, actual results could differ from those estimates.

***Investment options***

All investments are held in trust and are invested in registered investment companies and an insurance contract as of December 31, 2024 and 2023. Certain investment options incur fees and expenses embedded in the related investments. Refer to each investment prospectus for information on the investment, including applicable fees and expenses. Each participant chooses how their contributions and respective account balances will be allocated among the various investments through a participant-directed investment program. Investment income, gains, and losses are allocated to each participant's account each business day.

***Contributions***

Each year, participants may make elective contributions up to 90% of their annual pre-tax compensation, subject to certain limitations in accordance with the Internal Revenue Code ("IRC"). Transfers from other qualified plans are allowed under the provisions of the Plan. The Plan provides for the automatic election of deferrals at a rate of 5% of compensation for eligible new participants who do not decline to participate within 30 days of becoming eligible participants. The Plan provides for matching Company contributions of 20% for every 1% of the participant's elective contributions, up to a maximum of 10% of compensation. For each participant who contributes 10% or more of their compensation, the maximum Company contribution is 2% of compensation throughout the year. In addition, the Plan provides for a discretionary Company contribution. The Company made matching contributions of \$203,425 and no discretionary contributions for the year ended December 31, 2024.

***Participant accounts***

Each participant's account is increased with the participant's contributions (including elective and rollover), the Company's matching contributions, the Company's discretionary contributions, investment earnings, and forfeitures of terminated participants' non-vested accounts. Each participant's account is decreased with investment losses, benefit payments, corrective distributions, and an allocation of any administrative expenses paid by the Plan. Allocations are based on certain components of each participant's account balances or earnings, as defined in the Plan document. The benefit to which a participant is entitled is determined by and dependent on the value of the participant's vested account balance at the measurement date.

***Vesting***

The participant's vested benefit is based on years of service. Each participant receives one year of vesting service for each year of 1,000 hours or more of service. Balances in a participant's elective contribution account and rollover account are 100% vested. The participant's Company matching contribution and discretionary contribution accounts ("Company Contribution Accounts") become 100% vested upon reaching the normal retirement age of 65, death, or termination of employment because of a disability. Otherwise, balances in the Company Contribution Accounts have a six-year vesting schedule, as follows:

***Forfeited amounts***

The non-vested portion of the terminated participants' Company Contribution Accounts is forfeited and reallocated to reduce employer contributions. Forfeitures are \$9,667 for the year ended December 31, 2024. The balance of unused forfeitures available for future application was \$640 as of December 31, 2024.

***Benefit payments***

Upon death, disability, retirement, or termination of employment, a participant with a vested account balance exceeding \$5,000 may elect to receive a lump-sum distribution equal to the value of their account or a distribution in equal installments over a period of time as defined in the Plan document. The Plan will distribute the balance in a lump-sum distribution for vested account balances less than \$1,000. In addition, participants who have attained the age of 59½ may withdraw all or any part of the vested portion of their account. Hardship distributions are permitted, but the participants are suspended from contributing to the Plan for the succeeding six months and are limited to withdrawing from their vested balance, as defined in the Plan document.

Benefit payments are recorded when paid.

***Participant notes receivable***

Participants may borrow a minimum of \$500 from their account up to \$50,000 or 50% of their vested account balance, whichever is less. Loan transactions are treated as a transfer to (from) the participant's investments from (to) the participant's loan fund. Loan terms range from one to five years or up to 30 years for purchasing a primary residence. The loans are secured by the balance in the participant's account and bear interest as determined by the Plan administrator. Interest rates range from 4.25% to 9.50%. Principal and interest are payable through bi-weekly payroll deductions. Participant notes receivable is reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. As of December 31, 2024, there is accrued interest of \$1,156. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the Plan administrator considers the participant's loan to be in default, the loan balance is reduced, and the delinquent participant's note receivable is recorded as a benefit payment. No allowance for losses from delinquent participant notes receivable is recorded as of December 31, 2024 and 2023. Participant notes receivable are classified as "party-in-interest" and are therefore exempt from the prohibited transaction rules.

***Termination***

Although the Company has not expressed any intent to do so, it has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants' Company Contribution Accounts will become 100% vested, and the Plan's net assets will be distributed, as prescribed by ERISA.

***Tax status***

The Internal Revenue Service ("IRS") has determined, by a letter dated June 30, 2020, that the prototype plan and related trust adopted by the Company complied with the applicable requirements of the IRC. The Plan has been amended since receiving the determination letter. The Plan administrator and tax counsel believe that the Plan complies with the applicable requirements of the IRC and that the related trust is tax-exempt as of the date of the financial statements. Accordingly, no provision for income taxes is included in the Plan's financial statements. The Plan's federal and state information returns are subject to examination by federal and various state tax agencies until the statutes of limitations on the returns expire. In general, federal returns have a three-year statute of limitations. The various state income tax returns have their applicable statutes of limitations, generally four years or less. The statutes of limitations begin to run on the date the returns are filed with the related tax jurisdictions. With few exceptions, the Plan is no longer subject to federal and state tax jurisdiction examinations for the years ended before December 31, 2021 and 2020, respectively.

***Investment valuation and income recognition***

Investments are reported at fair value. Fair value is the price received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of investments, and resulting gains and losses, are recorded on a trade date basis. Net gains and losses from investment transactions are computed using the “average-cost” method. Interest and dividend income are recorded when earned. Capital gain distributions are included in dividend income. Net appreciation is the sum of the Plan’s gains and losses on investments bought, sold, and held during the year.

***Risks and uncertainties***

The Plan offers various investment options, including mutual funds (domestic and international), bonds, and other investment vehicles. Investment securities are exposed to various risks, including interest rates, market, and credit. It is at least reasonably possible that changes in risks and in the value of investment securities could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

Participants may direct their contributions to various investment options, including certain registered investment companies and an insurance contract holding securities of foreign companies. These investments may carry unique risks and considerations not usually associated with investing in companies in the United States (“U.S.”). Possible risks include currency fluctuations or devaluation, less reliable issuer information, different securities transaction clearance and settlement procedures, and potential adverse political and economic developments. Additionally, the securities of foreign companies and their markets may be less liquid, and their prices may be more volatile compared to those of similar U.S. companies.

***Subsequent events***

The Plan's administrator has evaluated events and transactions occurring subsequent to the statement of net assets available for benefits date of December 31, 2024, for items that should be recognized or disclosed in these financial statements. The evaluation was conducted through September 22, 2025, the date when these financial statements were available to be issued. No such material events or transactions were noted to have occurred.

**2. Fair value measurements**

Investments are reported at fair value in the statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not indicate the net realizable value or reflect future fair values. Although the Plan administrator believes their valuation methods are appropriate and consistent with other market participants, using different methodologies or assumptions to determine the fair value of specific financial instruments could result in a different fair value measurement at the reporting date.

The Plan administrator uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan administrator measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

The following describes the valuation methods used for assets that are required to be measured at fair value. The methodologies have remained unchanged as of December 31, 2024 and 2023.

**Level 1**

The fair value of registered investment companies is based on the quoted net asset values of the shares held by the Plan at year-end.

**3. Net asset value for insurance contracts and common/collective trusts**

Insurance contracts and common/collective trusts are recorded at net asset value (NAV). The NAV is determined by the pricing and valuation of the underlying investments comprising total assets minus total liabilities, divided by the number of outstanding units held by the Plan. The NAV for insurance contracts is \$310,198 and \$276,601 as of December 31, 2024 and 2023, respectively. The NAV for common collective trusts is \$2,531 as of December 31, 2023,

**4. Certifications**

The following is a summary of the unaudited information included in the Plan's financial statements and supplemental schedule prepared by the Custodian and furnished to the Plan administrator. The Custodian holds the Plan's investment assets and executes investment transactions on behalf of, and as directed by, the participants. The Plan administrator obtained certifications from the Custodian that the following information is complete and accurate:

- (a) Fair value and cost of all assets as of December 31, 2024 and 2023.
- (b) Net appreciation in the fair value of investments and interest and dividend income for the year ended December 31, 2024.
- (c) Supplemental schedule of assets held at the end of the year December 31, 2024.

**5. Party-in-interest**

An affiliate of the Trustee manages certain Plan investments. These transactions qualify as "party-in-interest," which are exempt from the prohibited transaction rules. If applicable, purchase fees are paid by the participants investing in those funds subject to such fees. Fees paid by the Plan for the investment management services were \$65,078 and are included in administrative expenses for the year ended December 31, 2024.

**6. Reconciliation to Form 5500**

The financial statements for the year ended December 31, 2024, agree to the IRS Form 5500, Annual Return/Report of Employee Benefit Plan, without exception.

**7. Supplemental Schedules**

The accompanying supplemental schedule is presented in accordance with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA and is not part of the basic financial statements. For the year ended December 31, 2024, the applicable schedule is Schedule H, Line 4i – Schedule of Assets (Held at End of Year). Management has evaluated the other supplemental schedules required under ERISA and the Department of Labor's rules, including the Schedule of Delinquent Participant Contributions, and determined that they are not applicable for the year ended December 31, 2024.
