Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of JEWISH COUNCIL FOR YOUTH SERVICES 401(K) PROFIT SHARING PLAN, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of JEWISH COUNCIL FOR YOUTH SERVICES 401(K) PROFIT SHARING PLAN's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Responsibilities of Management for the Financial Statements

NOTES TO FINANCIAL STATEMENTS

NOTE 1—PLAN DESCRIPTION

The following description of the Jewish Council for Youth Services 401(k) Profit Sharing Plan (“Plan”) provides only general information. Readers of the financial statements should refer to the Plan agreement for a more comprehensive description of the Plan’s provisions.

1. General – The Plan is a defined contribution plan covering all employees of Jewish Council for Youth Services (the “Council”) who are over 21 years of age and have completed a year of eligibility service, defined as a 12-month consecutive period during which an employee completes 1,000 hours of service. Effective January 25, 2018, the year of eligibility requirement was removed. After meeting the requirements, participants can make voluntary 401(k) contributions. A plan participant must also complete 500 hours of service to receive a discretionary match or profit-sharing contribution. Effective January 1, 2021, the requirement to receive a discretionary match or profit-sharing contribution changed to (1) eligible employee will be required to be employed on the last day of the plan year, and (2) must work at least 1,000 hours in order to receive discretionary match or profit-sharing contribution. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
2. Contributions – Participants may choose to contribute by payroll deduction up to 100% of their compensation, to a maximum of \$23,000 for 2024 and \$22,500 for 2023. Participants who are at least age 50 may make additional “catch-up” contributions of \$7,500 in 2024 and in 2023.

The Council may elect to make a discretionary matching or profit-sharing contribution. The Council made a matching contribution for 2024 and 2023.

3. Participant Accounts – each participant’s account is credited with the participant’s contribution and allocation of the Council’s contributions and plan earnings. Participants direct the investment of their contributions and the Council’s contributions into various investment options offered by the Plan.
4. Vesting – Participants are 100% vested in their voluntary contributions plus actual earnings thereon. Participants’ vesting in the Council’s matching contributions, plus actual earnings thereon, is determined in accordance with a schedule based on the participant’s years of service.
5. Forfeited Accounts – The Plan uses forfeitures to pay administrative expenses. Forfeitures utilized to pay plan expenses were \$25,182 for 2024 and \$-0- for 2023. Unused forfeitures were \$-0- at December 31, 2024 and 2023.
6. Payment of Benefits – On termination of service due to death, disability, or retirement, a participant may elect one of several methods to distribute the value of a participant’s vested account, as defined by the Plan. Participants may receive distributions of their voluntary contributions, not including earnings thereon, rollover contributions, and transfers under certain financial hardship circumstances.
7. Participant Loans – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant’s account and bear a reasonable fixed rate of interest determined by the Plan administrator. Principal and interest are paid ratably through regular payroll deductions.
8. Administrative Expenses – Certain administrative expenses of the Plan are paid by the Council.

NOTES TO FINANCIAL STATEMENTS

NOTE 2—SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

BASIS OF ACCOUNTING

The accompanying financial statements have been prepared using the accrual basis of accounting.

USE OF ESTIMATES

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions to and deductions from plan assets during the reporting period. Actual results could differ from those estimates.

INVESTMENT VALUATION AND INCOME RECOGNITION

The Plan's investments are held by John Hancock Life Insurance Company (U.S.A.). All investments are valued at market value as of December 31, 2024 and 2023.

Purchases and sales of securities are reflected on a trade-date basis. Realized gains and losses on the sale of securities are computed on a specific identification basis.

Dividend and interest income are recognized when received. Net appreciation (depreciation) on investments held represents the change in market value of the investments from the beginning of the Plan year (or date the investments were purchased, if later) to the end of the Plan year. Both are included in investment income (loss) – net realized and unrealized gains (losses) on pooled separate accounts.

NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are valued at unpaid balances which approximates fair value. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

BENEFIT PAYMENTS

Benefit payments to participants are recorded when paid.

NOTE 3—FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

NOTES TO FINANCIAL STATEMENTS

NOTE 3—FAIR VALUE MEASUREMENTS (Continued)

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Level 1 Fair Value Measurements

The fair value of the pooled separate accounts is based on quoted net asset values of the underlying mutual funds held by the Plan at year-end.

Level 2 Fair Value Measurements

Level 2 Fair Value Measurements are not applicable to the Plan for 2024 and 2023.

Level 3 Fair Value Measurements

Level 3 Fair Value Measurements are not applicable to the Plan for 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

In accordance with subtopic 820-10, certain investments that were measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statement of net assets available for benefits.

Money market funds are valued at the net asset value (“NAV”) of shares held by the Plan at year-end. NAV is determined by each fund’s recordkeeper based on the fair value of the underlying securities held less liabilities held by the fund. This practical expedient is not used when it is determined to be provable that the fund will sell the investment for an amount different than the reported NAV. Plan transactions (issuance and redemptions) may occur daily. There are no restrictions on a participant’s ability to redeem investments. However, withdrawals prompted by certain events (e.g., termination of the managed income portfolio, changes in laws and regulations) may restrict a participant’s ability to redeem the investment at its NAV.

NOTE 4—INFORMATION CERTIFIED BY THE PLAN'S RECORDKEEPER

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-5(c) of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Recordkeeper has certified that the following data included in the accompanying financial statements and schedule is complete and accurate.

- a. Investments, as shown in the accompanying statements of net assets available for benefits, as of December 31, 2024 and 2023.
- b. Investment income, as shown in the accompanying statements of changes in net assets available for benefits, for the years ended December 31, 2024 and 2023.
- c. The schedule of assets (held at end of year) as of December 31, 2024, as shown on Schedule H, Line 4(i).

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

NOTE 5—PARTICIPANT NOTES RECEIVABLE

Participants may borrow up to 50% of their vested account balance, with a maximum loan amount of \$50,000, and a minimum amount of \$1,000. Repayments of principal and interest are made in bi-weekly installments over the specified loan period. In no instance may the term of repayment be greater than five years, unless the loan is used to acquire the participant's principal residence. Loans have fixed interest rates which are typically based on the prime rate (8.50% at December 31, 2024 and 7.50% at December 31, 2023) plus 1%, as quoted in the Wall Street Journal. As allowed by the Section 2202 of the CARES act, the plan sponsors amended their plan for participants adversely affected by COVID-19. Participants affected could withdraw the amount of the participant's vested balance up to \$100,000 which is to be paid within 3 years to avoid tax consequences between the period of March 27, 2020 and September 23, 2020. No participants elected to borrow under this new provision in 2020.

NOTES TO FINANCIAL STATEMENTS

NOTE 6—PARTY-IN-INTEREST TRANSACTIONS

The Plan's investments are managed by John Hancock Life Insurance Company (U.S.A.), the recordkeeper of the Plan. Hunter Benefits Consulting Group, Inc. is the Plan's third-party administrator. Both of these entities qualify as parties-in-interest. The Plan paid \$13,070 in 2024 and \$11,302 in 2023 in administrative fees to John Hancock Life Insurance Company (U.S.A.). The Council also paid \$3,393 in 2024 and \$875 in 2023 in administrative fees to Hunter Benefits Consulting Group, Inc.

NOTE 7—PLAN TERMINATION

Although it has not expressed any intent to do so, the Council has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 8—TAX STATUS

The Plan is a Prototype Non-Standardized Profit-Sharing Plan with CODA ("Prototype Plan") designed by Fort William LLC. The Prototype Plan was adopted by the Council. The Prototype Plan obtained its latest determination letter on March 31, 2014, in which the Internal Revenue Service ("IRS") stated that the Prototype Plan, as then designed, was in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement dates.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9—RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 10—SUBSEQUENT EVENTS

Management has evaluated subsequent events through September 29, 2025, the date which the financial statements were available to be issued. There were no subsequent events which require disclosure.
