INDEPENDENT AUDITOR'S REPORT

To the Retirement Committee of the
Southwestern Law School DC Retirement Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements

We were engaged to perform audits of the financial statements of the Southwestern Law School DC Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency ("qualified institution"), provided that the investment information regarding assets so held is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Disclaimer of Opinion

We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matter described in the *Basis for Disclaimer of Opinion* section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

Basis for Disclaimer of Opinion

As described in Note 2, the Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the financial statements may have been affected by these conditions.



Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”), and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern within one year after the date the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor’s Responsibilities for the Audit of the Financial Statements

Our responsibility is to conduct an audit of the Plan’s financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditor’s report. However, because of the matter described in the *Basis for Disclaimer of Opinion* section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements related to our audit.

Other Matter – Supplemental Schedule Required by ERISA

The supplemental schedule of Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. Because of the significance of the matter described in the *Basis for Disclaimer of Opinion* section, it is inappropriate to and we do not express an opinion on the supplemental schedule referred to above.

1. PLAN DESCRIPTION

The following description of the Southwestern Law School DC Retirement Plan (the "Plan") provides only general information. Participants and other interested parties should refer to the Plan document for a more complete description of the Plan's provisions. The Plan utilizes Teachers Insurance and Annuity Association of America ("TIAA") and College Retirement Equities Fund ("CREF"), an insurance company and issuer of certain annuity contract investment assets of the Plan, and TIAA Trust, N.A., as a directed custodian, as its custodian (collectively, the "Custodian" or "TIAA-CREF").

General - The Plan is a defined contribution plan covering eligible employees who have been employed by Southwestern Law School (the "Plan Sponsor" or "Employer") in accordance with the universal availability standards. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Contributions - Each year, participants may contribute pre-tax and Roth deferrals up to 100 percent of eligible annual compensation, as defined and subject to certain limitations under the Internal Revenue Code ("IRC"). Effective January 1, 2024, the Plan was amended to include automatic enrollment provision for all eligible employees to be automatically enrolled at a pre-tax rate of five percent of eligible compensation, unless elected otherwise. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other eligible retirement plans, as defined. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan provides for Employer matching contributions. To be eligible to receive Employer matching contributions, a participant must be employed for one year (1,000 hours). Participants that contribute at least five percent of their compensation as pre-tax or Roth deferrals will receive an Employer matching contribution of nine percent of their eligible compensation, as defined in the Plan document. The Employer matching contribution was \$1,761,755 for the year ended December 31, 2024.

The Employer corrective contributions of \$10,783 for the year ended December 31, 2024 relates to the correction for a participant who had missed salary deferral opportunities over multiple Plan years.

Participant Accounts - Each participant's account is credited with the participant's contributions and Employer matching and corrective contributions and Plan earnings and charged with any withdrawals or distributions requested by the participant, investment losses and allocation of administrative expenses, if applicable. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are vested immediately in their contributions, Employer matching contributions, Employer corrective contributions, plus actual earnings thereon. As such, there were no forfeited non-vested accounts as of December 31, 2024 and 2023.

Plan Loans - Plan loans are available to participants through TIAA from a minimum of \$1,000 up to a maximum of 50 percent of a participant's account balance or \$50,000, whichever is lower. Participants may only maintain three loans at one time. A portion of a participant's TIAA Traditional Annuity account balance is reserved, or held as collateral, to cover 110% of the outstanding loan amount for the period of time the loan is outstanding. The term of a loan is either 5 or 10 years, depending on the loan purpose. The loan term may not extend beyond April 1 following the calendar year in which the participant attains age 70 1/2.

The loans bear an adjustable interest rate determined by TIAA based on the Moody's Corporate Bond Yield Averages or a similarly published average. Participants should refer to the loan agreement document provided by TIAA for a complete description of loan provisions. Refer to Note 3 for a description of the TIAA Traditional Annuity. Effective January 1, 2020, TIAA ceased offering Plan Loans.

As of December 31, 2024 and 2023, participants had outstanding Plan loan balances due to TIAA of \$17,880 and \$17,558, respectively. These loans were collateralized by the TIAA Traditional Annuity account balances of \$19,668 and \$19,314 as of December 31, 2024 and 2023, respectively. These amounts are included in the investment balances reported in the accompanying statements of net assets available for benefits. Investments underlying defaulted plan loans balances are reflected in the statements of net assets available for benefits until a distributable event occurs.

Payment of Benefits - On termination of service for any reason a participant or their beneficiaries, as applicable, may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account, partial withdrawals, annuity payments, or installment payments as permitted under the Plan. Effective January 1, 2024, the Plan was amended to increase the mandatory cash-out following severance of employment for account balances to less than \$7,000.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The accompanying financial statements have been prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America.

Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Contributions - Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the participant contributions are withheld from compensation.

Available Information - In November 2007, the Department of Labor ("DOL") issued amended regulations eliminating an exemption granted to 403(b) plans from the annual Form 5500 reporting and disclosure requirements under Part 1 of Subtitle B of Title I of ERISA. Prior to the amended regulations, the Plan (established in 1979) was not viewed as a separate reporting entity.

Historically, the Plan was viewed as a collection of individual contracts with which participants could engage in a range of actions with limited involvement, if any, by the Plan Sponsor. Accordingly, various records related to the Plan's 403(b) annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009, were not sufficiently maintained by the Plan. Consequently, the financial statements have been prepared based on available records analyzed by Plan management. As certain records were not available from the inception of the Plan, the effect, if any, on the completeness or accuracy of the Plan's financial statements cannot be determined.

Investment Valuation and Income Recognition - The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transaction under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Administrative Expenses - Certain administrative expenses incidental to the administration of the Plan may be paid by the Plan, unless otherwise paid by the Employer. Administrative expenses paid by the Employer are excluded from these financial statements.

Most investment options have fees which reduce the overall return on assets. The net appreciation of investments is reflected net of these fees.

Benefits Payable to Participants - Benefits are recorded when paid.

Subsequent Events - The Employer has evaluated subsequent events through August 18, 2025, which is the date that the financial statements were available to be issued, and determined that there were no subsequent events or transactions that required recognition or disclosure in the financial statements.

3. FAIR VALUE

The Plan accounts for its financial instruments using a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are the following:

- Level 1 – Inputs to the valuation methodology that are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in markets that are inactive; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

- Level 3 – Inputs to the valuation that are unobservable and significant to the fair value measurement.

A financial instrument's categorization within the valuation hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds – This category consists of publicly traded funds of registered investment companies. The net asset value ("NAV") of the mutual fund's shares is quoted on the exchange where the fund is traded and therefore classified as Level 1 within the valuation hierarchy.

TIAA Traditional Annuity – Investments in TIAA Traditional Annuity contracts are reported at contract value, which approximates fair value. As these investments are contract-based, observable prices for identical or similar investments do not exist and, accordingly, these investments are valued using unobservable inputs (Level 3). The contract value equals the accumulated cash contributions and interest credited to the contract, less any withdrawals. Liquidity restrictions apply to these investments that could impact the value realized upon exiting the contract.

Annuity contracts are invested in the TIAA Traditional Annuity fund. The annuity is a fixed annuity contract that is fully and unconditionally guaranteed by TIAA. The Traditional Annuity is offered through a variety of contract types, including Retirement Annuity ("RA"), Retirement Choice ("RC") and Retirement Choice Plus ("RCP") contracts. For accumulating RA contracts, the crediting interest rates were 5.25% and 6.75% as of December 31 2024 and 2023, respectively. For accumulating RC contracts, the crediting interest rates were 5.50% and 7.00% as of December 31, 2024 and 2023, respectively. For accumulating RCP contracts, the crediting interest rates were 4.75% and 6.25% as of December 31, 2024 and 2023, respectively. The guaranteed minimum rate of interest for RA contracts is three percent while the RC and RCP contracts is one to three percent.

CREF Variable Annuities – The fair values of accumulation units held by the Plan in CREF variable annuity accounts are based on each account's daily NAV, which is considered by Plan management to be the best approximation of fair value. Information distributed to Plan administrators and client investors provides sufficient corroborative evidence to ascertain the relationship between each fund's NAV and the values of individual underlying holdings. Underlying holdings are primarily valued using market quotations or prices obtained from independent pricing sources. There are no unfunded commitments from participants in the Plan who invest in these accounts.

TIAA-CREF Real Estate Variable Annuity Account ("REA") – The REA invests in real estate properties and real estate-related investments. The REA's value is principally derived from the market value of the underlying real estate holdings or other real estate-related investments. Real estate holdings are valued principally using external appraisals, which are estimates of property values based on a professional's opinion. The REA sometimes holds securities as well. These are generally priced using values obtained from independent pricing sources. Unit values are calculated each day and could be redeemed at that value and there are no unfunded commitments from participants in the Plan who invest in these accounts.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The investments measured at NAV consist of CREF variable annuities and the TIAA real estate account. The CREF variable annuities consist of the following types of funds:

Equity variable annuity accounts: Funds in this category invest in a diversified portfolio of domestic and/or foreign stocks to achieve a long-term rate of return.

Fixed income variable annuity accounts: Funds in this category invest in various types of debt securities to achieve a long-term rate of return while preserving capital. These funds invest heavily in U.S. Government bonds.

Multi-asset variable annuity accounts: This fund invests in domestic and foreign equities and in fixed income securities to achieve a long-term rate of return while giving special consideration to certain social criteria.

Money market variable annuity accounts: This fund invests in high-quality, short-term instruments to achieve high current income and capital preservation. This account primarily invests in commercial paper, bank obligations, and U.S. Government-issued securities that are classified as first-tier securities.

The TIAA real estate account invests in real estate properties, other real estate-related investments, and securities. Underlying real estate holdings are valued principally using external appraisals. Underlying securities are generally priced using values obtained from independent pricing sources.

Accordingly, as permitted under such election, the following information was obtained by management and agreed to or derived from information certified as complete and accurate by TIAA-CREF and was not subjected to any auditing procedures performed by the independent public accountants:

- b. Net appreciation of investments, interest and dividend income on investments, and interest income on notes receivable from participants as shown in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- c. Investments, fully benefit-responsive investment contract, and participant loans as listed in the accompanying Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024.

5. NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 less the highest outstanding loan balance during the prior 12 months or 50 percent of their vested account balance. Loans are generally issued with a maturity of up to five years. The term of any loan for the purpose of purchasing a primary residence shall not exceed 10 years. Participants may have three loans currently outstanding from the Plan. The loan interest rate is determined by the plan administrator based on prevailing rates, as defined by the Plan. Principal and interest are paid ratably through an ACH agreement to repay the loan.

6. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with TIAA totaling \$1,613,580 and \$1,580,127 as of December 31, 2024 and 2023, respectively. TIAA maintains the contributions in a nonunitized separate account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

TIAA is contractually obligated to repay the principal and specified interest rate that is guaranteed to the Plan. There are no reserves against contract value for the credit risk of TIAA or otherwise. The crediting interest rate is based on a formula agreed upon with TIAA. Such interest rates are reset quarterly as of the beginning of each month.

The TIAA Stable Value Fund meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by TIAA, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on TIAA's ability to meet its financial obligations. TIAA's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with TIAA. Such events include, but are not limited to the following: (1) premature termination of the contracts by the Plan, (2) Employer layoffs, (3) bankruptcy of the Plan Sponsor, (4) Plan termination, (5) mergers, or (6) early retirement incentives. The plan administrator believes that no events are probable of occurring that might limit the ability of the Plan to transact at contract value with TIAA and that would also limit the Plan's ability to transact at contract value with participants.

7. PLAN SERVICING CREDIT

Certain Plan investments maintain revenue sharing arrangements with the Custodian. Under these arrangements, revenue generated from the Plan in excess of TIAA's revenue requirement are held in a Revenue Credit Account ("RCA"). The RCA is used to offset permitted Plan administrative expenses, including those incurred for audits, investment performance monitoring, third party compliance consulting, and other administrative costs.

The Plan may also direct the Custodian to return any unused revenue credit balances to participants. During the year ended December 31, 2024, the Custodian transferred \$59,878 in revenue credits to the RCA and paid \$51,486 in Plan administrative expenses. As of December 31, 2024 and 2023, there was \$140,956 and \$126,604, respectively, in the RCA.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. PLAN TERMINATION

The Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA.

10. TAX STATUS

The Employer adopted a volume submitter 403(b) plan document which is the subject of a favorable tax opinion letter from the IRS dated August 7, 2017. The Employer routinely self-reviews the administration of the Plan and self-corrects any compliance issues in accordance with the Employee Plans Compliance Resolution System. The plan administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC and, accordingly, believes that the Plan is exempt from income taxes.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Employer has taken a significant uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

11. RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

Certain Plan investments are managed by the Custodian. Transactions with the Custodian qualify as party in interest transactions for which exemptions exist. The Custodian received \$53,231 for administration fees paid by the participants through the Plan as well as indirect compensation from certain mutual funds. The Plan also paid an independent public accountant \$22,708 for audit fees which was paid from the RCA. In addition, the Plan utilizes an investment advisor that received \$28,778 which was paid from the RCA.
