## INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees of  
Staff Education Association Retirees' VEBA Trust

### Opinion

We have audited the accompanying financial statements of Staff Education Association Retirees' VEBA Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.


### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). 

NOTES TO FINANCIAL STATEMENTS

YEARS ENDED DECEMBER 31, 2024 AND 2023

**NOTE 1. DESCRIPTION OF THE PLAN**

The following brief description of the Staff Education Association Retirees' Voluntary Employee Beneficiary Association (VEBA) Trust (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

**General** - The Plan was established pursuant to the February 2, 2010 Settlement Agreement between the Ohio Education Association (OEA) and the Settlement Class. The Plan was funded by a number of payments made by OEA. The final payment was made by OEA in January 2015. The Plan is administered and operated by the Board of Trustees (Trustees). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Benefits** - The Trust provides retiree only supplemental Medicare health benefits and prescription drug benefits through insurance companies. There are no active (working) participants in this plan.

The Plan provides a fully insured Prescription Drug benefit program and a fully insured Medicare Supplemental medical benefit plan for Medicare eligible participants who have elected to enroll.

Fully insured premium rates are proposed each year by the respective insurance carriers, prior to the coverage year. Once the fully insured premium rates are accepted by the Trustees, the rates are set. There are no other obligations or settlements required from the Plan for excessive/negative claims experience. The Plan also is not entitled to any rebate of premiums for favorable claims experience with either insurance carrier. The fully insured premiums rates are not subject to change during the coverage year even with fluctuations in enrollment.

**Contributions** - To receive benefits, each participant must make a self-contribution payment each month. This is a nominal amount to cover certain base expenses of the Plan.

**Eligibility** - The Plan provides benefits to retired eligible individuals as defined as Class Members in the February 2, 2010 Settlement Agreement and others who participate pursuant to the Trust Agreement and Plan Document.



## NOTE 1. DESCRIPTION OF THE PLAN (CONTINUED)

The Plan is a “closed group” VEBA. Only those Class Members identified in the February 2, 2010 Settlement Agreement along with certain other associated members, as approved by the Trustees, are eligible to participate in the Plan.

There are no active (working) participants enrolled in the Trust. Class Members must be Medicare eligible and retired to enroll in the trust's benefit plans.

## NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Method of Accounting** - The financial statements have been prepared using the accrual method of accounting. Under this basis, revenue is recognized when earned and expenses are recognized when incurred.

**Investment Valuation and Income Recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustees determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recognized on a trade-date basis. Interest income is recognized on the accrual basis. Dividends are recognized on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Administrative Expenses** - Administrative expenses are paid by the Plan.

**Concentration of Credit Risk** - Financial instruments that potentially subject the Plan to concentrations of credit risk consist primarily of cash. The Plan currently keeps its cash accounts with one financial institution. The balances are insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000 in a single financial institution. As of December 31, 2024, the Plan had \$335,313 of cash balances in excess of federally insured limits.

**Use of Estimates** - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Payment of Benefits** - Benefits are recorded when paid.

The Plan provides retiree only supplemental Medicare health benefits and prescription drug benefits through insurance companies. There are no active (working) participants in this plan. The Plan pays only fully insured premiums to insurance companies. The Plan has no continuing obligations or settlements requirements that could result from excessive or negative claims experience.



## NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

**Postretirement Benefit Obligations** - The provisions of the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 965 do not apply to this VEBA Trust.

**Reclassifications** - Certain items have been reclassified from prior year's financial statements for comparability purposes.

## NOTE 3. PLAN TERMINATION

Although it has not expressed any intent to do so, the Trustees have the right to discontinue the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination, the Trustees will allocate any remaining assets according to the Plan document.

## NOTE 4. FAIR VALUE MEASUREMENTS

Accounting standards provide the framework for measuring fair value which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include other significant observable inputs including:
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability; and
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.



## NOTE 4. FAIR VALUE MEASUREMENTS (CONTINUED)

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Short-term investments:* Valued at amortized cost, which approximates fair value.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. The mutual funds are valued at the NAV of the shares held by the trust at year end.

## NOTE 5. INCOME TAX STATUS

The Internal Revenue Service has determined and informed the Plan by a letter dated December 14, 2011, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the U.S. federal jurisdiction and the various states and local jurisdictions in which the Plan files returns. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.



## NOTE 6. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

## NOTE 7. PLAN AMENDMENTS

There were no plan amendments for the year ended December 31, 2023.

## NOTE 8. PARTY-IN-INTEREST TRANSACTIONS

As disclosed in Note 2, the Plan pays certain administrative, and professional fees to various service providers. These transactions are party-in-interest transactions exempt under ERISA.

## NOTE 9. RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500
