Opinion

NOTES TO FINANCIAL STATEMENTS

(1) Description of plan

The following description of the USSC Acquisition Corp. Group Medical Plan (the “Plan”) provides only general information. Participants should refer to the Plan document or Summary Plan Description for a more complete description of the Plan’s provisions, which are available from the plan administrator.

General - USSC Acquisition Corp. (the “Company”) established the Plan and related trust effective June 1, 2017. The Plan provides medical benefits for the benefit of the Company’s full-time employees and their spouses or domestic partners and eligible dependents of these employees. The payment of all medical benefits will be made by the USSC Acquisition Corp. Health Benefit Trust (the “Trust”), which is funded by the Company and is an exempt organization under Section 501(c)(9) of the Internal Revenue Code. The Plan is subject to the provisions of the Employee Retirement Security Act of 1974 (“ERISA”), as amended.

Under the Plan, all regular full-time employees of the Company working at least thirty hours per week are eligible to participate, along with others who meet the eligibility requirements as defined in the Plan document.

Benefits - The Plan provides health benefits (medical and prescription drugs) primarily through a Preferred Provider Organization (“PPO”). The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (“COBRA”).

The Plan pays participant medical claims up to a certain amount per individual and charges the Company for these amounts on a dollar-for-dollar basis. Any medical claims in excess of this amount are covered by the Company’s stop-loss coverage policy. The funds needed to pay medical claims are administered by the Trust, whereby the Company transfers the related accrued benefit costs to the Trust on a monthly basis. The majority of the costs of participant medical claims are paid directly by the Trust. Premiums for the stop-loss coverage and administrative fees are paid by the Plan and charged to the Company on a dollar-for-dollar basis.

Stop-loss coverage - The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims). The specified stop-loss amount per person based on the insurance contract was \$100,000 for the year ended December 31, 2024. The aggregate stop-loss amount based on the insurance contract was \$1,000,000 in the aggregate for the year ended December 31, 2024.

Self-insured benefits - Medical and prescription drug benefits are self-insured. The claims for self-insured benefits are processed by the Plan’s third-party claims administrator under administrative services only (“ASO”) arrangements. The claims processor pays claims directly to or for participants and is then reimbursed by the Trust. Despite the Plan’s utilization of the third-party claims’ administrator, ultimate responsibility for payments to providers and participants is retained by the Plan.

The Plan utilizes a pharmacy benefit manager (“PBM”) to help control drug costs. The PBM pays refunds to the Plan based on the Plan’s actual utilization pattern of specific drugs. There is an inherent lag between the periodic capture and calculation of refunds due to the Plan and the receipt of such refunds.

NOTES TO FINANCIAL STATEMENTS

(1) **Description of plan (continued)**

Contributions - Contributions are made by the Company on behalf of Plan participants on a monthly basis. If at any point during the year contributions are insufficient to pay claims, the Company is required to make an additional contribution to fund claims as deemed necessary by the claims administrator. The contributions of the Company are determined by the claims administrator in order to provide the Plan with assets sufficient to meet benefit obligations.

Plan termination - Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to, and contributions required of, participants to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of termination of the Plan, the remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

(2) **Summary of significant accounting policies**

Basis of accounting - The financial statements of the Plan are prepared under the accrual method of accounting.

Use of estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Income recognition - Interest income is recorded when earned.

Stop-loss - Premiums for stop-loss insurance are included in claim payments in the accompanying statement of changes in net assets available for benefits. Stop-loss refunds have been netted with claim payments in the accompanying statement of changes in net assets available for benefits.

Payment of claims - Claims are recorded when paid or invoiced to the Plan.

Administrative expenses - The Plan pays certain administrative expenses that consist primarily of administrative fees paid to the third-party claims administrator, the trustee, and the actuary. These expenses are reported on the statement of changes in net assets available for benefits as administrative expenses. All other administrative expenses, such as professional fees, are paid by the Company on behalf of the Plan.

(3) **Accumulated plan benefits**

Plan obligations as of December 31, 2024 and 2023, for claims incurred but not reported are estimated by the Company based on claims data provided by the Plan's third-party claims processor. These amounts are paid by the Plan only if claims are submitted and approved for payment.

The total of claims incurred but not reported as of December 31, 2024 and 2023, were \$249,480 and \$222,225, respectively. The change in claims incurred but not reported for the year ended December 31, 2024, is as follows:

(4) **Related-party transactions and party-in-interest transactions**

As described in Notes 1 and 2, the Plan has several arrangements with service providers. These transactions are party-in-interest transactions that are exempt under the prohibited transaction rules under ERISA.

(5) **Tax status**

The Plan has not obtained a tax determination letter from the Internal Revenue Service ("IRS"); however, the plan administrator believes that the Plan and related Trust are being operated in compliance with the applicable requirements of the Internal Revenue Code, and the Plan is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(6) **Subsequent events**

The Plan has evaluated subsequent events through September 16, 2025, which is the date the financial statements were available to be issued.

Effective January 1, 2025, the Company amended the Plan document to eliminate the Trust. The Plan will no longer be required to submit Schedule H along with the Form 5500 or have the financial statements audited in future years.

On July 3, 2025, the Plan made a surplus distribution to the plan sponsor of \$889,157. The distribution was based on collective overpayments made by the plan sponsor and represented a full distribution of the Trust's remaining assets. The plan sponsor will thereafter be making all payments of plan expenses from its general assets.
