## INDEPENDENT AUDITOR'S REPORT

To the Investment Committee of  
Second Harvest of Silicon Valley 403(b) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the accompanying financial statements of Second Harvest of Silicon Valley 403(b) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of February 28, 2025 and February 29, 2024, and the related statement of changes in net assets available for benefits for the year ended February 28, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Second Harvest of Silicon Valley 403(b) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of February 28, 2025 and February 29, 2024, and for the year ended February 28, 2025, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Second Harvest of Silicon Valley 403(b) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audits does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Second Harvest of Silicon Valley 403(b) Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audits of the Financial Statements**

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

#### **Other Matter - Supplemental Schedule Required by ERISA**

1. DESCRIPTION OF THE PLAN

The following description of Second Harvest of Silicon Valley 403(b) Plan (the "Plan") provides only general information. Participants should refer to the plan documents for a more complete description of the Plan's provisions.

General

The Plan, a defined contribution savings plan sponsored by Second Harvest of Silicon Valley (the "Organization" or "Employer"), is designed to qualify under the applicable provisions of the Internal Revenue Code (IRC). The Plan was established on March 1, 1987, restated as of May 15, 2020, and most recently amended on August 19, 2020. The Plan is designed to provide eligible participants with a means to defer a portion of their compensation for retirement and to provide benefits in the event of death, termination, disability, or financial hardship. The Plan is subject to the provisions of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974, as amended ("ERISA") and subsequent laws and the IRC.

An expansion of Setting Every Community Up for Retirement Enhancement Act of 2019 ("SECURE 2.0") was signed into law on December 29, 2022, as part of the Consolidated Appropriations Act of 2023. The effective dates of provisions within SECURE 2.0 vary through 2026. The Organization has until the end of the first Plan year beginning on or after January 1, 2026, to amend the Plan for the changes related to SECURE 2.0. The Plan has not been formally amended to adopt these provisions as of the date the financial statements were available to be issued.

Plan administration

The Organization has designated the Second Harvest of Silicon Valley 403(b) Plan Investment Committee (the "Committee") as the administrator of the Plan and, as such, the Committee performs the duties imposed by ERISA. The Organization has contracted with Ascensus Trust Company ("Ascensus"), Newport Trust Company, LLC ("Newport"), and The Variable Annuity Life Insurance Company ("VALIC") (collectively, the "Custodians") to provide custodial services and affiliates of the Custodians to provide record-keeping and administrative services to the Plan.

Participant eligibility

All employees of the Organization are eligible to immediately participate in the Plan. To be eligible to receive discretionary Employer non-elective contributions, participants must complete one year of service, equal to 1,000 hours. Additionally, employees who normally work less than 20 hours per week are excluded from being eligible to receive discretionary Employer non-elective contributions.

Participant contributions

Participants are allowed to contribute their eligible pre-tax or after-tax (as Roth contributions) compensation, as defined in the plan documents, up to the annual contribution limit as defined in the IRC. Participants are also allowed to make pre-tax and after-tax (as Roth) rollover contributions to the Plan from other qualified retirement plans.

Plan participants who have attained the age of 50 before the end of a calendar year are allowed to make additional contributions called "catch-up contributions" to the Plan, up to the annual contribution limit as defined in the IRC. The Plan also allows participants with more than 15 years of credited service, as defined in the plan documents, to make additional catch-up contributions to the Plan.

Employer contributions

The Organization is allowed to make discretionary Employer non-elective contributions to the Plan. During the year ended February 28, 2025, the Organization made discretionary Employer non-elective contributions equal to 5% of eligible compensation, as defined in the plan documents, each pay period. The Organization paid \$1,319,042 in discretionary Employer non-elective contributions for the year ended February 28, 2025.

Participant accounts

Each participant's account is credited with the participant's contributions, allocations of the discretionary Employer non-elective contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan and Plan losses. Allocations are based on participant earnings or account balances, as defined in the plan documents. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Participants direct the investment of contributions to their respective accounts into the investment options offered by the Plan.

Investment options

In February 2016, the Plan changed asset custodians from VALIC to Teachers Insurance and Annuity Association of America ("TIAA") and College Retirement Equities Fund ("CREF"), and as of the date of change, all subsequent contributions were made to investment options held by TIAA and CREF.

Participants who approved the transfer of funds to TIAA and CREF from VALIC had their account balances transferred and reinvested into new investment options held by TIAA and CREF. Participants who did not approve the transfer continue to have their respective account balances maintained in investments offered by VALIC.

Investment options (continued)

Effective May 15, 2020, the Plan changed custodians to Ascensus, and as of the date of the change, all subsequent contributions are made to investment options held by Ascensus and all participant balances held by TIAA and CREF were transferred to Ascensus.

Participants may change the investment allocation of their contributions at any time and may transfer all or a portion of the value of their accounts among the funds. The Custodians maintain the number of shares and value of each fund on a daily basis in each participant's account.

Notes receivable from participants

Participants are allowed to borrow from their accounts not less than \$1,000 and up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Notes receivable from participants ("participant loans") must be repaid within five years, unless the loan is to be used for the acquisition of a principal residence, in which case the repayment period may be more than five years. Participant loans are secured by the vested balance in the participant's account and bear interest at the prime rate plus 1.00%. Principal and interest are generally paid ratably through payroll deductions with payments made each pay period. Outstanding participant loans at February 28, 2025, bear interest at annual rates of between 4.25% to 9.50%, and have maturity dates through November 2045.

Participant loans are not permitted to be issued from VALIC-managed assets. VALIC issued policy loans to participants in accordance with the terms of the annuity product contract. The loans are issued directly from VALIC, and are secured by a portion of the participants account and unpaid balances are not available for use by the participant. Collateral held in participant accounts is invested in fixed options within the contract, in accordance with the terms of the contract. Policy loans held by VALIC as of February 28, 2025 and February 29, 2024, were \$17,430 and \$23,072, respectively. Defaulted loans held by VALIC as of February 28, 2025 and February 29, 2024, were \$49,248 and \$47,049.

Vesting and forfeitures

Participants are immediately 100% vested in all contributions, plus actual earnings thereon.

Forfeitures may occur as a result of excess Employer contributions. Forfeitures may be used to reduce either the Organization's discretionary non-elective contributions, subject to applicable contribution limitations under the IRC, or to pay Plan expenses in the year the amounts are forfeited. As of February 29, 2025 and February 28, 2024, the total balance of unallocated forfeitures were \$847 and \$730, respectively. During the year ended February 29, 2025, no forfeitures were utilized to offset Plan expenses or Employer contributions.

Payment of benefits

Distributions and withdrawals are payable upon retirement, termination of employment, financial hardship, disability, or death. Upon termination of employment, if a participant's vested account balance is equal to or less than \$1,000, the balance is immediately distributed as a lump-sum payment. Upon termination, if a participant's vested account balance is greater than \$1,000 and less than or equal to \$5,000, their balance shall be automatically rolled over into an individual retirement account designated by the Plan administrator, unless otherwise elected. Upon termination of employment, if a participant's vested account balance is greater than \$5,000, the participant (or beneficiary) may elect to receive a distribution of their account balance as a lump-sum payment, installment payments, an annuity, or postpone payment to a later date and remain in the Plan.

Participants with an immediate and heavy financial need may be eligible for a hardship withdrawal, subject to certain restrictions as described in the plan documents.

Administrative expenses

Fees and expenses charged under participant accounts impact retirement savings and fall into three basic categories. Investment fees are generally assessed as a percentage of assets invested and are deducted directly from investment fund balances. They can be in the form of sales charges, loads, commissions, or management fees. Plan administration and record-keeping fees cover the routine expenses for the services of lawyers, accountants, third party administrators, and other advisors. The Plan requires that certain expenses related to the Plan be paid directly by the Organization, but permits certain expenses incurred to administer the Plan to be paid from Plan assets. Currently, the Plan directly pays a portion of the expenses incurred to operate and administer the Plan. Transaction-based fees are associated with optional services offered under the Plan and are charged directly to participant accounts for particular Plan features that may be available, such as participant loans or the maintenance of a terminated participant's account.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting and financial statement presentation

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and the change therein, and disclosure of contingent liabilities. Actual results could differ from those estimates.

Risk and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and changes therein.

Investment valuation and income recognition

The Plan's investment in variable annuity contracts, mutual funds and money market funds are reported at fair value. The Plan's investment in fully benefit-responsive investment contracts are reported at contract value.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an ordinary transaction between market participants at the measurement date. See Note 4.

Contract value is the relevant measurement for assets invested in fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 5.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Contributions and receivables

Contributions from participants are recorded based on the date the contributions have been separated from a participant's pay by the Organization, which is the pay date. The Organization's discretionary non-elective contributions are recorded in the year they are earned and to coincide with the year in which the Organization records the contributions in its general ledger. The Plan records receivables for the Organization's discretionary non-elective contributions and contributions from participants based upon the contributions recognized, less amounts received by the Plan as of the last day of the Plan year.

Rollover contributions are recorded based on the date the Custodians receive the rollover contributions.

Notes receivable from participants

Participant loans are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on participant loans is recorded on an accrual basis.

Payment of benefits

Benefits are recorded when paid.

Administrative expenses

Administrative expenses are recorded when incurred.

Subsequent events

The Plan administrator has evaluated subsequent events through September 26, 2025, the date the financial statements were available to be issued. Effective March 1, 2025, the Plan was restated to remove the one year service requirement for participants to be eligible to receive discretionary Employer non-elective contributions. No other subsequent events have occurred that would have a material impact on the presentation of the Plan's financial statements.

3. INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIANS (UNAUDITED)

The Plan administrator, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditor not to perform any auditing procedures with respect to the Plan's investment information, and related activity, certified by the Custodians, determined to be qualified institutions by the plan administrator, as complete and accurate, except for comparing such information to corresponding information included in the Plan's financial statements and supplemental schedule. The Custodians have certified to the completeness and accuracy of:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of February 28, 2025 and February 29, 2024;
- Net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the year ended February 28, 2025;
- Investments and notes receivable from participants reflected on the schedule of assets (held at end of year) as of February 28, 2025.

4. FAIR VALUE MEASUREMENTS

Accounting standards define fair value as the price that would be received from selling an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Such standards establish a framework for measuring fair value and provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

- Level 1 - inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities the Plan has the ability to access.
- Level 2 - inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 - inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis. There have been no changes in the methodologies used at February 28, 2025 and February 29, 2024.

Variable annuity contracts: Investments made in the variable annuity contracts are held within separate accounts. Units held in the separate accounts are accumulation units and calculate the contract owner's interest. Such units are valued daily to reflect investment performance and the prorated daily deduction for expense charges. The number of units credited to a participant's account is determined by dividing the dollar amount of the transaction by the unit value the next time value is computed. Units are valued any day the New York Stock Exchange is open for business and may be accessed by plan sponsors and participants via the VALIC website.

Mutual funds and money market fund: Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-end funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. INVESTMENT CONTRACTS

The Plan holds guaranteed investment contracts with VALIC in the amount of \$444,479 and \$421,766 as of February 28, 2025 and February 29, 2024, respectively. The guaranteed investment contracts include the Fixed Account Plus ("FA") and Short Term Fixed Account ("STFA") which had balances of \$434,557 and \$411,924, and \$9,922 and \$9,842 as of February 28, 2025 and February 29, 2024, respectively. VALIC maintains all contributions made to these contracts in its general account and FA and STFA contracts are considered to be fully benefit-responsive contracts.

5. INVESTMENT CONTRACTS (continued)

For investment contracts that are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for plan benefits attributable to the guaranteed investment contract. Contract value represents accumulated cash contributions made under the contracts, interest credited to the contracts, less participant withdrawals and transfers. Participants may ordinarily direct the withdrawal of all or a portion of their investment at contract value with no restrictions. Participants are allowed to transfer up to 20% of their investment in the FA contract to other investment options held by the Plan per year, and once a participant transfers monies into the STFA contract, no transfers will be allowed from the STFA contract for 90 days.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. VALIC is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The VALIC FA's crediting rate is set monthly for deposits received that month for the duration of that respective calendar year and, typically, the following calendar year, and beginning January 1st of the third calendar year, a new pooled rate is declared for that calendar year where none of the annual credited rates are allowed to be less than 3%. The VALIC STFA's crediting rate is established on a portfolio basis annually for all deposits received and may not in any case be less than 3%. Additional interest is not guaranteed for future years.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the Plan's trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with the issuer or with participants are probable of occurring.

The contracts above do not permit VALIC to terminate the agreement prior to the scheduled maturity dates.

6. TAX STATUS

The Plan has adopted the Ascensus ERISA 403(b) Volume Submitter Plan and obtained its latest opinion letter on January 1, 2018, in which the Internal Revenue Service stated that the volume submitter plan document is acceptable for use by employers for the benefit of their employees. Although the Plan has been amended since the receipt of the opinion letter, the Plan administrator believes the Plan is currently designed and has been operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. After deducting all charges and expenses, the balances of all individual accounts will be adjusted and the remaining assets distributed.

8. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

ERISA defines parties-in-interest similarly to a related party as defined by financial accounting standards, except that ERISA's definition is broader and includes all entities and individuals that provide services to the Plan; however, these entities may not necessarily be related parties. Plan management did not identify any related parties to the Plan that were not also considered to be parties-in-interest.

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, and an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association or relatives of such persons.

The Plan has a revenue sharing agreement with Ascensus which allows Ascensus to be compensated by sharing, on a periodic basis, in the revenue derived from certain non-proprietary mutual funds offered as investment options to participants in the Plan.

The Custodians retain as compensation for services provided to the Plan, any interest on amounts earned while certain transactions are pending. This applies to both contributions and distributions. Earnings are at institutional money market rates.
