We have performed audits of the financial statements of Zuckerman Gravely Management, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1 - Description of the Plan

The following description of the Zuckerman Gravely Management, Inc. 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan, which is a single-employer plan, is a defined contribution plan covering all full-time employees of Zuckerman Gravely Management, Inc., and its affiliates (collectively, the "Company" or "Plan Sponsor"), who are not independent contractors or covered by another collective bargaining agreement. The Plan became effective on January 1, 1989 and was restated on January 1, 2013. The Plan is intended to qualify under Section 401(k) of the Internal Revenue Code ("IRC") and it is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). An employee is eligible to participate in the Plan on the first entry date coinciding with or following 30 consecutive days of being employed and having attained the age of 21. Entry dates are defined as the first day of each month. The Plan is administered by the Plan Sponsor. The Plan's assets are held in custody by Voya Retirement Insurance and Annuity Company (the "Trustee").

Contributions

Each year, eligible participants may contribute up to 50% of pretax annual compensation subject to an annual Internal Revenue Service ("IRS") limitation, as defined in the Plan Document. Participants may contribute up to 100% of pretax bonuses received and catch up contributions, as long as the limit stated above is not surpassed. The participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Based on the participant's elections, contributions and income are invested in the Voya Retirement Insurance and Annuity Company Separate Account D ("Separate Account D") and are allocated funds that correspond to the name of an underlying mutual fund. The Plan Sponsor may make an employer matching contribution of 100% of participant contributions up to a maximum of 4% of an employee's eligible compensation, as defined in the Plan Document. Each year, the Plan Sponsor may also make a discretionary profit-sharing contribution that is allocated based on eligible wages. Eligible participants who are employed on the last day of the Plan year, as defined, and are credited with 1,000 hours of service, as defined, are to receive the employer matching contribution and profit-sharing contribution. The Plan Sponsor made matching contributions of \$227,243 for the year ended December 31, 2024, which remain receivable as of December 31, 2024.

Participants direct the investment of their contributions and Plan Sponsor contributions into various investment options offered by the Plan. Contributions are subject to certain limitations.

Participant accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit-sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the employer matching contributions and employer profit-sharing contributions plus actual earnings thereon is based on years of service as follows:

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years or up to 10 years for the purchase of a primary residence. The participant notes receivable are secured by the balance in the participant's account and bear interest at a rate equal to 1% above the prime rate. Principal and interest is paid ratably through periodic payroll deductions. Effective for 2024, participants are limited to a maximum of four loans at one time.

Payment of benefits

Upon termination of service, death, retirement or disability, certain hardship situations and other reasons in accordance with the Plan Document, a participant or designated beneficiary may elect to receive either a lump-sum amount equal to the value of the participant's account, or installments over a period of not more than his or her assumed life expectancy. Participants may also roll over the value of their account into another qualified Plan. Participants are also eligible to receive hardship withdrawals if they meet the requirements provided by the Plan.

Forfeitures

Forfeited balances of terminated participants' nonvested accounts are used to pay certain administrative expenses of the Plan. Forfeited balances that remained unallocated as of December 31, 2024 and 2023 were \$17,533 and \$12,881, respectively.

Note 2 - Summary of significant accounting policies

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Accordingly, actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisers, Trustees and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's realized and unrealized gains and losses on investments bought and sold as well as held during the year. Interest income is earned on an accrual basis.

Contributions

Participant contributions are recorded in the period in which the payroll deductions are made. Employer contributions, if applicable, are accrued based on the terms of the Plan and are recognized when due and funded. Contributions are allocated to participant accounts based on the provisions of the Plan document. All contributions are invested in accordance with participant elections or default investment options as outlined in the Plan.

Participant notes receivable

Participant notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest on participant notes receivable is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of benefits

Benefit payments to participants are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent events

Material subsequent events have been considered for disclosure and recognition in these financial statements through September 29, 2025, the date the financial statements were available to be issued.

Note 3 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") issued Accounting standards Codification ("ASC") 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Group Annuity Contract: The Plan invests in the Voya Retirement Insurance and Annuity Company Separate Account D through a group annuity contract which is valued based on the quoted market prices of the underlying mutual funds on the last business day of the Plan year as determined by Voya. Redemptions may occur on a daily basis.

For the years ended December 31, 2024 and 2023, there were no significant transfers between Levels 1 and 2 and no transfers in or out of Level 3.

Note 4 - Plan termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participating employees will become 100% vested in their accounts. The Plan Administrator will facilitate the distribution of account balances in single lump sum payments to each participant in accordance with Plan document until all assets have been distributed.

Note 5 - Income tax status

The Plan Sponsor adopted a prototype plan document which received a favorable opinion letter dated March 31, 2014, in which the IRS stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has not yet filed for an individual determination letter. Although the Plan has been amended since receiving the opinion letter on the prototype plan, the Plan Administrator and the Plan's third-party administrator believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

During 2024, the Plan failed the actual deferral percentage test. As of the date of this report, Plan management is working on making the required corrective distribution of \$3,578.

Note 6 - Administration of Plan assets

Contributions are held and managed by the Trustee, which invests cash received, interest and dividend income as directed by participants. The Plan Administrator administers the payment of interest and principal on participant notes receivable, which are remitted to the Plan through the Plan Sponsor.

Certain administrative functions are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan. Administrative expenses and Trustee fees are paid by participants.

Note 7 - Risks and uncertainties

The Plan provides for various investment securities. Investment securities are exposed to various risks such as interest, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported on the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Note 8 - Related party transactions and party-in-interest transactions

Certain investments of the group annuity contract are shares of mutual funds managed by Voya Retirement Insurance and Annuity Company. Voya Retirement Insurance and Annuity Company is the Trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. The Plan made a direct payments to the third-party administrator for administrator fees of \$4,020 during 2024. The Plan Sponsor pays directly any other fees related to the Plan's operations.

Note 9 - Certified investments

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments held at December 31, 2024 and 2023, and investment income (loss) for the year ended December 31, 2024, that is disclosed in the accompanying financial statements and supplemental schedule of assets held at end of year, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Voya Retirement Insurance and Annuity Company, the Trustee of the Plan.

Note 10 - Nonexempt transactions

As reported on the supplemental Schedule of Delinquent Participant Contributions (Schedule H, Line 4a), \$19,562 of 2024 Plan contributions were not remitted to the trust within the time frame specified by the DOL's Regulation 29 (CFR 2510.3-102), thus constituting nonexempt transactions between the Plan and the Company for the year ended December 31, 2024. Plan management expects to restore lost earnings related to the 2024 late contributions during 2025.
