#### NOTE A - DESCRIPTION OF THE PLAN

The following description of the National Student Clearinghouse (the "Company") 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the provisions of the Plan.

##### **General**

The Plan was originated July 1, 2003 and is sponsored by the Company. It is a defined contribution plan covering all employees of the Company except part-time, temporary, seasonal employees who work less than 1,000 hours, and contingent employees. The Board of Trustees is responsible for oversight of the Plan. The Retirement Plan Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Trustees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 as amended ("ERISA").

##### **Contributions**

Contributions to provide benefits under the Plan are made by the Company and the participants of the Plan. Participants may contribute up to 100% of their eligible compensation to the Plan in any one year, subject to Internal Revenue Code ("IRC") limits. Participants will become eligible to participate in the Plan upon reaching age 21 and completing at least 1,000 hours of service within the 12-month period beginning on their date of hire. The eligibility requirement applies to all types of contributions. Further, participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Employer may make a discretionary matching contribution. The Plan will include catch-up deferrals in the elective deferral amount used to determine the amount of the matching contributions. Employer matching contribution formula stipulates that the employer match is equal to 100% of each employee's total contribution to a maximum of 5% of each employees' eligible compensation.

The Company may also elect to make a discretionary nonelective profit-sharing contribution as determined annually by the Board of Directors. Effective on January 1, 2021, the Plan was amended such that the profit-sharing contribution will be allocated to each designated group in a manner determined by the Company. There was no discretionary profit-sharing contribution made in 2024.

##### **Participant Accounts**

Individual accounts are maintained for each participant. Each participant's account is credited with the participant's contribution and the Company's matching contribution at the end of each bi-weekly pay period. An allocation of the Company's discretionary contributions may be made at the employer's discretion annually and is allocated pro rata as a percentage of eligible participant compensation. Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit-sharing contribution and Plan earnings.

Participants direct the investment of their contributions plus actual earnings thereon into various investment options offered by the Plan. Participants may change their investment options daily.

The benefit to which the participant is entitled is the benefit that can be provided from the participant's vested account.

***Notes Receivable from Participants***

Participants are allowed to borrow against their vested account balances per the Plan's provisions. The minimum loan amount is \$1,000, and the maximum is one-half of the participant's vested account balance, not to exceed \$50,000. A maximum of two outstanding loans is allowed per participant. The loans are secured by the balance in the participant's account. The interest rate on loans will be based upon the Prime Rate plus 1% as published in The Wall Street Journal on the first business day of each month. On December 31, 2024, the interest rate of all outstanding loans ranged from 4.25% to 9.50%. Plan loans have a term of five years except for residential home loans, which have a term of 20 years. Principal and interest payments are made through bi-weekly payroll deductions.

***Vesting***

Contributions made by participants are fully vested at all times. Employees become 25% vested in the Company's contributions after one year of credited service, 50% vested after two years of credited service, 75% vested after three years of credited service, and 100% after four years credited service.

***Benefits***

The Plan provides for benefit payments at retirement, death, disability, termination of employment, financial hardship, attainment at age 59½ years and attainment at age 73. Upon withdrawal, participants are entitled to their individual contributions and any vested amounts of the Company's contribution.

***Forfeitures***

Forfeitures are used to offset the employer's contribution and/or used to pay Plan expenses. During 2024, forfeitures used to offset employer matching contributions totaled \$1,918. Forfeited non-vested accounts totaled \$278,812 and \$80,081 as of December 31, 2024 and 2023, respectively.

***Plan Administration***

Empower Retirement serves as the Plan's recordkeeper.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Method of Accounting***

The financial statements have been prepared on an accrual basis in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") and in accordance with the terms of the Plan agreement.

***Using Estimates in Preparing Financial Statements***

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Contract value is the relevant measurement for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted

transactions under the terms of the Plan. The Plan invests in a separate guaranteed interest account (“GIA”), which is considered a fully benefit-responsive investment contract. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

***Tax Status***

The Plan uses a volume submitter profit sharing plan of Empower Retirement LLC. The Plan is relying on the Master Plan Sponsor’s opinion letter dated November 14, 2022 covering this Plan for purposes of qualification with the Internal Revenue Service (“IRS”). The Plan has been amended since receiving the opinion letter. The Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for tax periods in progress.

***Notes Receivable***

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Delinquent loans are reclassified as distributions based upon the terms of the Plan agreement.

***Benefit Payments***

Benefits are recorded when paid.

**NOTE C - INFORMATION CERTIFIED BY THE PLAN CUSTODIAN AND TRUSTEE**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company, LLC, the custodian and trustee, respectively, and Mass Mutual Life Insurance Company, an insurance entity, have certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments at fair value, investments at contract value and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

**NOTE D - FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements and Disclosures*, establishes a single authoritative definition of fair value, sets a framework for measuring fair value, and requires additional disclosures about fair value measurements.

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Investments are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

The following is a description of the valuation methodologies and inputs used for assets measured at fair value, as well as the general classification pursuant to the valuation hierarchy. There have been no changes in the methodologies used at December 31, 2024 and 2023.

***Mutual Funds***

Shares of mutual funds are valued based on quoted prices of the fund in active markets and classified within Level 1 of the fair value hierarchy.

***Pooled Separate Accounts***

The investments in the pooled separate accounts (“PSA”) represent ownership of units of participation in various mutual funds or collective trust funds, rather than ownership of specific assets. The value of a unit of participation is the total value of each mutual fund or collective trust fund within the PSAs divided by the number of units outstanding. The investments in the pooled separate accounts are stated at fair value based on each account’s daily net asset value (“NAV”), which is considered by Plan management to be the best approximation of fair value. Underlying holdings are primarily valued using market quotations or prices obtained from independent pricing sources. There are no unfunded commitments from participants in the Plan who invest in these accounts.

***Common/Collective Trust***

Common/collective trusts are valued using NAV as a practical expedient and are not categorized in the fair value hierarchy. NAV is provided by the fund's issuer and is based on the fair value of the underlying investments held by the fund less its liabilities.

**NOTE E - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS**

***Guaranteed Interest Account***

The Plan invests in a GIA managed by Mass Mutual Life Insurance Company, which provides a stated rate of return and insulates participants' accounts from daily fluctuations in the market. MassMutual maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charges for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate. The crediting rate is based on a formula established by the contract issuer but may not be less than 0%. The crediting rate is reviewed on a semi-annual basis for resetting.

The GIA is fully benefit-responsive because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may direct permitted withdrawal and/or transfer transactions of all or a portion of their balance at contract value.

Certain events may limit the ability of the GIA to transact at contract value with the issuer. Such events include: (1) material amendments to the GIA's structure or administration, (2) changes to the GIA's competing investment options, (3) complete or partial termination of the GIA, including a merger with another fund, (4) the failure of the GIA to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, (5) redemption of all or a portion of the interests in the GIA at the direction of the Trust due to bankruptcy, the merger of the Plan with another plan, the establishment of another tax qualified defined contribution plan, etc., (6) any change in law, regulation, ruling, administrative or judicial position, or accounting requirement, applicable to the GIA, and (7) any communication to Plan participants designed to influence a participant not to invest in the GIA. The occurrence of any such event that would limit the Plan's ability to transact at contract value with the participant is not considered by Plan management to be probable.

**NOTE F - PLAN TERMINATION**

Although the Company has not expressed any intent to do so, it has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**NOTE G - PARTY-IN-INTEREST TRANSACTIONS**

All transactions that are considered party-in-interest transactions relate to normal management and administrative services, and the payment of expenses related thereto. Plan investments are managed by the Plan's custodian and, as such, these transactions qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions and are denoted as such on the supplemental schedule of assets (held at end of year).

**NOTE H - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE I - SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through September 22, 2025, the date the financial statements were available to be issued. Plan management is not aware of any subsequent events which would require recognition or disclosure in the financial statements.
