## INDEPENDENT AUDITOR'S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Richardson Sports, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ## 1. Plan Description

The following brief description of Richardson Sports, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

### General

The Plan is a defined-contribution plan covering all eligible employees of Richardson Sports, Inc. (the Company). Employees are eligible to participate in the Plan upon the attainment of age 19 and at least 1,000 hours of service in a consecutive 12-month period. Eligible participants may enter the Plan on January 1 and July 1 of each Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's most recent restatement was effective January 1, 2022. The Board of Trustees oversees the governance of the Plan.

### Contributions

Participants may elect annually to contribute pre-tax or after-tax (Roth) contributions up to the maximum percentage allowable by law, limited to the amounts provided by the Internal Revenue Code (IRC). Individuals who attain age 50 by the end of the Plan year may make additional "catch-up" contributions. Participants may also contribute amounts representing distributions from other qualified plans. These contributions are fully vested at all times.

The Company makes a Safe Harbor matching contribution of 100 percent of deferrals up to 3 percent of eligible compensation, plus 50 percent of deferrals that exceed 3 percent of compensation but do not exceed 5 percent of compensation each payroll period. The Company may also make discretionary profit-sharing or matching contributions as elected by the Company allocated to participants based upon each participant's eligible compensation in proportion to the compensation of all participants or matching based on amounts contributed.

The Company made a Safe Harbor matching contribution of \$379,114 and \$381,310 for the years ended December 31, 2024 and 2023, respectively. The Company made no discretionary profit-sharing or discretionary matching contributions for the years ended December 31, 2024 and 2023.

### Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution, (b) the Plan's investment earnings or losses, and (c) certain Plan administration costs not covered by the Company. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the entire portion of their investment account.

**1. Plan Description, continued**

**Vesting**

Participants are immediately vested in their elective contributions and Safe Harbor match contributions plus actual earnings thereon. Vesting in the Company's discretionary contribution portion of their accounts is based on years of service. If termination is due to death, disability, or retirement at or beyond the normal retirement age, participant is considered to be 100 percent vested. Participants vest in the Company's discretionary contributions based on the following schedule:

**Payment of Benefits**

Upon retirement, disability, death, or termination of employment, a participant or their designated beneficiary may elect to receive the value of the participant's vested interest in their account in a lump-sum, installments, or roll it over to another qualified plan. The Plan does not allow hardship distributions.

**Forfeitures**

Forfeitures may arise from the nonvested portion of Company contributions in a participant's account. Once forfeited, they may be used to offset Company contributions or pay Plan expenses. There were no forfeitures during the years ended December 31, 2024 and 2023 which could be used to offset future Company contributions or pay Plan expenses.

**Participant Loans**

The Plan does not allow for participant loans.

**Plan Administration**

OneAmerica Financial Partners, Inc. (OneAmerica), a company related to American United Life Insurance Company, provided administration and recordkeeping services for the years ended December 31, 2024 and 2023.

**2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes, and changes therein. Actual results could differ from those estimates.

**Contributions**

Participant contributions and the employer match and profit-sharing contributions are recorded in the year in which the participant contributions are withheld from compensation.

**Investment Valuation and Income Recognition**

The Plan investments are reported at fair value, except for fully benefit-responsive insurance contracts as described in note 7, which are reported at contract value. Fair value is the price that would be received to sell an asset or transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income are recorded on the accrual basis. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Administrative Expenses**

Administrative expenses of the Plan are generally paid by the Plan. The Company may absorb certain costs of administering the Plan and these expenses are excluded from these financial statements. Custodial and other administrative fees are paid from participant accounts. Investment related expenses are included in net change in fair value of investments.

**Payment of Benefits**

Benefits are recorded when paid.

**Recent Accounting Standard Adopted**

On January 1, 2023, the Plan adopted Accounting Standards Update (ASU) 2016-13 Financial Instruments – Credit Losses (Topic 326): *Measurement of Credit Losses on Financial Instruments*, and all related amendments (ASC 326), which replaced the incurred loss methodology for recognizing credit losses with an expected loss methodology that is referred to as the current expected credit loss (CECL) methodology. CECL requires an estimate of lifetime expected credit losses to be recognized for financial assets based on historical experience, current conditions, and reasonable and supportable forecasts, and for the financial assets to be presented at the net amount expected to be collected on the statements of net assets available for benefits. The financial assets held by the Plan that are subject to ASC 326 are employee contributions receivable and employer contributions receivable. The Plan adopted ASC 326 effective January 1, 2023. There was no impact to the financial statements as a result of adopting this standard.

**3. Information Certified by the Custodian**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, American United Life Insurance Company, acting as the custodian for the Plan, has certified that the following information included in the accompanying financial statements and supplemental schedule is complete and accurate as of and for the years ended December 31:

**4. Tax Status**

The Plan is based on a Non-Standardized Pre-Approved Profit Sharing Plan with CODA. OneAmerica Financial Partners, Inc., the sponsor of the volume submitter plan, has received an opinion letter from the Internal Revenue Service (IRS) dated August 19, 2020, that the adoption agreement and basic Plan document satisfy Internal Revenue Code (IRC) Section 401.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by tax authorities.

**5. Party-in-Interest Transactions**

American United Life Insurance Company was the Plan investment custodian for the years ended December 31, 2024 and 2023; therefore, these investment transactions and related fees qualify as party-in-interest transactions. During the years ended December 31, 2024 and 2023, \$2,440 and \$840, respectively, of investment management fees were paid directly to American United Life Insurance Company from the Plan. These transactions were exempt from the prohibited transaction rules of ERISA.

**6. Fair Value Measurements**

Financial Accounting and Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to their fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

*Pooled separate accounts:* Recorded at fair value based on the stated net asset value (NAV) of the separate account, which is used as a practical expedient to estimate fair value. Participant transactions may occur daily at NAV. Pursuant to Accounting Standards Update (ASU) 2015-07, *Fair Value Measurements*, the pooled separate accounts measured at NAV have not been classified in the fair value hierarchy. All pooled separate account investments held by the Plan within a group annuity contract and have no unfunded commitments, and the investments may be redeemed by participants on a daily basis with no required notice period.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**7. Insurance Contracts**

The Plan's investments include a benefit-responsive insurance contract with American United Life Insurance Company (AUL). AUL maintains the contributions in a pooled account (Stable Value Account), which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. All assets in the Stable Value Account are credited with interest using a declared quarterly rate determined by AUL and stated in advance of the coming quarter. There is no specific portfolio of assets in which the stable value fund invests. The credited interest rate is backed by the income received from assets held in AUL's general account. The average interest rate being credited to assets in the Stable Value Account as of December 31, 2024 and 2023, was 1.5 percent and 0.75 percent, respectively. It is not considered a guaranteed interest contract nor a common/collective trust. Certain events, such as the premature termination of the contract by the Plan or the termination of the Plan, would limit the Plan's ability to transact at contract value with AUL. The Plan Administrator believes the occurrence of such events that would limit the Plan's ability to transact at contract value with the Plan participants is not probable.

**8. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of full or partial Plan termination, affected participants would become 100 percent vested in their Company employer discretionary contributions.

**9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**10. Subsequent Events**

Management evaluates events and transactions that occur after the statement of net assets available for benefits date as potential subsequent events. Management has performed this evaluation through the date of the independent auditor's report.
