## INDEPENDENT AUDITOR'S REPORT

### TO THE PARTICIPANTS AND ADMINISTRATOR OF MONROE PLAN FOR MEDICAL CARE, INC. 401(K) RETIREMENT PLAN

#### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of **Monroe Plan for Medical Care, Inc. 401(K) Retirement Plan**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

## Opinion

#### **NOTE 1 – GENERAL DESCRIPTION OF THE PLAN**

---

The following brief description of the Monroe Plan for Medical Care, Inc. 401(K) Retirement Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

##### **General**

The Plan is a defined contribution profit sharing plan covering all full-time employees of the Monroe Plan for Medical Care, Inc. Employees aged 18 or older are automatically enrolled to participate in the Plan on the first day of the month coinciding with or next following the date of employment. Employees aged 18 or older must have completed one year of service in which they are credited 1 hour of service to be eligible for the employer matching contributions. Employees must have completed one year of service in which they are credited 1,000 hours of service and are employed by the Plan Sponsor at the end of the Plan year to be eligible for the employer discretionary contribution. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

##### **Contributions**

Participants are automatically enrolled to contribute 3% of Plan compensation but may elect to contribute up to one hundred percent of their pre-tax annual compensation, subject to Internal Revenue Services (“IRS”) limitations. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Participants direct their investment of their contribution into various investment options offered by the Plan. The Company may contribute a discretionary matching contribution and a discretionary profit sharing contribution. For both the Plan years ended December 31, 2024 and 2023, the Company matched 100% of contributions up to 8% and 3% of participant’s Plan compensation, respectively.

##### **Participant Accounts**

Separate accounts are maintained for each participant. The trustee invests the contribution amounts, as instructed by the participants, in one or more of the separate investment funds offered under the Plan. Each participant’s account is credited with (a) the amount of the participant’s elected contributions; (b) the amount of the participant’s Company matching and discretionary contributions, if any; (c) the amount of any attributable investment earnings and market appreciation or depreciation; and (d) charged with direct administrative expenses when applicable. The benefit to which a participant is entitled is the final market value of the participant’s account.

**Payment of Benefits**

Upon retirement, disability or death, the participant is eligible to receive their vested benefits in accordance with the provisions of the Plan. The amount of the participant's retirement account may be distributed to the participant or the designated beneficiary in a lump sum distribution, installment payments or partial payments, as defined in the Plan. Upon separation from service before retirement, disability or death, the participant is eligible to request early payment of vested benefits or defer receipt of a distribution in accordance with plan provisions.

##### **Forfeited Accounts**

At December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$20,000 and \$23,000, respectively. Forfeitures arising under the Plan can be used to pay plan expenses or employer matching contributions. During the years ended December 31, 2024 and 2023, forfeitures of approximately \$67,000 and \$12,000 were used to reduce the employer matching contributions, respectively.

##### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at 4.25% - 9.50%, which is commensurate with local prevailing rates as determined by the Plan Administrator. Principal plus interest is paid ratably through payroll deductions.

#### NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES

---

The accounting principles and practices which affect the more significant elements of the financial statements are:

##### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### **Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value (except for the fully benefit-responsive investment contract with an insurance company, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurement.

Purchases and sales of investments are recorded on trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net investment gain (loss) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### Notes Receivable

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

##### Payment of Benefits

Benefits are recorded when paid.

##### Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation gain of investments.

##### Risks and Uncertainties

The Plan provides for various investment options in any combination of a variety of mutual funds and investment contracts. Investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

##### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure on contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

##### Subsequent Events

The Plan has evaluated subsequent events from December 31, 2024 through September 29, 2025, which is the date the financial statements were available to be issued. Management has determined no such events have occurred.

#### NOTE 3 – FAIR VALUE

---

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification (“FASB ASC”) No. 820 are described as follows:

Level 1        Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities that the Plan can access at the measurement date.

Level 2        Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3        Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the net asset value (“NAV”) of shares held by the plan at year end. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### NOTE 4 – GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY

---

The Plan entered a traditional fully benefit-responsive guaranteed investment contract with Massachusetts Mutual Life Insurance Company (“Mass”). Mass maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

---

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by Mass, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023 was approximately \$944,000 and \$5,291,000, respectively. The crediting interest rate is based on a formula agreed upon with the issuer.

Certain events limit the Plan's ability to transact at contract value with Mass. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe any events that would limit the Plan's ability to transact at contract value with the Plan participants or the issuer are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the maturity date.

#### **NOTE 5 – INCOME TAX STATUS**

---

The Plan has adopted the EPIC Advisors Inc. Non-Standardized Profit Sharing / 401(k) Plan With CODA. The Plan obtained its latest determination letter on June 30, 2020, in which the IRS ruled that the plan of EPIC Advisors Inc. is acceptable under Section 401(a) of the Internal Revenue Code (“IRC”) and, therefore, is not subject to federal income tax under present law. Although the plan has been amended and restated since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. As the Plan is tax-exempt, the Plan administrator has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

#### **NOTE 6 – FINANCIAL INFORMATION CERTIFIED BY PLAN TRUSTEE**

---

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator has obtained a certification from Empower Annuity Insurance Company of America, the trustee of the Plan, that all of the information provided by them is complete and accurate. Information included in the accompanying financial statements and supplemental schedule as of and for the years ended December 31, 2024 and 2023 pertaining to investments, notes receivable from participants, dividend and interest income, and net investment gain (loss) is presented in reliance solely upon those certifications.

#### **NOTE 7 – RELATED-PARTY TRANSACTIONS AND PARTIES IN INTEREST TRANSACTIONS**

---

Empower Annuity Insurance Company of America is the trustee of participant directed plan assets of the Plan for both the years ended December 31, 2024 and 2023, as defined by the Plan and, therefore recordkeeping, loan, and benefit payment processing transactions qualify as party-in-interest transactions. Fees incurred and paid directly by the plan participants to Empower Annuity Insurance Company of America were approximately \$6,700 and \$4,300 for the years ended December 31, 2024 and 2023, respectively.

#### **NOTE 8 – PLAN TERMINATION**

---

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

#### **NOTE 9 – DELINQUENT PARTICIPANT CONTRIBUTIONS**

---

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets. While the Company has remitted all employee contributions to the Plan, contributions totaling approximately \$58,900 were not remitted within the required time period for the year ended December 31, 2024. The Company remitted lost earnings related to these delinquent contributions by the Plan year ended December 31, 2025.
