Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Honolulu Museum of Art 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Notes to Financial Statements
December 31, 2024 and 2023

1. Description of Plan

The following description of the Honolulu Museum of Art 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

a. General

The Plan is a defined contribution plan created and sponsored by the Honolulu Museum of Art (the Museum) to provide retirement benefits to eligible employees of the Museum. The Plan was established on November 1, 2013 and is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Ascensus Trust Company (the Custodian) is the custodian of the Plan's assets.

b. Eligibility

Employees who are at least 21 years of age become eligible for participation in the Plan on the first day of the quarter following the completion of one year of employment during which at least 1,000 hours of service were performed. Employees who meet these eligibility requirements are also eligible for discretionary matching contributions.

c. Contributions

Each year, participants may contribute up to the Internal Revenue Service (IRS) limit of included compensation on a pre-tax or Roth basis as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans. Participants direct the investment of their contributions into the investment options offered by the Plan.

The Museum may make discretionary matching contributions to eligible participants. The amount of matching contributions are determined on an annual basis by the Museum. For the year ended December 31, 2024, the Museum made a discretionary matching contribution of 4 percent of participating eligible employee compensation.

d. Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants subsequent to year end.

1. Description of Plan (continued)

e. Participant Accounts

Each participant's account is credited with the participant's contributions, matching contributions from the Museum and allocations of net earnings and losses from the Plan's investments in proportion to individual participant balances in such investments on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

f. Vesting

Participant contributions and funds rolled over from other qualified plans, plus earnings thereon are fully vested upon deposit. Participants are 50 percent vested in employer contributions after 1 year of service and 100 percent vested in employer contributions after 2 years of service.

g. Notes Receivable from Participants

Participants may borrow from their accounts in amounts up to the lesser of 50 percent of their vested pre-tax deferral balance or \$50,000. Loans are secured by the balance in the participant's account, bear interest at a commercially reasonable rate and are to be repaid over a reasonable period of time not to exceed five years. These loans bear interest based on the prevailing interest rates, as determined by the Plan Administrator at the time of the loan, ranging from 4.25 to 9.50 percent at December 31, 2024 and mature on various dates through September 2028.

h. Payment of Benefits

A participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account upon termination of service due to death, disability, retirement, or other termination of employment.

In-service withdrawals are available in certain limited circumstances, as defined by the Plan document. Hardship withdrawals are allowed for participants incurring an immediate and heavy financial need, as defined by the Plan document, and in accordance with the Internal Revenue Code (IRC). The Plan allows a participant to receive a hardship withdrawal of all or part of the vested portion of their individual account attributable to employer contributions and all elective deferrals and other contributions, including any earnings attributable to such contributions, as defined by the Plan document, in the event of hardship.

1. Description of Plan (continued)

i. Forfeitures

Participants forfeit their nonvested balances upon termination of employment. Forfeited balances of terminated participants' nonvested accounts are used to pay the Plan's administrative expenses or to reduce any employer contributions. There were no unallocated forfeiture account balances at December 31, 2024 and 2023.

j. Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the Museum as provided by the Plan document.

2. Summary of Significant Accounting Policies

a. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

b. Management's Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (US GAAP) requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

c. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Audit and Risk Committee determines the Plan's valuation policies utilizing information provided by the Custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

d. Contributions

Contributions from Plan participants and the related matching contributions from the employer are recorded in the year which the employee contributions are withheld from compensation.

e. Payment of Benefits

Benefits are recorded when paid.

f. Subsequent Events

The Plan has evaluated subsequent events through, September 4, 2025, the date the financial statements were available to be issued, and it was determined that all subsequent events had been properly accounted for.

3. Information Certified by Custodian

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedule, obtained by management and agreed to or derived from information certified as complete and accurate by the Custodian, a qualified institution. Accordingly, as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information which appears throughout the financial statements and supplemental schedule related to the following assets:

4. Fair Value Measurements

US GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under US GAAP are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following describes the methods and significant assumptions used to determine fair values:

Mutual funds – Valued at the closing price reported on the active market on which the individual funds are traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

At December 31, 2024 and 2023, the Plan classifies mutual funds carried at fair value in the amount of \$6,223,744 and \$5,217,341, respectively, as level 1 investments.

5. Plan Termination

Although it has not expressed any intent to do so, the Museum has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, each participant automatically becomes vested to the extent of the balance credited in the participant's account.

6. Tax Status

The Plan has adopted a non-standardized pre-approved plan sponsored by the Custodian. The non-standardized pre-approved plan has received an opinion letter dated June 30, 2020 from the Internal Revenue Service as to the non-standardized pre-approved plan's qualified status. The non-standardized pre-approved plan opinion letter has been relied upon by the Plan. The Plan has been amended since the non-standardized pre-approved plan received the opinion letter. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

US GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Plan years from December 31, 2021 are open for examination for federal tax purposes.

7. Risks and Uncertainties

Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits. Plan participants should refer to the individual fund and investment descriptions for more information regarding the funds, the underlying investment securities and the associated risks of investment loss.

8. Exempt Party-in-Interest Transactions

The Plan's investments in mutual funds are managed by an affiliate of the Custodian and therefore are considered exempt party-in-interest transactions. Notes receivable from participants are also considered exempt party-in-interest transactions.
