INDEPENDENT AUDITORS' REPORT

To the Administrative Committee of
Gold Star Foods 401(k) Retirement Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Gold Star Foods 401(k) Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section -

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Gold Star Foods 401(k) Retirement Savings Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Gold Star Foods 401(k) Retirement Savings Plan’s ability to continue as a going concern for one year after the date financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors’ Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors’ report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Gold Star Foods 401(k) Retirement Savings Plan’s ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE A - DESCRIPTION OF THE PLAN

The following description of the Gold Star Foods 401(k) Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

1. General

Effective December 1, 1995, the Plan was established for the benefit of all eligible employees of Gold Star Foods and Gold Star Food Service, Inc. (collectively, the “Employer”). The Plan has been amended and restated throughout the years to comply with tax legislation. Most recently restated January 1, 2022. The Plan is a contributory profit sharing plan under Sections 401(a) and 401(k) of the Internal Revenue Code (“IRC”) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

2. Eligibility

An employee is eligible to participate in the Plan on the first day of the month following completion of three months of service and attainment of age 18. Employees who are non-resident aliens are not eligible to participate in the Plan.

3. Contributions

Participants may elect to contribute, on a tax-deferred basis, up to 65% of their compensation up to the maximum deferral limit per Section 402(g)(1) of the IRC. The Plan allows for auto-enrollment, which automatically enrolls newly eligible employees into the Plan at a 3% deferral rate, unless a different amount is elected by the participant. Participants who attain age 50 before the end of the Plan year are eligible to make catch-up contributions.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans or conduit Individual Retirement Accounts (“IRA”).

The Employer makes matching contributions equal to 25% on 65% of the participant’s deferred compensation. Employer matching contributions for the year ended December 31, 2024 were \$477,917 (net of \$82,530 of applied forfeitures). Employer non-elective contributions and qualified non-elective contributions are discretionary (subject to determination on an annual basis by the Board of Directors of the Employer). Participants must be employed on the last day of the Plan year to be eligible for Employer non-elective contributions. There were no Employer non-elective or qualified non-elective contributions for the year ended December 31, 2024.

4. Investment Options

Upon enrollment in the Plan, a participant may direct employee and Employer contributions, as desired, in any of a variety of options offered by ADP Retirement Services, as provided by the Plan. Participants may change their investment options daily.

5. Participant Accounts

Each participant's account is credited with the participant's contributions, Employer matching contributions and allocations of Employer non-elective contributions, plan earnings, and administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

6. Notes Receivable from Participants

Participants may borrow a minimum of \$500 up to a maximum of 50% of their vested account balance not to exceed \$50,000 less the highest outstanding loan balance during the previous one year period. Effective December 1, 2019, the loans shall bear interest at the prime rate as published in the Wall Street Journal plus 1%. Loans issued prior to December 1, 2019 bear interest at the prime rate plus 2%. The loans must be repaid within five years of the date of issuance in accordance with terms established by the plan administrator. Loans for the purchase of a principal residence may be paid back over a longer reasonable period of time. Up to three loans may be outstanding at any time but only one with an initial term greater than five years.

7. Benefit Payments

Upon termination of service, participants are entitled to receive their vested account balances. Upon normal retirement age, or in the event of permanent disability or death while employed by the Employer, a participant or a participant's beneficiary is entitled to the total value of the participant's account balance. In-service and hardship withdrawals are permitted if certain criteria are met.

8. Forfeitures

Forfeitures of terminated participants' non-vested accounts may be used to reduce Employer contributions or to pay plan expenses. The unallocated forfeiture balances at December 31, 2024 and 2023 were \$9,377 and \$7,379, respectively. See Note A-3.

9. Plan Termination

While the Employer has not expressed any intent to do so, the Employer reserves the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination, all interests of participants become fully vested, and the assets are distributed to the participants of the Plan in accordance with the provisions of the Plan.

10. Vesting

Participant contributions, Employer qualified non-elective contributions, and Employer qualified matching contributions and actual earnings on all such contributions are fully vested at all times. However, vesting of the Employer matching and Employer non-elective contribution portions of participant accounts, plus actual earnings thereon, is based upon the participant's years of service with the Employer as follows:

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1. Basis of Presentation

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

2. Plan Administration

Gold Star Foods, Inc. is the plan sponsor and plan administrator. The plan administrator is responsible for carrying out the duties imposed under ERISA.

3. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

4. **Payment of Benefits**

Benefits are recorded when paid.

5. **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

6. **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation/depreciation in fair value of investments.

7. **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned on an accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

9. **Contributions**

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

NOTE C - INFORMATION CERTIFIED BY THE TRUSTEE

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (the trustee of the Plan).

NOTE D - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at quoted net asset value (“NAV”) of shares held by the Plan at year end. These funds are required to publish their daily net asset value and transact at that price. The NAV for mutual funds is a publicly available quoted price in an active market.

Common/collective trust: The Invesco Stable Asset Fund (“Invesco”) is composed primarily of fully benefit responsive investment contracts and is valued at the net asset value of the units of Invesco. The net asset value represents contract value and is used as a practical expedient to estimate fair value. The Plan may redeem units at any time upon ten days’ notice at the lesser of market value or contract value of the redeemed units. Employer initiated events, if material, such as plant closings, layoffs, plan termination, bankruptcy or reorganization, merger, early retirement incentive programs, tax disqualification of a trust, or other events could limit Invesco’s ability to transact at contract value with unitholders. As of December 31, 2024, plan management believes the occurrence of an event that would limit the ability of Invesco to transact at contract value with its unitholders is not probable.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Reliance Trust Company is the trustee and ADP Retirement Services is the recordkeeper for the Plan. Therefore, transactions with these entities qualify as party-in-interest transactions. Notes receivable from participants and the related interest income are also considered party-in-interest transactions.

NOTE F - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

NOTE G - TAX STATUS

The Employer adopted a Non-Standardized Pre-Approved Profit Sharing Plan (pre-approved plan) which received a favorable opinion letter from the Internal Revenue service ("IRS") dated October 6, 2020, which stated that the pre-approved plan is acceptable under section 401 of the IRC. The Plan has been amended since receiving the opinion letter. However, the plan administrator and the plan's advisors believe that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC. Administration errors, if any, that are insignificant or operational in nature are handled by the plan administrator in accordance with applicable IRS correction policies. Therefore, the plan administrator believes that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE H - SUBSEQUENT EVENTS

Effective January 1, 2025, the Plan changed its trustee from Reliance Trust Company to ADP Retirement Trust Services, LLC. Additionally, the Plan was amended to permit elective Roth deferrals as of June 1, 2025.

Plan management has evaluated subsequent events through September 25, 2025, the date the financial statements were available to be issued and determined that no other events occurred that require disclosure.
