Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of Fore Property Company 401(k) Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Their report also indicated that the form and content of the 2023 supplemental schedules, other than the information in the 2023 supplemental schedules that agrees to or is derived from the certified investment information, were presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, and the information in the 2023 supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTES TO FINANCIAL STATEMENTS

Note 1. Summary of Significant Accounting Policies

A summary of the Plan's significant accounting policies follows:

Basis of accounting:

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition:

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Payment of benefits:

Benefits are recorded when paid.

NOTES TO FINANCIAL STATEMENTS

Note 1. Summary of Significant Accounting Policies (continued)

Expenses:

Certain expenses of maintaining the Plan are paid directly by the Sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participants account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent events:

The plan has evaluated subsequent events through September 24, 2025 the date the financial statements were available to be issued.

Note 2. Description of Plan

A brief summary of Fore Property Company 401(k) Savings Plan is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

Fore Property Company entered into the Fore Property Company 401(k) Savings Plan on January 1, 2000. The Plan became effective on this date. The plan was amended on August 1, 2024 to allow for in plan rollover contributions. The Plan and Trust agreement was written to comply with the requirements of the Employee Retirement Income Security Act of 1974 (ERISA) and the provisions of the Tax Reform Act of 1986 and have been amended and restated since inception to comply with various changes in legislation and regulations.

Eligibility:

All eligible employees who have been employed for at least two months by Fore Property Company (the "Plan Sponsor").

Contributions and benefits:

Each year, participants may contribute up to 90%, subject to certain dollar limits set by law, of pre-tax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Plan includes an automatic enrollment provision where all eligible employees are automatically enrolled at a pre-tax deferral rate of 3% of eligible compensation.

NOTES TO FINANCIAL STATEMENTS

Note 2. Description of Plan (continued)

Participants direct the investment of their contributions into various investment options offered by the Plan. The Company will determine in its sole discretion how much, if any, it will make as an employer matching contribution. Participants must complete 1,000 hours of service and be employed on the last day of the Plan year in order to be eligible for Company discretionary matching contributions. For the period January 1, 2024, through December 31, 2024, the Company contributed dollar per dollar of participant contributions up to \$1,000, totaling \$145,302. The plan also provides for discretionary profit sharing contributions. No Company discretionary profit-sharing contribution was made for the year ended December 31, 2024.

Notes receivable from participants:

Participants may borrow from the Plan a minimum of \$1,000 or a maximum of \$50,000 or the lesser of one-half of the nonforfeitable accrued benefit attributable to the participant in the Plan. Loan transactions are treated as a transfer to (from) the investment fund from (to) the Participant Loan Fund. Loan terms range from 1-5 years. The loans are secured by the balance in the participant's account and bear interest at a rate of 1% plus the prevailing prime rate as determined quarterly by the Plan Administrator. Interest rates range from 4.25% to 9.50%. Principal and interest are paid ratably through monthly payroll deductions.

Forfeited accounts:

Forfeitures of Company contributions may be used to pay Plan administrative expenses or to reduce future Company contributions. During the year ended December 31, 2024, forfeitures of \$14,355 were used to reduce the 2023 Company discretionary matching contribution made during 2024.

Participant accounts:

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participants vested account.

NOTES TO FINANCIAL STATEMENTS

Note 2. Description of Plan (continued)

Vesting:

Participants are immediately vested in their contributions and Employer's Safe Harbor contributions plus actual earnings thereon. Vesting in the Company's discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. Participants are vested in Company contributions at 25% after one year of service and an additional 25% each year thereafter until 100% vested upon four years of service. If a participant becomes disabled, dies or reaches normal retirement age, the participant becomes 100% vested.

Payment of benefits:

The form of distribution is a lump-sum payment equal to the value of the participant's vested interest in his or her account. On termination of service, a participant forfeits all non-vested balances. Prior to termination of employment, a participant may receive a hardship or in-service distribution for part or all of their vested accounts. The Plan provides for a mandatory cash-out following severance of employment for account balances less than \$5,000.

Note 3. Tax Status

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated October 6, 2020 that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator and the plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related Trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no recognition of a liability (or asset) or disclosures required to be included in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTES TO FINANCIAL STATEMENTS

Note 4. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 5. Plan Termination

Although the Company has established the Plan with the bona fide intention and expectation that it will be maintained indefinitely, nevertheless, the Company is not under any obligation or liability to continue the Plan for any given length of time. The Company may in its sole discretion discontinue or terminate the Plan in whole or in part in accordance with its provisions at any time without any liability for such discontinuance or termination. In the event the Plan terminates, if the Plan is not replaced by a comparable plan qualified under Section 401(a) of the Code, then the accounts of all participants affected by the termination, partial termination or discontinuance of contributions will become non-forfeitable. After termination of the Plan, the Trust will continue until the Plan benefit of each participant has been distributed. Plan benefits may be distributed promptly after they are computed or distribution may be deferred, as the Committee may direct. Distributions of a participant's account will be made in joint and survivor or pre-retirement survivor annuities of the Plan. If the participant (and spouse if applicable) elects not to receive such annuities, the account will be distributed, at the participant's election, in either a lump sum or in cash installments.

Note 6. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

NOTES TO FINANCIAL STATEMENTS

Note 6. Fair Value Measurements (continued)

Level 2 Inputs to the valuation methodology include;

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Mutual Funds: Valued at the daily closing price as reported to the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Invesco Stable Asset Fund: The Invesco Stable Asset Fund, held in a collective trust ("CT"), is valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

NOTES TO FINANCIAL STATEMENTS

Note 6. Fair Value Measurements (continued)

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

ADP, the recordkeeper and broker-dealer, received \$48,293 for administration fees, all of which were paid by the participants through the Plan, and indirect compensation.

Note 8. Benefits Distributed to Participants

Benefit distributions totaling \$1,182,592 were paid for the year ended December 31, 2024.

Deemed distributions associated with defaulted loans totaled \$1,307 as of December 31, 2024.

There were no unallocated forfeitures for terminated participants as of December 31, 2024.

Note 9. Certified Investments

Certain information related to investments and notes receivable from participants in the accompanying financial statements and supplementary schedules, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Reliance Trust Company (current trustee).
