Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Fungi Perfecti, LLC 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Fungi Perfecti, LLC 401(k) Profit Sharing Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

NOTE A.--DESCRIPTION OF PLAN

The following description of the Fungi Perfecti, LLC (Company or Plan Sponsor) 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a non-standardized pre-approved profit sharing plan with money purchase or cash or deferred arrangement originally established by the Company effective January 1, 2006. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Effective June 1, 2022, the Plan was amended and restated to comply with Cycle 3 restatement requirements. An eligible employee is any person employed by the Company except union employees, non-resident aliens, and leased employees. Effective October 1, 2024, the Plan was amended to remove the service requirements, making participants immediately eligible to enter the Plan on the first day of the month following their employment. Prior to this, an employee was eligible to make elective deferrals and receive safe harbor contributions after completing three months of service, with the entry date being the first day of each month following completion of eligibility requirements. See also Note J.

Contributions: The Plan is funded by eligible participant elective deferrals which may range from 1% to 90% of eligible compensation, safe harbor contributions, and non-elective discretionary contributions. The Plan is a safe harbor plan. The Company contributes a safe harbor qualified match of 100% of elective deferral contributions that are not over 6% of pay.

Non-elective discretionary contributions are allocated to participants in the same proportion as a participant's compensation bears to the total of all participants' compensation. Participants must be employed on the last day of the Plan year and complete 1,000 hours of service during the Plan year to be eligible to receive any profit sharing contributions, unless the participant dies, becomes disabled or reaches the normal retirement age. There were no discretionary profit sharing contributions in 2024.

Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. All participants who are eligible to make elective deferral contributions may elect to designate all or any portion of their future deferrals as Roth elective deferral contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans. Contributions are subject to certain limitations.

NOTE A.--DESCRIPTION OF PLAN (Continued)

Participant Accounts: Each participant's account is credited with the participant's contribution, an allocation of the Company's contribution, an allocation of plan earnings (losses), and charged with an allocation of certain administrative expenses. Allocations are based on participant compensation, account balances, or specific participant transactions, as applicable, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant's account.

Vesting: Participants are immediately vested in their rollover contributions, elective deferrals, Company safe harbor matching contributions and any non-elective profit-sharing contributions plus actual earnings thereon.

Retirement: The normal retirement date is the date the participant turns 65. Early retirement is not permitted.

Payment of Benefits: On termination of service, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account as soon as administratively feasible. Upon death of a participant, payments made to a beneficiary shall be payable in a lump sum or partial withdrawals or substantially equal installments. For terminated participants, if the balance of the vested accounts is \$1,000 or less, excluding rollover contributions, payment may be made in a lump-sum without the participant's consent. If such balance is greater than \$1,000 but less than \$5,000, without other election it will automatically be rolled over into an IRA established by an IRA provider selected by the Company. Effective January 1, 2024, as part of the SECURE 2.0 Act, the cash out limit was increased from \$5,000 to \$7,000. In-service distributions are allowed at age 59 ½. Hardship distributions are allowed in accordance with Plan provisions. Distributions may be taken from contributed rollover amounts at any time.

Notes Receivable from Participants: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are issued by the Plan and secured by the balances in the participant's account. Loan transactions are treated as a transfer to (from) the investment fund from (to) the loan fund. All loans must be repaid within a period of five years, unless the loan is used to purchase a principal residence, in which case, the loan must be repaid within a reasonable period of time not to exceed thirty years. Effective May 2, 2022, the loans are to bear a rate of interest of the Prime Rate plus 1%. Prior to this, the loans were to bear a rate of interest based on rates available for similar loans from commercial lending institutions. A participant may only have two loans outstanding at any time. Principal and interest are paid through payroll deductions.

Forfeited Accounts: Participants are fully vested in their employer contributions. Accordingly, forfeitures relate to corrective distributions only. Forfeitures may be used to pay Plan expenses and the remainder will be reallocated to eligible participants as employer contributions. At December 31, 2024 and 2023, the balance of forfeited accounts totaled \$10 and \$11, respectively. During 2024, no balances were forfeited and \$1 of employer contributions were paid from forfeited non-vested accounts.

Investment Options: Participants direct their contributions and account balances in a variety of investment options including mutual funds. The Plan Sponsor periodically reviews the investment options available to participants and changes them as warranted. Participants may change their investments at any time.

Plan Expenses: Expenses of maintaining the Plan may be paid by the Company or the Plan. Certain expenses of maintaining the Plan are paid for directly by the Company and are not included in these financial statements. Fees relating to administration of notes receivable from participants and for certain withdrawals are charged directly to the participant's account and are included in administrative expenses. Investment related expenses, including revenue sharing fees and 12(b)(1) fees, as applicable, are deducted from each funds' earnings and included in net appreciation (depreciation) in fair value of investments.

NOTE B.--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the financial statements and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's committee determines the Plan's valuation utilizing information provided by investment advisors, custodian and trustee. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits: Benefits are recorded when paid.

NOTE C.--CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, dividend income and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, the trustee and custodian of the Plan.

NOTE D.--FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E.--RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are in funds managed by the trustee and custodian, Reliance Trust Company; therefore, these transactions qualify as party-in-interest transactions. Certain administrative functions of the Plan are performed by officers or employees of the Company. Certain employees of the Company serve as trustees of the Plan. No such officer or employee receives compensation from the Plan.

NOTE F.--TAX STATUS

The Plan was amended and restated effective June 1, 2022 and adopted a prototype non-standardized pre-approved profit sharing plan with money purchase or cash or deferred arrangement which received a favorable opinion letter from the Internal Revenue Service (IRS) on October 6, 2020, which stated that the Plan is designed in accordance with applicable sections of the Internal Revenue Code.

The Plan has been amended since the date of this determination letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination.

The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE G.--PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provision of ERISA. In the event of Plan termination, the respective accounts of the participants under the Plan, including employer contributions, shall become fully vested and non-forfeitable.

NOTE H.--RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as foreign currency exchange rate, interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

NOTE I.--TRUE-UP OF EMPLOYER MATCH

As part of the normal course of plan operations, an annual true-up must be calculated on the safe harbor match contributions made throughout the year. As a result of the true-up assessments at December 31, 2024 and 2023, total additional safe harbor match contributions of \$36,436 and \$14,128, respectively, were deposited to participant accounts subsequent to those year ends and are included in employer contribution receivable as of December 31, 2024 and 2023, in the accompanying statements of net assets available for benefits.

NOTE J.--SUBSEQUENT EVENTS

Effective January 1, 2025, the Plan was amended to incorporate an eligible automatic contribution arrangement feature at 6% of compensation, with no escalation for all new plan participants after this date. The Plan allows for permissible withdrawals within the first 60 days of the first automatic deferral.

Plan management has evaluated subsequent events through September 12, 2025 the date the financial statements were available to be issued.
