NOTES TO THE FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF THE PLAN

The following description of the Indio Management 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan, which was effective January 1, 2017, is a defined contribution plan with salary reduction features as permitted under Section 401(k) of the Internal Revenue Code (IRC). The Plan covers substantially all employees of Indio Partners, LP (the Company and Plan Sponsor). The Plan is administered by a committee appointed by the Company. At December 31, 2024 and 2023, the assets of the Plan were maintained in investment funds held by Reliance Trust Company (Reliance), the Custodian of the Plan. The Plan is intended to conform to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and subsequent legislation, where applicable.

Eligibility

Individuals become eligible to participate in the Plan on the first day of the following month after attaining three consecutive months of service as long as they have attained age 21. Employees not eligible to participate in the Plan are non-resident aliens with no U.S. earned income, and residents of Puerto Rico.

Contributions

Participants employed by the Company may elect to contribute to the Plan a portion of compensation, on a pre-tax basis and/or in the form of a designated Roth contribution, up to 75% of the contributing employee's compensation, not to exceed the maximum annual limitations as provided by the IRC.

The Company provides a safe harbor matching contribution equal to 100% of the first 3% of the participant's deferral plus 50% of deferrals from the next 2% of compensation a participant contributes to the Plan. The Company may also make an annual discretionary non-elective contribution to the Plan. Participants must be employed on the last day of the plan year and have earned 1,000 hours of service to be eligible to receive discretionary non-elective contributions. No additional discretionary non-elective contributions were made to the Plan for the years ended December 31, 2024 and 2023. The Plan also accepts participant rollover contributions from other qualified plans.

Participant Accounts

Each participant's account is credited with the participant's contribution and (a) an allocation of Company safe harbor matching and discretionary non-elective contributions, (b) plan earnings or losses, and (c) administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investments

Participants direct the investment of their and company contributions into various investment options offered by the Plan. Participants may change their investment allocation on a daily basis.

1. DESCRIPTION OF THE PLAN (Continued)

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the vested balance in the participant's account and bear interest rates at the interest rate determined by the Plan Administrator at the time of the loan.

Payment of Benefits

Participants are eligible for retirement benefits upon reaching age 65. The normal form of benefit under the Plan is a single lump sum distribution. Participants may receive their accumulated vested benefits held by the Plan's trustees upon termination of employment or elect to keep their vested balance in the Plan until the earlier of normal retirement age, death, or disability if their account balance is in excess of \$5,000. If participants elect to keep their vested interest in the Plan, their account will continue to receive its share of earnings or losses.

Vesting

Participants are automatically 100% vested in their before-tax, Roth, rollover and safe harbor contributions. Vesting in the Company's contributions is based on years of service. For safe harbor matching contributions, a participant becomes 20% vested after two years of service, 40% vested after three years of service, 60% vested after four years of service, 80% vested after five years of service, and 100% vested after six years of service.

Hardship Withdrawals

Participants can, under certain defined conditions, withdraw any part of their vested account attributable to their elective deferral contributions credited to their account.

Forfeitures

Forfeitures of nonvested separated participants may be used to offset plan expenses or reduce future employer contributions. Forfeitures of \$229 and \$465 were used to offset employer contributions to the Plan for the years ended December 31, 2024 and 2023, respectively. Unused forfeited account balances were \$10 at December 31, 2024 and 2023.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan prepares its financial statements on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition

The Plan's assets are held in a trust maintained by Reliance. Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Changes in the current value of investments held during the year, including realized gains and losses on assets bought and sold during the year, are reflected in the statements of changes in net assets available for benefits as net appreciation or depreciation in the fair value of investments. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan Document.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Certain accounting and investment fees of the Plan are paid by the Plan Sponsor.

Risks and Uncertainties

The Plan's assets include various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty related to the value of such investments, changes in the values of investments will occur and such changes could materially affect the amounts reported in the financial statements.

Income Taxes

The Plan Sponsor adopted a pre-approved plan document which received a favorable opinion letter, issued to the document provider, from the Internal Revenue Service dated October 06, 2020, which states that the Plan is designed in accordance with the applicable sections of the IRC and is, therefore, not subject to tax under present income tax law. The Plan is required to operate in conformity with the IRC to maintain its qualification. Management is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status.

3. FINANCIAL CERTIFICATION

The following financial information relating to the Plan's assets at December 31, 2024 and 2023, as well as investment income and investment transactions for the years then ended, has been derived from information provided by Reliance, the Custodian of the Plan, and has been certified as complete and accurate. The incorporation of this financial information in the accompanying financial statements is based solely on the certification.

4. FAIR VALUE MEASUREMENTS

The Plan uses various valuation techniques in determining fair value. Accounting Standards Codification Section 820 established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Accounting Standards Codification Section 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

4. FAIR VALUE MEASUREMENTS (Continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used for the years ended December 31, 2024 and 2023.

Mutual Funds

The fair values of the Plan's mutual funds are based on quoted market prices in active markets.

Common Collective Trust

Valued at Net Asset Value (NAV) based on the underlying assets of the trust. The NAV is used as a practical expedient to estimate fair value. The fund seeks to provide maximum current income while maintaining stability of principal. The fund invests primarily in a portfolio of Guaranteed Investment Contracts, Bank Investment Contracts, Synthetic Investment Contracts and Separate Account Contracts, which are designed to provide stability and a competitive yield. NAV is obtained from information provided by the investment advisor using the audited financial statements of the common collective trust funds at year end.

The common collective trusts can be redeemed on a daily basis and there are no restrictions. There are no unfunded commitments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Financial assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurements. For the years ended December 31, 2024 and 2023, no transfers in or out of Level 1 occurred.
