## INDEPENDENT AUDITORS' REPORT

Their report dated October 11, 2024 indicated that in their opinion (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2023 supplemental schedules, other than the information in the 2023 supplemental schedules that agrees to or is derived from the certified investment information, were presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, and the information in the 2023 supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**Note 1 – Description of Plan**

The following description of the St. Moritz 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan’s provisions.

General – The Plan commenced on January 1, 2016 and was most recently amended on January 1, 2022. The Plan is a defined contribution plan covering all eligible salaried and hourly employees of St. Moritz Security Services, Inc. and affiliated contributing companies (collectively referred to as “Company”) who have met the plan participation requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions – Participants may elect to contribute from 1% to 90% of their compensation, as defined in the Plan document, as a pre-tax contribution or as a post-tax Roth deferral up to the limits established by the Internal Revenue Service (the “IRS”) of \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively, or as a post-tax Roth deferral. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Contributions are subject to certain limitations. The aggregate contributions to each participant account may not exceed \$69,000 (\$76,500 including catch-up contributions) and \$66,000 (\$73,500 including catch-up contributions) for the years ended December 31, 2024 and 2023, respectively. The Plan currently offers various mutual funds and common collective trust funds as investment options for participants.

**Contributions – Participant 401(k) Deferral**

Eligibility and Participation – The eligibility requirements of salary deferrals require the participant to be 21 years of age and completion of one year of service or 1,000 hours of service during the Plan year.

Participant Contributions – Participants may direct their contributions or re-allocate their account balance at any time into various investment options offered by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions of \$7,500 during the years ended December 31, 2024 and 2023.

**Employer Contributions**

Employers may make employer discretionary matching and discretionary profit-sharing contributions to the Plan. There were no employer discretionary matching and discretionary profit-sharing contributions as of December 31, 2024.

Compensation is defined as the total of a participant’s wages, salary, and other amounts subject to federal income tax withholding received from the Company for services rendered. ERISA regulations limit maximum compensation to \$345,000 and \$330,000 for the years ended December 31, 2024 and 2023, respectively.

Participant Accounts – Each participant’s account is credited to reflect participant contributions, Company matching and discretionary contributions, distributions, allocation of Plan earnings, and forfeitures, as outlined in the Plan document. Allocations of the Company’s matching and discretionary contributions are based on a percentage of participant compensation. Allocation of Plan earnings are based on the actual earnings of the participant-directed investments. Allocations of administrative expenses are either on a prorate or an equal-dollar basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Note 1 – Description of Plan – Continued**

Vesting – Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the employer match and discretionary contributions portion of their accounts is based on years of service. A participant is 100% vested after six years of credited service, earned in successive annual increments if 20% a year starting in year two.

Payment of Benefits – Upon retirement, disability, death, or other termination of employment, the participant's vested account will be distributed in a lump-sum payment or deferred installment payments for participants with required minimum distributions. In-service distributions are permitted if participants attain age 59 ½ and are limited to a minimum amount of \$500. Distributions may be made as soon as administratively feasible following severance of employment for accounts in excess of \$5,000.

Participants may request a distribution of a portion of their contributions in the event of a documented financial hardship. The distribution is limited to the amount of the hardship, which must arise from certain events prescribed by law. Hardship distributions can only be made from accounts which are 100% vested. Participants must be employed with the Company at the time of the hardship distribution.

Forfeited Accounts – Forfeitures may be used to pay Plan expenses or to reduce amounts otherwise required to be contributed to the Plan. There were no forfeited accounts as of December 31, 2024 and 2023.

**Note 2 – Summary of Significant Accounting Policies**

Basis of Accounting – The financial statements and supplemental schedule of the Plan have been prepared using the accrual method of accounting.

Investment Valuation and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's administrator determines the Plan's valuation policies utilizing information provided by the investment advisor and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Benefits Paid to Participants – Benefits are recorded when paid, unless a situation arises where benefits are to be paid, but actual disbursement does not occur until the following Plan year, in which case accrued benefits are recorded. There were no accrued benefits noted as of December 31, 2024 and 2023.

Administrative Expenses – Certain administrative expenses of the Plan were paid by the Company, are not reflected in the accompanying financial statements, and are not considered an employer contribution. Investment related expenses are included in net appreciation in fair value of investments.

Use of Estimates – The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

**Note 3 – Information Prepared and Certified by Custodians**

The unaudited information regarding the Plan included in the Plan's financial statements and the supplemental schedule that was prepared by, or derived from, information prepared by Reliance Trust Company, the custodian of the Plan's assets, and furnished to the Plan administrator. The Plan administrator has obtained certifications from the custodians that such information is complete and accurate. See Note 4 for a summary of the unaudited information and all investment and investment income. All information is included in the supplemental schedule.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

**Note 4 – Fair Value Measurements**

The Plan reports investments at fair value. Market price observability is impacted by several factors, including the type of investment, the characteristics specific to the investment, and the state of the marketplace (including the existence and transparency of transactions between market participants). Investments with readily-available, actively-quoted prices (or for which fair value can be measured from actively-quoted prices in an orderly market) will generally have a higher degree of market price observability and a lesser degree of judgment used in measuring fair value.

Investments measured and reported at fair value are classified and disclosed in one of the following categories based on inputs:

Level I – Quoted prices are available in active markets for identical investments as of the reporting date. The type of investments which would generally be included in Level I include listed equity securities and listed derivatives. The Plan, to the extent that it holds such investments, does not adjust the quoted price for these investments, even in situations where the Plan holds a large position, and a sale could reasonably impact the quoted price.

Level II – Pricing inputs are observable for the investments, either directly or indirectly, as of the reporting date, but are not the same as those used in Level I. Fair value is determined using models or other valuation methodologies. The types of investments which would generally be included in this category include publicly-traded securities with restrictions on disposition, debt securities and partnerships that hold Level I assets, and real estate held for investment, if measured by a current appraisal.

Level III – Pricing inputs are unobservable for the investment and include situations where there is little, if any, market activity for the investment. The inputs into the determination of fair value require significant judgment or estimation by the Plan. The types of investments which would generally be included in this category include debt and equity securities issued by private entities, as well as real estate held for investment, if measured using management estimates.

In certain cases, the inputs used to measure fair value may fall into different levels of the fair value hierarchy. In such cases, the determination of which category within the fair value hierarchy is appropriate for any given investment is based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement in its entirety requires judgment and considers factors specific to the investment.

**Note 4 – Fair Value Measurements – Continued**

The following sections describe the valuation methodologies used by the Plan to measure investments at fair value, including an indication of the level in the fair value hierarchy in which each major category of investments is generally classified. Where appropriate, the description includes details of the valuation models and any significant assumptions. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual Funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/Collective Trusts* – A stable value fund that is composed primarily of fully benefit-responsive investment contracts that are valued at the NAV of units of the bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above could produce a fair value calculation that might not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5 – Related Party and Party-In-Interest Transactions**

The Plan paid certain administrative fees paid by the Plan for investment management services. These fees are netted against net appreciation or depreciation in fair value of investments during the years ended December 31, 2024 and 2023. These transactions are not, however, considered prohibited transactions under Section 408(b) of ERISA regulations.

**Note 6 – Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

**Note 7 – Tax Status**

The IRS has determined and informed the Employer by a letter dated October 6, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

**Note 7 – Tax Status – Continued**

Accounting principles generally accepted in the United States of America (“U.S. GAAP”) requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position, based on management’s judgment of the risk of loss for items that have been, or may be, challenged by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in process.

**Note 8 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

**Note 9 – Certified Investments**

Certain information related to investments disclosed in the accompanying financial statements and ERISA required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and dividends for the year ended December 31, 2024 was obtained by management and agreed to, or derived from information certified as complete and accurate by Reliance Trust Company, the trustee of the Plan.

**Note 10 – Subsequent Events**

Management has evaluated subsequent events through September 24, 2025, the date the financial statements were available to be issued, and determined that no material subsequent events have occurred but do require disclosure in the notes to the financial statements as follows:

The Company changed trustees from the Reliance Trust Company to ADP Retirement Trust Services, LLC, effective January 1, 2025.
