Except as discussed in the following paragraph, in planning and performing our audit of the financial statements of CRH Medical 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as of and for the year ended December 31, 2024, in accordance with auditing standards generally accepted in the United States of America, we considered the Plan's internal control over financial reporting (internal control) as a basis for designing audit procedures that are appropriate in the circumstances for the purpose of issuing our report on the financial statements, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, we do not express an opinion on the effectiveness of the Plan's internal control.

We were engaged to perform an ERISA Section 103(a)(3)(C) audit of those financial statements as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to assets held for investment of the Plan (investment information) by a qualified institution that prepared and certified the investment information in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Our audit also did not include a consideration of internal control relating to the investment information.

A deficiency in internal control exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct misstatements on a timely basis. A material weakness is a deficiency, or a combination of deficiencies, in internal control, such that there is a reasonable possibility that a material misstatement of the Plan's financial statements will not be prevented, or detected and corrected, on a timely basis.

Our consideration of internal control was for the limited purpose described in the first two paragraphs and was not designed to identify all deficiencies in internal control that might be material weaknesses. In addition, because of inherent limitations in internal control, including the possibility of management override of controls, misstatements due to fraud or error may occur and not be detected by such controls. Given these limitations, during our audit we did not identify any deficiencies in internal control that we consider to be material weaknesses. However, material weaknesses may exist that have not been identified.

### **Material weaknesses**

Given the limitations described in the third paragraph, during our audit, we did not identify any deficiencies in internal control that we consider to be material weaknesses.

## **Significant deficiencies**

A significant deficiency is a deficiency, or a combination of deficiencies, in internal control that is less severe than a material weakness, yet important enough to merit attention by those charged with governance. We consider the following deficiencies in the Plan's internal control to be significant deficiencies:

### **Plan governance**

A Plan administrator has certain responsibilities as a fiduciary under ERISA. Examples of fiduciary acts include selection of fiduciaries or delegation of fiduciary responsibility, plan interpretation, determination of plan eligibility, selection of service providers, or determination and approval of expenses paid from plan assets. Fiduciaries are required to act solely in the interest of plan participants and beneficiaries and to act with the care, skill, prudence, and diligence under the circumstances then prevailing. They also have the duty to follow plan documents and avoid prohibited transactions.

We recommend that you take appropriate measures to mitigate risk by establishing appropriate oversight and governance of your benefit Plan. Appropriate benefit Plan governance should be structured by use of an oversight committee, and all actions taken by the committee should be formally tracked in the form of minutes.

### **Timing of contributions/prohibited transactions**

DOL Regulation 2510.3-102 requires that amounts that participants have withheld from their wages by an employer be contributed to the plan on the earliest date on which such contributions can reasonably be segregated from the employer's general assets. In any event, employee salary deferrals must be segregated from employer assets no later than the 15th business day of the month following the month in which they would otherwise have been payable to the participant in cash. If an employer does not deposit deferrals into the plan as soon as they can be reasonably segregated, they are considered as holding plan assets. This results in a prohibited transaction (a nonexempt extension of credit between the plan and a party in interest) which will trigger an excise tax of 15% of the amount of the lost earnings on the salary deferral contributions which were not deposited to the trust in a timely manner.

During our audit, we noticed that various salary reduction contributions, of approximately \$68,000 were not segregated from the general assets of the Employer and deposited to the trust in a timely manner for the 2024 and 2023 Plan year. These late contributions must be treated as prohibited transactions, as noted above. As such, they will be required to be reported on the supplemental schedule of delinquent participant contributions. Further, correction of the uncorrected prohibited transactions must be made by confirming that the salary reduction contributions have been paid to the trust, and submitting an interest payment to the trust, for allocation to the Plan participants' accounts, that is attributable to the period of the resulting extension of credit.

**Timing of contributions/prohibited transactions (continued)**

It is our understanding that management is taking the necessary steps to correct these late contributions. As fiduciary of the Plan, and part of Plan governance, the Plan Sponsor has an obligation to ensure that contributions are being remitted timely to the trust.

**Other deficiencies in internal control and other matters**

During our audit, we became aware of deficiencies in internal control and other matters that provide an opportunity to strengthen your internal control and improve the efficiency of your operations.

**Missing or incorrect employee demographic data**

During our audit, we noted cases of incomplete and incorrect I-9 demographic data that did not agree to the census demographic data. It is important to ensure documentation is complete and accurate to allow for support of employee eligibility and vesting dates. We recommend controls be reviewed and implemented to ensure I-9 forms are completed accurately and census data is reconciled.

**Reportable findings**

Reportable findings are items that are not in accordance with the criteria specified (for example, not in accordance with the plan instrument). We consider the following matters communicated above to be reportable findings.

- Plan Governance
- Timing of Contributions/Prohibited Transactions

We will review the status of these comments during our next audit engagement. We have already discussed many of these comments and suggestions with various plan personnel, and we will be pleased to discuss them in further detail at your convenience, to perform any additional study of these matters, or to assist you in implementing the recommendations.
