### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of JSSI Management Enterprises, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). ### 1. Description of the Plan

The following description of JSSI Management Enterprises, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan covering substantially all employees of JSSI Management Enterprises, LLC (the Company or JSSI), as defined in the Plan document, who are aged 21 or older. An eligible employee may become a Plan participant immediately on date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The Plan is administered by the JSSI Management Enterprises, LLC Plan Committee (the Committee) that serves at the discretion of the Company's Board of Directors. The Committee is responsible for all matters, including, but not limited to, determining eligibility and rights to benefits, interpreting Plan documents, and directing the Plan's trustee, Reliance Trust Company. Effective January 1, 2025, the Company appointed ADP Retirement Trust Services, LLC as the trustee of the Plan.

#### *Contributions*

Each year, participants may contribute up to 90% of their pretax annual compensation, as defined in the Plan, subject to limits allowed under the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Plan also allows participants to designate all or a portion of their deferrals as Roth contributions to the Plan on an after-tax basis.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated investment fund until changed by the participant. Automatically enrolled participants may elect to increase or decrease percentages, as defined in the Plan document.

The Plan provides for discretionary Company matching contributions. For the years ended December 31, 2024 and 2023, the Company made discretionary Company matching contributions equal to 75% of each participant's compensation contributed to the Plan up to 6% of the participant's eligible compensation. The Company contributed \$1,293,063 and \$1,368,508 as of December 31, 2024 and 2023, respectively.

The Plan also provides for discretionary Company profit-sharing contributions. Allocations to participant accounts are based on each participant's compensation as it bears to total compensation for all participants. The Company did not elect to make any such additional discretionary profit-sharing contributions to the Plan for the years ended December 31, 2024 and 2023.

Contributions are subject to certain IRC limitations.

Participants may direct all their contributions among one or more funds offered in the Plan. Changes in allocation of future contributions and transfers among funds of presently invested contributions are permitted pursuant to the Plan provisions.

### ***Participant Accounts***

Each participant's account is credited with the participant's contributions and any discretionary Company matching contributions, as well as allocations of (a) any additional discretionary Company profit-sharing contributions, and (b) Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balance, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### ***Notes Receivable from Participants***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates determined by the Plan administrator based on local prevailing rates. Interest rates range from 4.25% to 9.50% on outstanding loans as of December 31, 2024. Principal and interest are paid ratably through payroll deductions over a term not exceeding five years unless the loan is used for the purchase of a primary residence in which case a longer term may be granted.

### ***Payment of Benefits***

On termination of service due to retirement, death, disability, termination of employment, or attainment of age 59½, a participant may elect to receive the value of their vested interest in his or her account as a lump-sum amount, as partial payments, or in the form of installments. If the participant's vested interest in their account is less than \$7,000, a mandatory lump-sum distribution will be made to the participant. Withdrawals from the Plan may also be made upon circumstances of financial hardship, in accordance with provisions specified in the Plan document.

### ***Vesting***

Participants are immediately vested in their contributions plus actual earnings thereon. Participants are 100% vested in the Company's discretionary matching contribution portion of their accounts plus actual earnings thereon after three months of service.

## **2. Summary of Accounting Policies**

### ***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make significant estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial

statements, changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and trustees. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

### *Contribution Receivable*

Participant contributions and any related employer discretionary matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation. Non-elective/ discretionary profit sharing contributions are recorded in the relevant period in accordance with the terms in the Plan document.

### *Payment of Benefits*

Benefit payments are recorded when paid.

### *Plan Expenses*

The administrative expenses of the Plan are paid by the Plan participants directly and indirectly through an ERISA spending account, from the forfeiture accounts, and potentially from general assets of the Company. Certain asset management fees of the Plan are charged against the Plan's investment income. The ERISA spending account consists of a quarterly fee collected from each Plan participant to be used to pay eligible plan expenses on the Plan's behalf.

### *Subsequent Events*

Plan management evaluated subsequent events up through and including September 29, 2025, which is the date the financial statements were available to be issued.

## **3. Fair Value Measurements**

Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurements and Disclosures*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure

fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered Investment Companies* - These assets are valued at the daily closing prices as reported by the fund. Registered investment companies held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The shares of registered investment companies held by the Plan are deemed to be actively traded.

*Common/Collective Trust* - The Plan invests in the T. Rowe Price Stable Value Fund. It is a common/collective trust composed primarily of synthetic guaranteed investment contracts, as provided by the fund manager, and other investment contract products that provide stability. This asset is valued using the NAV as a practical expedient to estimate fair value. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV's unit price is quoted on a private market that is not active; however, the unit price is based on underlying investments that are traded on an active market. There were no unfunded commitments related to the common/collective trust. Participant transactions may occur daily with no advance notice. If the Plan initiates a full redemption of the stable value fund, the issuer reserves the right to require 12 months notification in order to ensure that securities liquidations will be carried out in an orderly business manner. This is a direct filing entity.

*Self-Directed Brokerage Accounts* - Self-directed brokerage accounts are valued based on the underlying holdings, which consist of cash and common stock, exchange traded funds, and registered investment company investments traded in active markets.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 8. Tax Status

The Plan adopted a pre-approved plan document from ADP, LLC, which received an opinion letter from the Internal Revenue Service (IRS), dated October 6, 2020, stating that the pre-approved plan document, as then-designed, was in compliance with the applicable regulations of the IRC. Although the Plan has been amended since the date of the opinion letter, the Plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
