The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024, and the related notes to the financial statements.

Plan management, having determined it is permissible in the circumstances, has elected to have the audits of the Synerfac, Inc. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Plan management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting described in Note 2.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Basis of Accounting

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements and supplemental schedule are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to that matter.

Responsibilities of Plan Management for the Financial Statements

Plan management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2, this includes determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Plan management's election of the ERISA Section 103(a)(3)(C) audit does not affect Plan management's responsibility for the financial statements.

Plan management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

1. Description of Plan

The following description of the Synerfac, Inc. Retirement/Profit Sharing Plan (the “Plan”) provides only general information. The Plan was originally effective January 1, 1990, and was most recently amended and restated effective October 1, 2022. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of Synerfac, Inc. (the “Company”), who have completed six months of service and are age twenty-one or older. Union employees, nonresident aliens and residents of Puerto Rico are not eligible to participate in the Plan. Eligible employees enter the Plan on the date the eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Contributions

Each year, participants may contribute a percentage of their pre-tax annual compensation, as defined in the Plan document. Contributions may also be designated as Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Plan provides for discretionary matching contributions. For the year ended December 31, 2024, the discretionary matching contributions amount was 10% of salary deferrals up to the first 5% of plan compensation.

The Plan also provides for discretionary nonelective profit sharing contributions. Participants who are age twenty-one or older and completed one year of service are eligible for discretionary nonelective profit sharing contributions. Participants must be employed on the last day of the Plan year and work 1,000 hours of service during the Plan year to share in the discretionary nonelective profit sharing contributions unless the participant retires, dies or becomes disabled. For the year ended December 31, 2024, the Company made no discretionary nonelective profit sharing contributions to the Plan.

Contributions are subject to certain Internal Revenue Service (“IRS”) limits. Participants direct the investment of their deferral contributions and Company contributions into various investment options offered by the Plan. Participants may change their investment options at any time.

Participant Accounts

Individual accounts are maintained for each participant. Each participant’s account is credited with the participant’s contributions and the Company’s matching contributions, if any, as well as allocations of nonelective profit sharing contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the amount that can be provided from the participant’s vested account.

Vesting

Participants are vested immediately in their contributions, including their elective pre-tax deferral contributions and rollover contributions, plus actual earnings thereon.

Vesting in the Company's discretionary employer matching contributions and nonelective profit sharing contributions portion of their accounts, plus related earnings thereon is based on years of vesting service, as follow:

Participants also become fully vested upon death, disability or normal retirement age (65).

Forfeited and Unallocated Accounts

Forfeitures resulting from the termination of participants with less than 100% vested interest in their employer contribution account balances are applied to reduce subsequent employer contributions to the Plan or to pay administrative expenses of the Plan. Forfeited non-vested accounts available as of December 31, 2024 and 2023 totaled \$8,393 and \$10, respectively. During the year ended December 31, 2024, \$0 of forfeitures were used to pay administrative expenses and \$14,766 forfeitures were used to offset employer contributions.

Payment of Benefits

On termination of service due to disability, retirement (age 65), or other reasons, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. In circumstances when a terminated participant has a vested account balance less than \$1,000, the participant's vested account balance shall be distributed in a lump sum. In the event of a mandatory distribution greater than \$1,000 but does not exceed \$7,000 (\$5,000 prior to modification allowed by the SECURE 2.0 Act of 2022), if the participant does not elect to have such distribution paid directly to an eligible retirement plan specified by the participant in a direct rollover or to receive the distribution directly, then the Plan administrator will pay the distribution in a direct rollover to an individual retirement account designated by the Plan administrator. Hardship and in-service distributions are also permitted from participant accounts, based on the terms of the Plan document. In addition, minimum payments must begin subject to IRS guidelines.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate one percent above the published prime rate. Principal and interest are generally repaid ratably through payroll deductions over a period of five years or less, with the exception of loans made for the purchase of a primary residence. Interest rates on notes receivable from participants ranged from 4.25% to 9.50% as of December 31, 2024. No more than one loan from the Plan to a participant shall be permitted at any time.

Corrective Distributions

Corrective distributions are amounts due to participants for their contributions that exceeded contribution limitations of the Plan allowed by the IRS. As of December 31, 2024 and 2023, corrective distributions were \$33,392 and \$66,927, respectively, and were remitted to the participants prior to March 15 of the subsequent year.

2. Summary of Significant Accounting Policies

The following are the significant accounting policies followed by the Plan:

Basis of Accounting

The accounts of the Plan are maintained, and the accompanying financial statements have been prepared on the modified cash basis of accounting, which is a comprehensive basis of accounting other than generally accepted

accounting principles. Under the modified cash basis, the only assets recognized are investments, which are recorded at fair value and notes receivable from participants (including the related accrued but unpaid interest). Cash receipts and disbursements transactions are recognized when made. Contributions are recognized when received. Disbursements are recognized when paid. Accordingly, the financial statements are not intended to present the net assets available for benefits and changes in net assets available for benefits of the Plan in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (exit price). The Plan's administrator determines the Plan's investment policies utilizing information provided by the investment advisors and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants (participant loans for Form 5500 reporting purposes) are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit distribution is recorded, based upon the terms of the Plan document.

Contributions

Contributions from Plan participants, discretionary matching contributions from the Company, if any, and nonelective profit sharing contributions from the Company, if any, are recorded in the year in which the contributions are received by the trustee.

Payments of Benefits

Benefits are recorded when paid.

Administrative Expenses

All reasonable administrative expenses, including trustee and third-party administration fees necessary to operate and administer the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses of maintaining the Plan that are paid directly by the Company are excluded from these financial statements. A participant's account may be charged for expenses associated with a specific optional feature elected by that participant, and are included in administrative expenses. Certain investment related expenses are included in the net appreciation in fair value of investments.

3. Information Certified by Qualified Institution

The Plan administrator having determined that it is permissible in the circumstances elected to have the audits of the Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information included in the accompanying financial statements and ERISA-required supplemental schedule of assets (held at end of year) – modified cash basis was obtained or derived from information obtained by the Plan administrator and certified as complete and accurate by Reliance Trust Company

a qualified institution, in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

- Investments, at fair value, and notes receivable from participants, as shown in the statements of net assets available for benefits – modified cash basis as of December 31, 2024 and 2023.
- Investment activity, including net appreciation in fair value of investments, interest and dividend income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits – modified cash basis for the year ended December 31, 2024.
- The information for all mutual funds (registered investment companies), the collective investment trust, and participant loans listed in the schedule of assets (held at end of year) as of December 31, 2024, as shown in the ERISA-required supplemental schedule.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under the Financial Accounting Standards Board (“FASB”) Accounting Standards Codification are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The shares of mutual funds held by the Plan are deemed to be actively traded.

Collective investment trust: The collective investment trust is valued at the net asset value or equivalent based on units of the collective investment trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is generally based on the fair value of the underlying investments held by the collective investment trust less its liabilities. This practical expedient is not used when it is determined to be probable that collective investment trust will sell the investment for an amount different than the reported NAV.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan is applying the practical expedient as of December 31, 2024 and 2023 to its collective investment trust, the Reliance MetLife Stable Value Fund (the “Fund”). The investment objective is to seek to preserve principal and maintain a stable crediting rate that is responsive to changes in interest rates by investing in a group annuity contract issued by MetLife Insurance Company. Participants’ ownership of the collective investment trust is represented in units. Units are issued and redeemed daily at the collective investment trust’s current NAV. The collective investment trust allows for daily liquidity, with no additional days’ notice required for redemption for participant-initiated transactions. However, it is possible that these redemption rights may be restricted by the collective investment trust in the future in accordance with the underlying collective investment trust agreement. Due to the nature of the investments held by the collective investment trust, changes in market conditions and the economic environment may impact the NAV of the collective investment trust, and consequently, the fair value of the Plan’s interest in the collective investment trust. Furthermore, changes in the liquidity provisions of the collective investment trust may significantly impact the fair value of the Plan’s interest in the collective investment trust.

5. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in statements of net assets available for benefits – modified cash basis.

6. Related Party and Party-in-Interest Transactions

Plan investments include a collective investment trust managed by Reliance Trust Company, the trustee of the Plan. Certain fees are also paid to Automatic Data Processing (“ADP”), recordkeeper of the Plan. Additionally, for participants who have elected to take a participant loan, the loans are secured by the respective participant's account balance. Therefore, these transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA. Fees paid by the Plan amount to \$56,822 for the year ended December 31, 2024.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts, including any Company contributions in which they are not already vested.

8. Tax Status

Effective October 1, 2022, through the adoption of a pre-approved ADP defined contribution plan, the Plan was amended and restated. The IRS issued an opinion letter dated October 6, 2020, stating that the pre-approved ADP defined contribution plan document as then designed was in accordance with applicable Internal Revenue Code (“IRC”) requirements. Although the Plan has been amended since receiving the opinion letter, management of the Plan believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan, as amended, is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. While the accounts of the Plan are maintained and the accompanying financial statements have been prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America, the Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

9. Subsequent Events

Management evaluated subsequent events for the Plan through September 18, 2025, the date the financial statements were available to be issued.
