### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of Ocean Associates, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

### Note 1. Description of Plan

The following description of the Ocean Associates, Inc. 401(k) Plan (the "Plan") provides only general information. A complete description of the Plan is contained in the Plan Document which governs the operation of the Plan.

#### General

The Plan is a defined contribution plan pursuant to the provisions of Section 401(k) of the Internal Revenue Code (the Code) established for the benefit of all employees (participants) who have completed three months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. The legislation includes a vast array of provisional changes to retirement plans, effective in 2023 and 2024, and beyond.

#### Contributions

Each year, participants may contribute the maximum allowed by law of their pretax compensation. Participants who have attained the age of 50 before the end of the plan year are eligible to make additional catch-up contributions. Ocean Associates, Inc. (the Corporation) may decide to make a matching contribution to the Plan, although the Corporation is not required to make this contribution. Participants must make elective deferrals to the Plan to receive this matching contribution. The percentage of elective deferrals to be matched will be determined by the Corporation and allocated to participants at the end of the plan year. The Corporation may also decide to make a non-elective contribution to the Plan which will be allocated to all employees eligible to participate in the Plan. Participants may roll over contributions from other plans.

#### Participant Accounts

Each participant's account is credited with participant's contributions, Corporation's contributions and allocations of Plan earnings and charged with an allocation of administrative expenses. Plan earnings are allocated based on the participant's share of each investment. Participants direct the investment of their contributions into various investment options offered by the Plan. The investment options available to participants include registered investment companies (mutual funds) and common/collective trusts.

#### Vesting

Participants are immediately 100% vested in their contributions plus actual earnings thereon. Vesting in the Corporation's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after four years of credited service.

#### Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$83,462 and \$14,777 respectively. These accounts will be used to reduce future employer contributions and to pay Plan expenses. Also, employer contributions were reduced by \$13,949 and \$5,837 from forfeited non-vested accounts in 2024 and 2023, respectively.

#### Benefit Payments

The Plan provides for benefit payments upon termination, death, disability, age 59 1/2 in-service distributions or normal retirement at the age of 65, based on the vested balance in the participant's account. Hardship withdrawals and participant loans are also permitted if certain conditions are met as outlined in the Plan Document. Benefit payments are recorded when paid. There were no significant benefits payable to terminated participants who have withdrawn from the Plan as of December 31, 2024 or 2023.

### Note 1. Description of Plan (Concluded)

#### Notes Receivable – Participant Loans

Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account. The interest rate is the prime rate as published in the Wall Street Journal on the 14th of each month, plus two percentage points. Principal and interest is paid ratably through bi-weekly payroll deductions for a period not to exceed five years, unless for the purchase of a primary residence. Participants may have only one outstanding loan at any given time.

Notes receivable – participant loans are reported at their unpaid principal balances plus any accrued but unpaid interest.

### Note 2. Summary of Significant Accounting Policies

#### Basis of Accounting

The Plan's financial statements are prepared on the accrual basis in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

#### Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Shares of registered investment companies (mutual funds) are valued at quoted market prices. Units of the common/collective trusts investments are valued based on net asset value per share provided by the manager of the fund. Investment income consists primarily of net realized and unrealized appreciation in fair value of investments and interest and dividend income.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Corporation and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in the administrative expenses. Investment related expenses are included in net appreciation in the fair value of investments.

#### Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates and assumptions.

### Note 3. Income Tax Status

The Plan has adopted a prototype plan designed by Automatic Data Processing, Inc. (ADP). The prototype plan obtained its latest determination letter on October 6, 2020 in which the Internal Revenue Service stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (Code). The Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, no provision for income taxes has been included in the Plan's financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there is no audit in progress for any open tax period.

#### Note 3. Income Tax Status (Concluded)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize an adjustment to income if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The Company has analyzed the tax positions taken by the Plan, and is not aware of any uncertain tax positions that would require an adjustment to income or disclosure in the financial statements as of December 31, 2024 and 2023.

#### Note 4. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement* (ASC 820), establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of inputs other than quoted prices in an active market that are observable; and Level 3 inputs are unobservable and significant to the fair value measurement, and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits.

### Note 4. Fair Value Measurements (Concluded)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

#### Mutual Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. The mutual funds held by the Plan are deemed to be actively traded.

#### Common Collective Trusts

Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.
