SCOPE AND NATURE OF THE ERISA SECTION 103(a)(3)(C) AUDIT

We have performed audits of the accompanying financial statements of Forrester Construction Company 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. OPINION

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

BASIS FOR OPINION

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. NOTE A - DESCRIPTION OF PLAN

The following description of the Forrester Construction Company 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering all employees of Forrester Construction Company (the "Company") who are age eighteen or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - Participants were able to contribute up to 100% of eligible compensation to the Plan through July 31, 2024, beginning August 1, 2024 and for each subsequent plan year, the maximum allowable contribution is limited to 90% of eligible compensation, as defined in the Plan or such dollar limit established by the Internal Revenue Service. Participants may designate all or a portion of their contributions to be Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover.) Participants direct the investment of their contributions and Company matching contributions into various investment options offered by the Plan. In 2024 and 2023, the Company matched 50% of elective deferrals up to 5% of eligible compensation. The Company may also make profit sharing contributions to the Plan at its discretion. Profit sharing contributions are remitted in the year immediately following the Plan year to which they relate. The Company made a \$100,000 profit sharing contribution in 2023 for the 2022 Plan year.

Participant Accounts - Each participant's account is credited with the participant's contribution, the Company's matching contribution, the Company's profit sharing contribution and an allocation of Plan earnings. Investment earnings are allocated based on participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. Participants direct the investment of their accounts among available investment options.

Vesting - Participants are vested immediately in their contributions plus actual earnings or losses thereon. Vesting in the Company's matching contributions and profit sharing contribution plus actual earnings or losses thereon is based on years of credited service. Effective January 1, 2023, participants become 25% vested after the completion of one year of credited service earning 25% each year thereafter until becoming fully vested after four years of credited service.

Payment Of Benefits - A Plan participant or beneficiary may receive lump-sum distributions equal to the value of the participant's vested interest in his or her account through eligible in-service distributions, termination of services or under specific situations of financial hardship. Balances less than \$5,000 may be paid in lump-sum distributions without requiring participant approval.

Notes Receivable From Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear a fixed rate of interest at 5.25% to 10.5%, which is commensurate with local prevailing rates at the time the loan is originated. All loans must have a definite repayment schedule, which provides for principal and interest payments to be made ratably through payroll deductions over a period not to exceed five years, except for home loans that may be repaid over a reasonable period of time that may exceed five years. Notes receivables are measured at their unpaid principal balance plus any accrued but unpaid interest.

NOTE A - DESCRIPTION OF PLAN - CONTINUED

Forfeited Accounts - Forfeitures may be used to reduce employer contributions and to offset Plan expenses. At December 31, 2024 and 2023, the Plan had forfeited nonvested accounts totaling \$18,180 and \$73,378, respectively. During 2024 and 2023, the Plan applied \$61,608 and \$44,168, respectively, of forfeitures to reduce Plan expenses. The Plan utilized \$31,702 and \$0 for 2024 and 2023, respectively, to reduce employer contributions.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis Of Accounting - The financial statements of the Plan are prepared on the modified cash basis of accounting which differs from accounting principles generally accepted in the United States of America (US GAAP). Under this method, additions are required to be recognized when received and deductions to be recognized when paid.

Investment Valuation And Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell assets or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

See note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the modified cash basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use Of Estimates - The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Payment Of Benefits - Benefits are recorded when paid.

Notes Receivable From Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the modified cash basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Plan Expenses - The Company absorbs certain administrative expenses of the Plan. Expenses that are paid by the Company are excluded from the Plan's financial statements. Fees related to the administration of notes receivable from participants and distributions from the Plan are charged directly to the participants' account and are included in administrative expenses.

Subsequent Events - The Plan evaluates the events and transactions occurring subsequent to the date of the financial statements for matters requiring recognition or disclosure in the financial statements. The accompanying financial statements consider events through September 29, 2025, the date the financial statements were available to be issued.

NOTE C - INVESTMENTS

All information on investments and notes receivable from participants included in the accompanying financial statements and schedule was obtained or derived from information certified as complete and accurate by the consecutive custodians, ADP Retirement Trust Services, LLP (ADP) for the period August 1, 2024 through December 31, 2024 and John Hancock Trust Company, LLC (John Hancock) for the period January 1, 2023 through July 31, 2024.

NOTE D - FAIR VALUE MEASUREMENTS

The Plan applies generally accepted accounting principles to establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under generally accepted accounting principles are described as follows:

- Level 1 – inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2 – inputs to the valuation methodology include quoted prices for identical or similar assets and liabilities in active or inactive markets; inputs that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3 – inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's categorization within the valuation hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

Money Market Funds - Valued at cost which approximates fair value.

Registered Investment Companies (Mutual Funds) - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested.

NOTE F - TAX STATUS

The Company adopted a prototype standardized profit-sharing plan that obtained an opinion letter dated October 6, 2020, in which the IRS stated that the prototype plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan administrator timely adopted the prototype plan. Although the Plan has been restated since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore believes that the Plan is qualified.

NOTE G - RISKS AND UNCERTAINTIES

The Plan's investments include financial instruments which are exposed to various risks such as interest rate, market and credit. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of financial instruments will occur in the near term that could materially affect the participants' account balances, and the amounts reported in the accompanying financial statements.

NOTE H - PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by ADP from August 1, 2024 onward. ADP is the custodian as defined by the Plan and, therefore, qualifies as a party-in-interest. Fees paid by the Plan to ADP were \$7,116 during 2024.

Certain Plan investments were managed by John Hancock from January 1, 2023 through July 31, 2024. Through that date, John Hancock was the custodian as defined by the Plan and, therefore, qualified as a party-in-interest. Fees paid by the Plan to John Hancock were \$11,824 and \$23,325 during 2024 and 2023, respectively.

Certain participants of the Plan have outstanding loans with the Plan at December 31, 2024 and 2023. These loans are considered party-in-interest transactions according to the Department of Labor guidelines. Total outstanding loans as of December 31, 2024 and 2023 were \$147,908 and \$113,048, respectively.
