Notes to Financial Statements

1. Description of the Plan

The following description of the MG Building Materials, Ltd. 401(k) Profit Sharing Plan & Trust (the Plan) provides only general information. Participants should refer to the Plan Document or Summary Plan Description for a more complete description of the Plan's provisions.

General

The Plan is sponsored by Grothues Brothers Holdings, Ltd. (the Employer) for its employees. The Plan is designed to comply with the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA), and the Internal Revenue Code (IRC). The trustee of the Plan's assets is Reliance Trust Company (the Trustee). ADP Retirement Services (ADP) serves as the Plan's recordkeeper.

Eligibility

All employees of the Employer who have completed at least one-half year of service and who are of age 21 or older are eligible to participate in the Plan, except for union employees, non-resident aliens, and any IRC 410(b)(6)(c) employees during the transaction period.

Participant Contributions

Participating employees may elect to contribute up to 50% of their compensation to the Plan, subject to the maximum dollar amount allowable under the IRC. Participants may contribute any percentage of their annual wages before bonuses. Additionally, participants are allowed to make rollover contributions from certain tax-qualified retirement plans. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions of up to IRC limits.

Employer Contributions

The Employer makes matching contribution of 100% of salary deferrals up to 3% of each participant's base salary. The Employer may also contribute a discretionary amount to the Plan annually as determined by the board of directors. There was no discretionary contribution made in 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Employer's contributions, earnings, or losses and may be charged with certain administrative expenses. Plan earnings or losses are applied to a participant's account balance based on the investment experience of the funds held and the number of shares owned in each fund by the participant.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings or losses thereon. Vesting in the Employer's matching and discretionary contributions plus actual earnings or losses thereon is based on continuous years of service as follows:

Upon death or disability, the participant (their beneficiary in case of their death) becomes 100% vested in the Plan. Upon reaching normal retirement age or after four years in the Plan, the participant becomes 100% vested in the Plan.

Excess Contributions Payable

Excess contributions payable relate to amounts payable to certain active participants to return to them excess deferral contributions required to satisfy relevant nondiscrimination provisions of the Plan. The Plan had no excess contributions payable as of December 31, 2024 and \$27,000 of excess contributions payable as of December 31, 2023.

Payment of Benefits

The benefit to which a participant is entitled equals the value of the participant's vested interest in his or her account. Upon death, disability, severance, or retirement, a participant may elect to receive a lump-sum payment equal to the vested portion of his or her account in accordance with provisions specified in the Plan. Upon termination of employment, vested account balances of less than \$5,000 may be distributed in a lump sum or rolled over to another qualified plan or an Individual Retirement Account or annuity for the benefit of the participant. Account balances less than \$1,000 are distributed as a lump-sum distribution.

Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$11,700 and \$8,400, respectively. These accounts may be used to pay administrative expenses and reduce future employer contributions. \$4,734 of the forfeited funds were used to fund employer contributions in 2024.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years. If the purpose of the loan is to acquire or construct the primary residence of the participant, the repayment period may exceed five years. The loans are secured by the balance in the participant's account and bear interest at rates determined by the Plan administrator, currently from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

Administrative Expenses

Administrative expenses are generally paid by the Employer. However, the Plan may pay transaction fees, which are allocated to the specific participants initiating the transactions.

2. Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Employer determines the Plan's valuation policies utilizing information provided by its custodians. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits paid to participants are recorded as a reduction of net assets available for benefits when paid.

3. Certified Investment Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net

appreciation in fair value of investments, interest and dividend income, and interest income on notes receivable from participants for the year ended December 31, 2024 was obtained by management and agreed to or derived from information certified as complete and accurate by the Trustee, a qualified institution.

At the request of the Plan administrator, the Plan's independent auditors did not perform audit procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information in the financial statements, including reading the disclosures related to the investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP, and, in the ERISA-required supplemental schedule, including assessing whether the ERISA-required supplemental schedule is in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

4. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodology used at December 31, 2024 or 2023. The following is a description of the valuation methodology used for assets measured at fair value:

Mutual Funds - The fair value of mutual fund investments is determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Related Party and Party-in-Interest Transactions

Certain Plan investments are in funds and accounts that are managed by the Trustee. Participant loan and distribution processing fees are paid by participants. The Plan also issues loans to participants that are secured by the vested balance of the participants' accounts. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

6. Risks and Uncertainties

The Plan holds various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.

7. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

Notes to Financial Statements

8. Tax Status

The Plan adopted a prototype plan document sponsored by ADP. ADP received an opinion letter from the Internal Revenue Service (IRS), dated October 6, 2020, which states that the prototype document satisfies the applicable requirements of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRS. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.
