NOTES TO FINANCIAL STATEMENTS

The Arms Trucking Co. 401(k) Plan

1 Description of Plan

The following description of The Arms Trucking Co. 401(k) Plan provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan covering all employees of The Arms Trucking Co., Arms Dock, Inc. and KRK Mack 2018, LLC dba Kronks Garage (hereinafter collectively referenced to as the "Company") who meet the age requirements. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Effective June 30, 2022, the Plan was restated in order to comply with IRS legislative and regulatory requirements.

Eligibility:

All employees of the Company age twenty-one and older and who are employed for two months are eligible to participate in the Plan. Effective April 1, 2023, the Plan was amended to decrease the age of eligible employees to eighteen years of age.

Contributions:

Employee Contributions - Participants may elect a portion of their compensation to be contributed to the Plan by the Company. A participant's elective deferrals must be between 1% and 90% of their compensation.

Employees who have completed two months of service are automatically enrolled in the Plan with a deferral withholding rate of 4%. Participants have the ability to opt out of the Plan prior to automatic enrollment. The automatic salary deferral amount will increase by 1% per Plan year up to a maximum of 10% of eligible compensation, as defined by the Plan.

Employer Discretionary Matching Contributions - The Company may make contributions to each eligible participant's account by matching a percentage of the Participant's elective deferral for the Plan year. For the years ended December 31, 2024 and 2023, the Company made matching contributions equal to 50% of the participant's deferral, up to 4% of the participant's compensation.

Rollover contributions from other Plans are also accepted, providing certain specified conditions are met.

Contributions are subject to limitations on annual additions and other limitations imposed by the Internal Revenue Code, as defined in the Plan document.

Participants' Accounts:

Each participant's account is credited with the participant's elective contributions, employer discretionary matching contributions, earnings and losses thereon.

1 Description of Plan, Continued

Vesting:

All participants are 100% vested in elective deferrals and rollover contributions made to the Plan.

Vesting in the participant's employer discretionary contributions is based on years of service. A participant is vested as follows:

Years of Service	Vested %
2	20%
3	40%
4	60%
5	80%
6	100%

Forfeitures:

Forfeitures due to termination from the Plan before a participant is 100% vested may be used to pay reasonable Plan expenses or be allocated to remaining participants in the same manner as the employer's discretionary contributions. Forfeitures for the years ended December 31, 2024 and 2023 were \$6,255 and \$5,973, respectively.

Notes Receivable from Participants:

Loans are permitted under certain circumstances and are subject to limitations. Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loans are repaid over a period not to exceed five years with exceptions for the purchase of a primary residence. Loans are valued at unpaid principal plus accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan document.

The loans are secured by the balance in the participant's account and bear interest at rates established by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

Other Plan Provisions:

Normal retirement age is 65. The Plan also provides for early payment of benefits after reaching age 59-1/2.

Payment of Benefits:

Upon termination of service by reason of separation of retirement, death or total and permanent disability, a participant receives a lump sum amount equal to the value of his or her account.

Hardship Withdrawals:

Hardship withdrawals are permitted in accordance with Internal Revenue Service guidelines.

Investment Options:

Upon enrollment in the Plan, a participant may direct any contributions to any of the investment options offered by the Plan.

2 Summary of Significant Accounting Policies

Basis of Accounting:

The Plan's transactions are reported on the accrual basis of accounting.

Valuation of Investments:

Investments are stated at fair value. Marketable securities are reported at fair market value as of the balance sheet date. Fair market values represent quoted market prices or, if quoted market prices are not available, estimated fair values as determined by the Plan's investment broker. The fair value of the Common Collective Trust is valued based on the unit value of the fund.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net unrealized/realized appreciation (depreciation) includes the Plan's gains and losses on investments purchased and sold as held during the year.

Use of Estimates:

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

Administrative Fees:

The Plan will generally pay the expenses of the Plan administration, however, some of the Plan administration expenses may be paid by the Company.

Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

Risks and Uncertainties:

The Plan's investments includes investments in Mutual Funds and a Common Collective Trust with varying degrees of risk, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the Statement of Net Assets Available for Plan Benefits.

Contributions:

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Subsequent Events:

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements.

Subsequent events have been evaluated through September 25, 2025, which is the date the financial statements were available to be issued.

3 Tax Status

On October 6, 2020, the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended, however, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more-likely-than-not would not be sustained upon examination by applicable taxing authorities.

The Plan Administrator has analyzed tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. However, currently no audits for any tax periods are in progress.

NOTES TO FINANCIAL STATEMENTS

The Arms Trucking Co. 401(k) Plan

4 Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- * Quoted prices for similar assets or liabilities in active markets.
- * Quoted prices for identical or similar assets or liabilities in inactive markets.
- * Inputs other than quoted prices that are observable for the asset or liability.
- * Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs that are unobservable inputs for the asset or liability.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds:

The fair values of the mutual funds are based on quoted market prices. The mutual funds are classified in the Level 1 category of the valuation hierarchy.

Common Collective Trust:

The fair value of the Common Collective Trust (“Federated Capital Preservation Fund”) is based on the underlying assets of the contracts which include a portfolio of securities and wrapper contracts. The value is expressed in units. The Common Collective Trust is valued based on using NAV as the practical expedient.

Participant transactions (purchases and sales) may occur daily. The Plan is required to provide twelve months advance notice in order to initiate a full redemption of the Common Collective Trust.
