### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed an audit of the financial statements of Lowcountry Grocers LLC Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Lowcountry Grocers LLC Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

### 1. Description of Plan

The following description of Lowcountry Grocers LLC Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering substantially all employees of Lowcountry Grocers LLC (the "Company") who are age twenty-one or older and have completed one year of eligible service. Leased employees, union employees and employees who are non-resident aliens are not permitted to participate in the Plan. Participants may enter the Plan on the first day of the quarter after which the participant meets the Plan's eligibility requirements. The plan document has been amended to recognize prior service credit for employees of newly acquired locations. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). The Plan is administered by the Retirement Plan Committee of the Company. The Retirement Plan Committee of the Company acts as trustee and is responsible for the custody and management of the Plan's assets.

#### **Contributions**

Each year, participants may contribute an elected amount of pretax annual compensation, as defined in the Plan. Additionally, participants may elect to make after-tax Roth contributions to the Plan. Participants who are age fifty or older by the end of the year are eligible to make an additional catch-up contribution to the Plan. With the Trustee's consent, participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover contributions).

The Plan contains an automatic enrollment provision. Upon meeting the Plan's eligibility requirements, participant contributions are automatically started at an initial contribution rate of three percent of eligible compensation. The Plan does not have an auto-escalation provision once a participant is automatically enrolled into the Plan.

The Company may provide a discretionary matching contribution dependent on the Company's operating results. Company contributions are invested into the investment options elected by the participant. The Company has elected not to make any discretionary contributions since the inception of the Plan.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of the Company's contribution and Plan earnings and charged with an allocation of administrative expenses. Allocations of Company's contributions are based on a match of participant deferral contributions. Allocations of Plan earnings and administrative expenses are based on account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants are immediately vested in their elective contributions plus actual earnings thereon. Vesting in the Company's discretionary contribution plus actual earnings thereon is based on years of credited service. A participant vests according to the following schedule:

<u>Years of Service</u>	<u>Vesting Percentage</u>
Less than two years	0%
More than two years, less than three years	20%
More than three years, less than four years	40%
More than four years, less than five years	60%
More than five years, less than six years	80%
More than six years	100%

### **Investment Options**

Upon enrollment in the Plan, a participant may direct employee contributions and employer matching contributions into any of the available investment options offered under the Plan. The Plan currently offers various mutual funds, a money market account and a common collective trust fund as investment options for participants. Participants may change their investment options as often as permitted under the investment vehicles chosen by the participant.

### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Participant loans are valued at their unpaid principal balances, plus all accrued but unpaid interest. The loans are secured by the balance in the participant's account and bear interest at prime rate plus 1%. Principal and interest is paid ratably through weekly payroll deductions. The Plan only allows loans that meet established Safe Harbor hardship criteria.

### **Payment of Benefits**

On retirement, death, disability, or termination of service, a participant (or participant's beneficiary in the event of death) receives a lump sum distribution equal to the participant's vested account balance. Hardship distributions are permitted if certain criteria are met.

### **Forfeitures**

There have been no employer contributions into the plan; therefore, there have been no forfeitures of participant account balances.

### **Unallocated Asset Holdings**

As of December 31, 2024 and 2023, there are \$1,778 and \$1,710, respectively, of unallocated asset holdings. These amounts represent uncashed checks for distributions to plan participants that have been returned to the Plan. These funds originate from vested participant account balances and are not available for general plan use.

### 2. Summary of Significant Accounting Policies

#### **Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting.

#### **Use of Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustees determine the Plan's valuation policies utilizing information provided by the Plan's investment advisors and custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. Deemed distributed loans continue to be reported in the Plan's financial statements until the participant has reached a distributable event.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Administrative Expenses**

Certain expenses incurred in connection with the general administration of the Plan are paid by the Plan and are recorded in the accompanying statement of changes in net assets available for benefits as administrative expenses. Expenses of maintaining the Plan that are paid directly by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation of fair value of investments.

#### **Subsequent Events**

The Plan has evaluated subsequent events through September 16, 2025, the date the financial statements were available to be issued.

#### **New Accounting Pronouncements**

On December 29, 2022, the SECURE 2.0 Act of 2022 was signed into law. This act contains provisions that go into effect at various times starting in the year 2023 and ending in 2033. The deadline for

adopting any required plan amendments pursuant to the SECURE 2.0 Act is December 31, 2026; however, plans must be operated in accordance with the effective date of each new provision. Management has reviewed the provisions effective for the 2024 year and continues to monitor and adjust operations in accordance with provisions as they become effective. As of December 31, 2024, no formal Plan amendments have been made to adopt SECURE 2.0 Act provisions. Management has determined that the Plan was in compliance with all applicable provisions for the year ended December 31, 2024.

### 3. Investment Information Certified by Custodian (Unaudited)

Empower Trust Company, LLC, (Empower) held plan assets on December 31, 2024 and 2023, and executed investment transactions from January 1, 2024 through December 31, 2024. The accompanying financial statements and supplemental schedule include the following unaudited information as of December 31, 2024 and 2023 and for the year ended December 31, 2024 that was obtained from data prepared and certified to be complete and accurate by Empower, the custodian:

### 4. Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

#### Basis of Fair Value Measurement

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2 Inputs to the valuation methodology include
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability; and
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment, and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

*Pooled Separate Accounts:* The Plan's assets are held in a group annuity unallocated contract offered as a pooled separate account (PSA). The underlying investments in the PSA consist of mutual funds and a common collective trust account/

*PSA - Mutual Funds:* The Plan's assets are held in a group annuity unallocated contract offered as a pooled separate account (PSA). The PSA invests in mutual funds that are valued based on the market value of the underlying net asset in each separate account. The majority of the underlying net assets have observable Level 1 and/or 2 quoted pricing inputs which are used to determine the unit value of the PSA which is not publicly quoted.

*PSA - Common Collective Trust Funds:* Valued at the NAV of units of a bank collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Common Collective Trust Funds

The common collective trust funds held by the Plan at December 31, 2024 and 2023 consist of the Wilmington Trust Index Select Funds. These Funds invest in other collective funds, investment contracts and securities, including MassMutual Stable Value Contract GIA, a stable value contract offered by Mass Mutual.

An investment contract is a contract issued by a financial institution to provide a stated rate of return to the buyer of the contract for a specified period of time. A security-backed contract has similar characteristics as a traditional investment contract and is comprised of two parts: the first part is a fixed-income security or portfolio of fixed-income securities; the second part is a contract value guarantee (wrapper) provided by a third party. Wrappers provide contract value payments for certain participant-initiated withdrawals and transfers, a floor crediting rate, and return of fully accrued contract value at maturity.

### 6. Fixed Interest Investments

As of December 31, 2024 and 2023, the Plan held \$2,364 and \$2,392, respectively, of fixed interest investments under an Agreement with Mass Mutual. The Fixed Interest Account, backed by Mass Mutual's general assets, is designed to provide stable, long-term investment growth. The diversified portfolio is composed primarily of high-quality, fixed-income investments including public bonds, private placements, commercial mortgage loans and short-term investments. Investments are made using a conservative approach by matching assets to liabilities.

Participants are guaranteed preservation of principle and a stated rate of return regardless of economic events while their investment is active. The guaranteed interest rate is determined in advance thus allowing plan sponsors and participants to make informed decisions regarding current allocations of their investment holdings.

Participants' accounts invested in the Fixed Interest Account are available for participant-initiated transactions at book value, including transfers to other investment options, loans and distributions in the event of hardship and upon a participant's retirement, death, disability and certain separations from service. Because these participant-initiated transactions occur at book value, participants' investments are not subject to changes in value due to market conditions. Mass Mutual backs its commitments with its own surplus and capital.

If the Agreement is fully or partially terminated, participants will receive the liquidation value of the Fixed Interest Account instead of the book value. The liquidation value is determined in accordance with a formula contained in the Agreement, which is designed to reflect the value of the assets in the account.

The liquidation value may be more or less than the book value of the plan's investments in the account. This means that upon partial or full termination of the Agreement, a participant's account balance in the Fixed Interest Account may be either increased or decreased.

The MassMutual Fixed Income Account is fully-benefit responsive and has been reported in the Statement of Net Assets Available for Benefits at contract value. A reconciliation of fair value to contract value at December 31, 2024 and 2023 is as follows:

### 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the plan to discontinue its contributions at any time and to terminate the plan, subject to plan provisions and ERISA. In the event of plan termination, participants would become 100% vested in the company contributions portion of their account.

### 8. Related Party Transactions

The Company performs certain administrative functions for the Plan for which no fees are charged. Additionally, the Company pays directly any administrative fees not paid from Plan assets.

### 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the individual participant account statements and the statement of net assets available for benefits.

### 10. Prohibited Transactions – Delinquent Participant Contributions

For the plan years ended December 31, 2024 and 2023, the Company failed to remit participant deferral contributions and loan repayments totaling \$12,567 and \$1,547, respectively, to the Plan within the time limit required by the Department of Labor, representing a nonexempt loan of funds to the Company from the Plan. These untimely remittances constitute prohibited transactions between the Company and the Plan. The 2023 delinquent contributions were remitted to the plan in 2024. The Company is currently working with the Plan's third-party service provider to correct the 2024 deficiency by filing a Form 5330 for the late remittances and remitting lost earnings to the Plan. Plan management does not believe that the resolution and correction of this matter will have a negative impact on the Plan's qualified tax status.

### 11. Tax Status

The Plan is a volume Submitter 401(k)/Profit Sharing Plan offered by My Benefits, LLC. The Internal Revenue Service issued an opinion letter dated June 30, 2020, indicating that the plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the plan has been amended since receipt of the opinion, letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the plan is qualified and tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the notes to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject income tax examinations for years prior to 2021.

### 12. 5500 Reconciliation

The financial statements have been prepared on the accrual basis of accounting. As such, they include the accrual of certain expenses that are presented in the Form 5500 filing in the year paid and the accrual of contributions that are presented in the Form 5500 filing in the year received. Additionally, the financial statements include outstanding participant loans that have been deemed for income tax reporting purposes for participants who have not yet incurred a distributable event.
