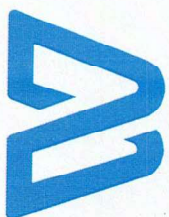

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Farmer Boy Ag, Inc. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 2 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year from issuance.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. NOTES TO FINANCIAL STATEMENTS YEARS ENDED DECEMBER 31, 2024 AND 2023

1. Description of the Plan and summary of significant accounting policies:

The following description of the Farmer Boy Ag, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan covering all employees of Farmer Boy Ag, Inc. (the Employer). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility and enrollment:

Employees are eligible to participate after one year of service and who have attained the age of 18 or older. All eligible employees are automatically enrolled in the Plan, when they become eligible, at a pretax contribution rate of 4%. Participants may waive their right to participate during a reasonable time period before their enrollment date or during the first 60 days after their participation date, and the value of the participant contribution account will be returned to the participant.

Contributions:

Each year, participants may contribute a percentage of their pretax annual compensation, as defined in the Plan, up to the maximum allowable under the Internal Revenue Code (IRC). Participants may designate all or a portion of their contribution as a Roth contribution. Participants who attain age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions and employer contributions into various investment options offered by the Plan.

After one year of service, the Employer contributes a 25% match for the first 4% that the participant contributes to the Plan. Additional profit sharing amounts may be contributed at the option of the Employer's board of directors. Profit sharing in the amount of \$1,110,000 and \$1,000,000 was reported as an Employer receivable in 2024 and 2023, respectively.

Participant accounts:

Each participant's account is credited with the participant's contribution and allocations of the Employer's contributions and Plan earnings and is charged with an allocation of Plan losses and expenses. Allocations are based on the participant's earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are vested immediately in their contributions, plus earnings thereon. The Employer's contribution portion of their accounts, plus earnings thereon, vests over a six-year period becoming 20% vested after two years of credited service and increasing 20% per year of service thereafter.

1. Description of the Plan and summary of significant accounting policies (continued):

Notes receivable from participants:

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 minus the difference between the highest outstanding balance of loans in the past 12 months and the outstanding balance of loans from the Plan on the date the loan is made, or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest between 4.24% to 8.74% at December 31, 2024, which is commensurate with local prevailing rates as determined at the time of the loan by the Plan administrator. Principal and interest are paid ratably through weekly payroll deductions. Repayment terms range from one to five years or greater for the purchase of a primary residence.

Notes receivable from participants are measured at the unpaid principal balance, plus unpaid accrued interest. The Plan classifies all participant loans with no payments received for six months as in default. Defaulted loans are deemed distributed and recorded as benefits paid to participants in the statement of changes in net assets available for benefits. During 2024, there were no loans recorded as deemed distributions.

Payment of benefits:

Upon termination of service, death, disability or retirement, a participant may elect to receive the value of the vested interest in his or her account as a lump-sum distribution, installment payments, a life annuity or a joint and survivor annuity. Additionally, under certain circumstances of financial hardship, the participant is allowed to withdraw funds from the Plan. Account balances that are under \$1,000 may be automatically paid out at the discretion of the Employer. Balances between \$1,000 and \$5,000 may be transferred to an Individual Retirement Account, also at the discretion of the Employer.

Forfeiture account:

The forfeited non-vested account balance totaled \$27,927 and \$21,491 at December 31, 2024 and 2023, respectively. Forfeited account balances are used to reduce future Employer contributions, as defined in the Plan. Forfeitures of \$21,491 were used during the year ended December 31, 2024.

Administrative expenses:

The Plan generally pays all administrative fees, as prescribed in the Plan document and service agreements.

Basis of accounting:

The accompanying financial statements have been prepared under the accrual method of accounting, in accordance with accounting principles generally accepted in the United States of America.

Investment valuation and income recognition:

The Plan's investments are valued at fair value. Investments in mutual funds and common stocks are valued at quoted market price, which is available on the active market.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

1. Description of the Plan and summary of significant accounting policies (continued):

Investment valuation and income recognition:

The net appreciation (depreciation) in the fair value of the Plan's investments, included in the statement of changes in net assets available for benefits, consists of the realized gains or losses and the unrealized appreciation (depreciation) on investments.

Payment of benefits:

Benefit payments to participants are recorded when paid.

Use of estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

2. Certification of Plan assets and transactions:

The Plan's cash, including interest-bearing cash, and investments are held by Matrix Trust Company, the Custodian. Investment information disclosed in the accompanying financial statements and schedule of assets held at end of year, specifically cash and investments held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, investment income, and dividends, for the year ended December 31, 2024 was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by the Custodian.

3. Fair value measurements:

The Plan ranks investments required to be reported at fair value in a three-level hierarchy for fair value measurements based upon the transparency of inputs to the valuation of an asset. Inputs may be observable or unobservable and refer broadly to the assumptions that market participants would use in pricing the asset. Observable inputs reflect the assumptions market participants would use in pricing the asset based on market data obtained from sources independent of the reporting entity. Unobservable inputs reflect the Plan's own assumptions about the assumptions that market participants would use in pricing the asset developed based on the best information available in the circumstances. The three levels of the fair value hierarchy are described below:

Level 1 – Quoted prices in active markets for identical investment.

Level 2 – Other significant observable inputs (including quoted prices for similar investments, interest, rates, prepayment speeds, credit risk, etc.). The Plan does not hold any Level 2 investments.

Level 3 – Significant unobservable inputs (including the Plan's own assumptions in determining the fair value of investments). The Plan does not hold any Level 3 investments.

4. Related party and party-in-interest transactions:

Plan investments are managed by Fulton Bank, N.A./Fulton Financial Advisors Division, another division of Fulton Bank, N.A. who serves as the Trustee as defined by the Plan; and therefore, these transactions qualify as party-in-interest transactions. Fulton Bank, N.A./Fulton Financial Advisors Division Retirement Services applies the Plan's mutual fund revenue sharing earned as a reduction of the Plan's expenses. Fees amounting to \$79,036 were paid by the Plan for the investment management and administration services.

5. Risks and uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities could occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

6. Plan termination:

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

7. Tax status:

Effective July 1, 2022, the Plan was restated by executing a Non-Standardized Pre-Approved Profit Sharing Plan with CODA through Fulton Bank. The prototype plan sponsor has obtained an opinion letter dated June 30, 2020, in which the Internal Revenue Service (IRS) stated that the restated prototype plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan Administrator believes that the Plan is qualified and the related trust is tax exempt.

8. Concentrations:

Four investments accounted for approximately 52% and four investments accounted for approximately 53% of investments at December 31, 2024 and December 31, 2023, respectively.

9. Subsequent events:

The Plan has evaluated subsequent events through September 2, 2025, the date which the financial statements were available to be issued.
