### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Don Franklin Auto 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from Transamerica Financial Life Insurance Company, Inc. as of December 31, 2024 and for the period from April 5, 2024 to December 31, 2024, and Matrix Trust Company as of December 31, 2023 and for the period from January 1, 2024 to April 4, 2024 stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

### **Basis for Opinion**

NOTE 1 - DESCRIPTION OF PLAN

The following description of the (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

*General* - The Plan is a defined contribution plan subject to the provision of the Employee Retirement Income Security Act (ERISA). The Plan was effective and signed January 1, 2014, and has been amended and restated since inception. The Plan covers all full-time employers who have six months of service and are 21 years of age or older. Entry dates are semi-annually.

*Plan Sponsor* - The Plan is a multiple-employer plan sponsored by Franklin Management Company, Inc. (the Company) and its related and controlled companies. The following companies are co-sponsors of the Plan:

*Contributions* - Subject to applicable limitations, each year participants may contribute up to 100% of pretax annual compensation before bonuses, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and an interest-bearing cash account.

*Profit Sharing* - The Company has determined that participants are eligible for profit-sharing contributions provided under the Plan by meeting the same eligibility requirements as described in the above paragraph. Each year the Company may make a discretionary profit-sharing contribution to the Plan which will be allocated to all eligible employees. No profit-sharing contributions were made for the years ended December 31, 2024 and 2023.

*Matching Contribution* - The Company, at its sole discretion, will determine if, and how much, it will contribute to an employer match for eligible participants. For the years ended December 31, 2024 and 2023, the Company matched 100% of participant elective deferrals up to 2% of compensation for employees meeting eligibility requirements for elective deferrals.

NOTE 1 - DESCRIPTION OF PLAN - continued

*Participant Accounts* - Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions and (b) plan earnings (losses), and charged with an allocation of any administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Accounts are adjusted daily for any change in the fair values of the account's investments. The participants may transfer existing assets between investment options.

*Vesting* - Participants are immediately vested in their voluntary contributions and are a subject to a five-year graded vesting schedule for their matching and profit-sharing contributions plus actual earnings thereon.

*Payment of Benefits* - On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount.

*Participant Investment Rollovers* - Participants are allowed to transfer or rollover funds into the Plan from other qualified plans.

*Notes Receivable from Participants* - The Plan does not allow for participant notes receivable.

*Forfeitures* - Forfeitures can be used to pay plan expenses or reduce employer contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$39,987 and \$113,052, respectively. During 2024 and 2023, employer contributions were reduced by \$131,424 and \$0, respectively, from forfeited nonvested accounts.

*ERISA Account* - The Company has entered into an agreement with Transamerica Retirement Solutions Corporation ("TRS"), an affiliate of Transamerica Financial Life Insurance Company Inc. ("TFLIC"), to create a Plan expense account ("ERISA Account") to hold revenue sharing funds the Plan receives from TRS pursuant to an agreement. These funds are available to pay qualified Plan administrative expenses or may be reallocated to Plan participants. The amount credited to the ERISA Account is determined on a monthly basis by TRS and is reported as other income on the statement of changes in net assets available for benefits. At December 31, 2024 and 2023, the ERISA Account balance was \$27,258 and \$0, respectively. The ERISA Account was used to pay Plan expenses totaling \$0 and \$0 during the years ended December 31, 2024 and 2023.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Date of Management's Review

Subsequent events were evaluated through September 8, 2025, which is the date the financial statements were available to be issued.

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Accordingly, actual results may differ from those estimates.

Basis of Accounting

The accounting records of the Plan are maintained on the accrual basis of accounting in accordance with generally accepted accounting principles in the United States of America.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Participants' contributions are recorded by the Plan as of the date such participants' elected contributions are withheld by the Company. Sponsor contributions are recorded by the Plan when committed by the Sponsor.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Fees for administration are included in administrative expenses and charged directly to the participants' accounts.

Excess Contributions Payable

Amounts payable from the Plan totaling \$58,061 and \$57,952 for 2024 and 2023, respectively, for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the excess contributions to the applicable participants and employers prior to March 15<sup>th</sup> of the following year.

NOTE 3 - UNAUDITED INFORMATION CERTIFIED BY TRUSTEE

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedules, including investments held at December 31, 2024 and 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Transamerica Financial Life Insurance Company, Inc. (TFLIC) and Matrix Trust Company (MTC), the trustees of the Plan. This information has not been audited by independent accountants.

NOTE 4 - FAIR VALUE MEASUREMENTS

FASB Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1- Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable value option: Valued at NAV as it is a readily determinable fair value and the basis for current transactions.

The methods described above may produce a fair value estimate that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain administrative expenses, indirect fees, and costs of the Plan are paid to TFLIC and MTC. TFLIC and MTC are the trustees as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 6 - INCOME TAX STATUS OF THE PLAN

The Plan uses a prototype plan document sponsored by CCH Incorporated which received an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. The prototype plan document has been amended since receiving the advisory opinion. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan has analyzed its tax positions taken and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan is subject to income tax examinations generally for three years after filing.

NOTE 7 - PLAN TERMINATION

Although it has not expressed any intent to do so, the plan sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan should be allocated to participant accounts and distributed in such a manner as the Company may determine.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan provides for various participant-directed investment options, which are exposed to various risks, such as interest rate, credit risks and market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the financial statements.

NOTE 9 – TRANSFERS

During 2024, the Company purchased LES Pinkham Lincoln Mercury which operated LES Pinkham Lincoln Mercury 401(k) Plan. That Plan filed a final Form 5500 ending May 31, 2024 and transferred total assets of \$623,922 into the Plan.
