Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of Katahdin Trust Company 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with U.S. GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Their report, dated September 9, 2024, indicated that in their opinion (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with U.S. GAAP, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2023 supplemental schedule, other than the information in the 2023 supplemental schedule that agrees to or is derived from the certified investment information, was presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, and the information in the 2023 supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. Description of Plan

The following description of Katahdin Trust Company 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by Katahdin Trust Company (the Bank). Substantially all full-time employees of the Bank may participate in the Plan. Employees are eligible to participate in the Plan immediately following their date of employment and may enter the Plan on the first day of each quarter during the Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may voluntarily contribute up to 100% of their annual compensation. Contributions are subject to certain limitations. The Bank makes safe harbor matching contributions of 100% of the first 3% of participant eligible compensation plus 50% of the next 2% of participant eligible compensation. The Bank may also contribute discretionary profit sharing and additional matching contributions. Participants must be employed by the Bank on the last day of the Plan year to receive discretionary profit sharing and additional matching contributions. The Bank did not contribute discretionary profit sharing or additional matching contributions in 2024. Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Bank's contributions, an allocation of Plan earnings and an allocation of administrative expenses. Plan earnings are allocated based upon participant account balances. Administrative expenses are allocated to participant accounts to the extent they are not paid by the Bank. In addition, administrative expenses are paid in part by the investment funds based on revenue sharing agreements between the Plan and investment funds.

Vesting

Participants are immediately vested in their contributions and safe harbor matching contributions plus actual earnings thereon. Discretionary profit sharing and additional matching contributions vest in 25% installments over a six-year period, with the 25% installments starting in year two.

Payment of Benefits

The Plan provides benefits to participants upon death, disability, retirement or termination of employment. The Plan also permits in-service distributions upon meeting age 59 1/2. The benefit to which a participant is entitled is limited to the vested benefit in their account. Unless otherwise directed by the participant, the Plan provides for the direct rollover to an Individual Retirement Account for participants with vested balances greater than \$1,000 and not more than \$5,000 and automatic lump-sum distributions for participants with vested balances of \$1,000 or less. Participant consent is required for distributions in excess of \$7,000. Participants are permitted to make hardship withdrawals from their account provided they meet certain criteria and the withdrawal is approved by the plan administrator.

Notes Receivable from Participants

Participants may also elect to borrow funds against their accounts. Loans made to a participant cannot exceed the lesser of (a) \$50,000 or (b) 50% of the participant's vested account balance. A participant may not request a loan of less than \$1,000 and may have no more than two outstanding loans at one time. The loan terms range from one to five years or up to ten years for the purchase of a primary residence and bear interest at prime rate plus 1%.

2. Summary of Significant Accounting Policies

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for discussion of fair value measurement.

Purchases and sales of securities are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan document. There were no notes receivable from participants as of December 31, 2024 and 2023.

Administrative Expenses

Certain administrative expenses are paid by the Plan, unless otherwise paid by the Bank.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

Management has considered transactions or events occurring through September 24, 2025, which is the date that the financial statements were available to be issued. Management has not evaluated subsequent events after that date for inclusion in the financial statements.

3. Income Tax Status

The Plan is part of a prototype plan designed by Empower Trust Company, LLC. The Internal Revenue Service has determined and informed Empower Trust Company, LLC by a letter dated June 30, 2020, that the prototype plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination; however, the plan administrator believes that the Plan is designed and currently operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

4. Information Prepared and Certified by the Trustee

The investments, investment transactions, net appreciation in fair value of investments, and interest and dividends were obtained by management and agreed to or derived from the information certified by Empower Trust Company, LLC, the trustee of the Plan, as complete and accurate. This information is included in the following:

- Statements of Net Assets Available for Benefits
- Statement of Changes in Net Assets Available for Benefits
- Schedule H, Line 4i - Schedule of Assets (Held at End of Year)

5. Party-In-Interest Transactions

Certain Plan investments are managed by CAPTRUST Financial Advisors, the investment advisor to the Plan. Administrative expenses of \$69,121 were paid by the Plan to CAPTRUST Financial Advisors for investment advisory services in 2024. Administrative expenses of \$36,089 were also paid by the Plan to Empower Annuity Insurance Company of America, an entity related to Empower Trust Company, LLC, for recordkeeping services in 2024. These transactions qualify as transactions with a party-in-interest.

6. Plan Termination

Although it has not expressed any intent to do so, the Bank has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. Fair Value Measurement

Financial Accounting Standards Board Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024 and 2023:

Mutual funds: Valued at the net asset value (NAV) of units held by the Plan at year-end.

Collective trust and stable value funds: Valued at fair value using the market approach based on the NAV obtained directly from the fund house or other investment provider. The collective trust funds require advance written notice of five business days for withdrawals which will exceed \$1 million or 10% of the assets invested in each collective trust fund.

Redemptions of the stable value fund may be made daily at the current NAV and are considered as made immediately after the daily valuation. Subject to certain restrictions, withdrawals from the stable value fund are generally permitted daily at contract value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
