INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of OTO Development 401K Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended December 31, 2024, and the related notes to the financial statements.

Basis for Opinion

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The supplemental schedules of Schedule H, Line 4i, Schedule of Assets (Held at End of Year), are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion

- the form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis of Accounting

We draw attention to Note B to the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

A. Description of Plan

The following description of the OTO Development 401K Plan provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

1. General. The Plan is a defined contribution plan covering substantially all full-time employees of OTO Development 401K Plan (the "Company") who have two months of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").
2. Contributions. Each year, participants may contribute up to 50 percent of pretax annual compensation, as limited each year by the Internal Revenue Service. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company can contribute a discretionary percentage of the salary reduction each participant elects to defer as determined each year by the Company. Additional amounts may be contributed at the discretion of the Company's board of directors.

Upon enrollment, a participant may direct contributions to any of the Plan's investment options. Participants may change their investment options daily. Participants are eligible to contribute elective deferrals after completing two (2) months of service. All contributions are invested in various pooled separate accounts or the guaranteed interest account offered by Ascensus Trust Company. Contributions are subject to certain limitations.

3. Participant Accounts. Each participant's account is credited with the participant's contribution, the Company's matching contribution, and all allocations of Plan earnings. Allocations are based on participant earnings as defined. Forfeited balances of terminated participants' nonvested accounts are used to reduce future Company contributions or pay administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

4. Vesting. Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100 percent vested after five years of credited service, at normal retirement age or death. Vesting percentages for participants that are terminated under circumstances that do not entitle them to the full vesting percentage under the Plan are listed below in the Vesting Schedule:

The matching contribution will be a Safe Harbor Matching contribution where the participants are 100% vested in the company’s matching contribution. The plan sponsor's employer contribution is 100% of the elective deferrals that do not exceed 5% of the employee's compensation.

5. Payment of Benefits. Upon qualification for benefits, a participant’s vested account balance will be distributed in a single lump sum, or in installment payments over a specified period of time.
6. Forfeitures. The plan provides for participant forfeitures to decrease the required Company contributions or pay administrative expenses of the plan. As of December 31, 2024 and 2023 forfeited nonvested accounts totaled \$29 and \$11,993, respectively. Additionally, the Plan did not utilize any forfeitures to reduce Company contributions during the year ended December 31, 2024.
7. Investment Options. Upon enrollment in the Plan, a participant may direct employee contributions in one percent increments in any of 30 investment options as provided for by Ascensus Trust Company.

B. Summary of Accounting Policies

1. **Basis of Accounting.** The financial statements of the Plan are prepared under the modified cash basis method of accounting. This basis differs from accounting principles generally accepted in the United States of America because the Plan has not recognized contributions receivable. Modified cash basis differs from cash basis because the investments are adjusted to fair value.
2. **Investments.** Quoted market prices are used to value investments at fair value. Guaranteed Investment Contracts are valued at the contract value at the date of purchase.
3. **Payment of Benefits.** Benefits are recorded when paid,
4. **Estimates.** The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.
5. **Date of Management's Review.** Subsequent events were evaluated through September 5, 2025, which is the date financial statements were available to be issued.

- C. **Investments.** The Plan's investments were held by Ascensus Trust Company (trustee) in certain investment funds. The investments are presented at the fair value and contract value as determined and certified by the trustees at quoted market prices and contract values.

During the year ended December 31, 2024 the Plan's investments (including investments bought, sold, held during the year) increased 3,750,722 per the certified trust statements.

- D. **Plan Termination.** Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan Termination, participants will become 100 percent vested.
- E. **Tax Status.** The Plan uses a prototype document sponsored by Ascensus LLC, which received an opinion letter from Internal Revenue Service dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the determination letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service or Department of Labor. The Plan is subject to

routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

- F. **Plan Administrative Expenses.** It is the policy of the Company to pay administrative expenses incurred by the Plan including, but not limited to, trustee fees and auditing fees.

- G. **Market Risk.** All of the assets held for investment are subject to market risk. There is no coverage under FDIC for any of the investments held by the Plan. Consequently, the solvency of the Plan is directly dependent on the continued solvency of the Plan's investments and the economic market.

- H. **Information Certified by Trustee.** In addition to the information contained in Note C, the trustees have certified, as being complete and accurate, all investment income that is reported.

I. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds – Valued at the net asset value (NAV) of shares held by the plan at year end.

Common/Collective Trust - The fair value of the investments in common/collective trusts (pooled) funds is determined by each fund's trustee based on the fair value of the underlying securities within the fund, which represent the net asset value of shares held by the Plan at year end. The investment in the trust is carried at fair value based on the closing price on NASDAQ. Unit values are determined by dividing the fund's net assets at fair value by its units outstanding at the valuation dates.

J. Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds managed by Ascensus Trust Company. Ascensus Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to \$99,769 and \$66,666 for the years ended December 31, 2024 and 2023, respectively. The fees are deducted from participants' account and presented net of investment gain or loss.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

K. Self-Correction Program

The plan sponsor inadvertently failed to properly allow for 2024 contributions and related Company matches for bonuses paid during 2024 due to a system error within the Plan Sponsor's payroll system. Ascensus, the Plan Administrator, completed calculations using the IRS pre-approved method as outlined in the Employee Plans Compliance Resolution System (EPCRS) and the appropriate contributions and Company match (along with estimated earnings) was made on July 23, 2025. A total of \$239,368 was credited to participant accounts, which included \$97,050 in missed deferrals and \$142,318 in safe harbor Company match. The Company has implemented the necessary measures to address the issue and ensure accuracy of future deferrals and related matching contributions associated with bonus payouts. This had no impact on the net assets available for benefits.
