Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Robertson Heating Supply Company 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 **and 2023**, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section -

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of

the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. 1. Description of the Plan

The following description of the Robertson Heating Supply Company 401(k) Profit Sharing Plan provides only general information. Participants should refer to the Plan agreement and summary plan description for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all full-time employees of Robertson Heating Supply Company of Ohio (the Plan Sponsor) except union members, leased employees and non-resident aliens who are age 21 or older and have six months of service. The Plan is subject to ERISA. The Plan's administrative committee oversees the governance of the Plan, the appropriateness of the Plan's investment offerings with significant input by the trustee and monitors investment performance.

Contributions

Each year, eligible employees may contribute up to 90% of pre-tax or post-tax (Roth) compensation, as defined in the Plan, up to the maximum dollar contribution allowed by law. Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions. All eligible participants are automatically enrolled in the Plan at a deferral rate of 3% upon their eligibility date. Participants may opt-out of automatic enrollment at any time. Participants may also contribute amounts representing distributions from other qualified retirement plans or individual retirement accounts.

Employer contributions includes discretionary matching and profit-sharing contributions. Participant contributions consist of pretax elective deferrals, after-tax contributions and rollover contributions.

The Plan Sponsor matching contribution is 50% of the first 5% of compensation that a participant contributes to the Plan. The Plan Sponsor made employer matching contributions of \$488,682 for the year ended December 31, 2024. The Plan Sponsor used forfeitures of \$731 to offset matching contributions during the year ended December 31, 2024. Additional profit-sharing amounts may be contributed at the option of the Plan Sponsor's board of directors. For the year ended December 31, 2024, the profit-sharing contribution was \$1,020,000. The Plan Sponsor used forfeitures of \$51,173 to offset matching contributions during the year ended December 31, 2024. All contributions are limited to the maximum allowed as a deduction under the Internal Revenue Code (IRC).

Participant Accounts

Each participant's account is credited with the participant's pre-tax, Roth and rollover contributions, the Plan Sponsor's matching and profit-sharing contributions and allocations of Plan earnings and charged with an allocation of administrative expenses. The allocation of earnings occurs through the appreciation or depreciation in the fair value of a participant's investment in each of the separate investment accounts as well as interest and dividend income. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All investments of the Plan are fully participant-directed.

Vesting

Each participant is immediately and fully vested in their contributions and employer match and earnings thereon. Vesting for employer's profit-sharing contributions is as follows:

Notes Receivable from Participants

Participants are permitted to obtain loans from the Plan. The minimum permitted loan amount is \$1,000 and the amount of any loan may not exceed 50% of the participant's vested account balance in the Plan up to \$50,000. The \$50,000 maximum loan amount is reduced by the highest loan balance during the past 12 months minus the loan balance on the date a new loan is made. Interest rates for participant loans range from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

A participant may elect to receive benefits distributed in one lump-sum or installments. Amounts credited to an individual's account are distributed at termination of employment as a lump-sum if it is less than \$5,000, known as minimum cash out. No such minimum cash out amounts were payable at December 31, 2024 and 2023. Non-terminated employees may make withdrawals from their elective deferral account balance as a hardship withdrawal prior to reaching normal retirement age. Hardship withdrawals are subject to additional rules and conditions as outlined in the Plan agreement.

Forfeitures

Forfeitures which occur pursuant to the Plan may be used at the discretion of the Plan Sponsor. Total forfeitures used to reduce matching contributions and profit-sharing contributions were \$51,904 during the year ended December 31, 2024. There were no forfeitures that reduced matching contributions or profit-sharing contributions during the year ended December 31, 2023. At December 31, 2024 and 2023, amounts from forfeited accounts totaled \$13 and \$30,668, respectively.

2. Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts in the financial statements and accompanying notes. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments held by a defined contribution plan are required to be reported at fair value, except for the fully benefit-responsive investment contract which is reported at contract value. Contract value is the relevant measurement attribute for the portion of the net assets available for benefits of a defined contribution plan attributable to the fully benefit-responsive investment contract because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Committee determines the Plan's valuation policies utilizing information provided by the investment adviser, trustee, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant does not make loan repayments and the plan administrator considers the participant note to be in default, the note balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on terms of the plan agreement.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Certain investment management and other administrative fees are paid directly by the Plan. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

3. Information Prepared and Certified by the Trustee

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedules including investments and notes receivable from participants held at December 31, 2024 and 2023, and investment income, interest from notes receivable, and benefit payments for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

4. Fair Value Measurements

The authoritative accounting guidance establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical

assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy per the authoritative accounting guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices that are observable for the asset or liability and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. Mutual funds held by the Plan at both December 31, 2024 and 2023 are Level 2 within the fair value hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Fully Benefit-Responsive Investment Contract

The Plan holds a synthetic investment contract. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions in accordance with the terms of the Plan. Contract value represents contributions made for each contract, plus earnings, less participant withdrawals, and administrative expenses.

The key difference between a synthetic investment contract and a traditional investment contract is that the Plan owns the underlying assets of the synthetic investment contract. A synthetic investment contract includes a wrapper contract, which is an agreement for the wrap issuer, such as a bank or insurance company, to make payments to the Plan in certain circumstances. The wrapper contract typically includes certain conditions and limitations on the underlying assets owned by the Plan. With traditional investment contracts, the Plan owns only the contract itself. Synthetic and traditional investment contracts are

designed to accrue interest based on crediting rates established by the contract issuers.

The synthetic investment contract held by the Plan includes a wrapper contract that provides a guarantee that the credit rate will not fall below 2.85%. Cash flow volatility (for example, timing of benefit payments) as well as asset underperformance can be passed through to the Plan through adjustments to future contract crediting rates. Formulas are provided in each contract that adjusts renewal crediting rates to recognize the difference between the fair value and the book value of the underlying assets. Crediting rates are reviewed monthly for resetting.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the IRC or the failure of the trust to be tax-exempt under Section 501(a) of the IRC
2. Premature termination of the contracts
3. Plan termination or merger
4. Changes to the Plan's prohibition on competing investment options
5. Bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants. In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured breach of the Plan's investment guidelines
2. A violation of a material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreements without the consent of the issuer

6. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in the employer contributions portion of their accounts.

7. Tax Status

The Internal Revenue Service (IRS) has determined that the prototype non-standardized profit-sharing plan with cash or deferred arrangement is designed in accordance with the applicable sections of the IRC and informed Fidelity Management Trust Company of such in a letter dated June 30, 2020. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of

the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

8. Transactions with Parties in Interest

Fidelity Management Trust Company, the trustee of the Plan, is a party in interest of the Plan as defined by ERISA Section 3(14) and accordingly, investment transactions in the respective funds are parties in interest transactions. Certain administrative expenses related to the Plan are paid by the Plan Sponsor. Additionally, the Plan pays another provider for investment advisory services which qualify as party in interest transactions. Other than as described above or pursuant to a trust agreement, the Plan has no agreements or transactions with any parties in interest.

9. Reconciliation to Form 5500

Deemed distributions are defaulted and unpaid participant loans of active participants that are disallowed on Form 5500. The following tables reconcile benefits paid to participants and changes in net assets available for benefits for the year ended December 31, 2024, per the financial statements to the Form 5500 as filed by the Plan for the year ended December 31, 2024.

10. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

11. Subsequent Events

The Plan Sponsor has evaluated subsequent events through September 24, 2025, which is the date the financial statements were available to be issued.

Effective January 1, 2025, the Plan Sponsor approved an amendment to the Plan to increase the automatic enrollment percentage for pre-tax contributions from 3% to 4% of eligible compensation for newly eligible participants.
