INDEPENDENT AUDITORS' REPORT

To the Trustees of Tri-Mack Plastics

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Tri-Mack Plastics Mfg Corp 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF THE PLAN

The following description of Tri-Mack Plastics Mfg Corp 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, covering all employees of Tri-Mack Plastics Manufacturing Corp. (the Company) after completing three consecutive months of service and attaining age twenty-one or older. Employees who are nonresident aliens as defined in the Plan agreement and leased employees are not eligible to participate in the Plan. Participants may enter the Plan on the first day of the month following the date of eligibility. The Plan is qualified under Section 401(k) of the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Automatic Enrollment

The Company has elected to utilize an automatic enrollment policy. Participants become automatically enrolled into the Plan, after meeting eligibility requirements, unless the eligible participant specifically opts out of the Plan. Participants are automatically enrolled in the Plan at 3% of their eligible compensation, as defined in the plan agreement.

Contributions

Each year, participants may voluntarily contribute up to 100% of pre-tax or after-tax (Roth) annual compensation, as defined in the plan agreement, not to exceed the dollar limitations as established by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the Plan year are also eligible to make catch-up contributions. Participants may also contribute amounts representing rollover contributions from other qualified defined benefit or defined contribution plans.

The Plan allows for a discretionary employer matching contribution in which eligible participants must complete a minimum of 1,000 hours of service and be employed by the Company on the last day of the Plan year. For the year ended December 31, 2024, the Company made a discretionary matching contribution equal to 50% of each participant's weekly contribution to the Plan, limited to a maximum of 50% of 8% of the participant's weekly gross salary.

The Plan allows in-plan Roth conversions under the current in-service withdrawal provisions, as defined in the plan agreement.

Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds as investment options for participants.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's matching contributions, (b) plan earnings and (c) advisory and loan fees of the Plan, if not paid by the Company. Allocations are based on participant compensation or account balances, as defined in the plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's discretionary matching contribution occurs in 20% increments, commencing upon the completion of one year of service, with 100% vesting after the completion of five years of service or permanent disability, normal retirement or death of the participant.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the participant's vested account balance and bear interest at rates that range from 3.25% to 8.50%, which are based on the prime rate at the time the loans were originated. Loans must be repaid over a period not to exceed five years unless the loan proceeds are used for the purchase of a primary residence, in which case a longer repayment period is allowed. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant, or their beneficiary, may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or a partial payment for voluntary distributions. Involuntary distributions to a participant, upon termination of employment, with an account balance of less than or equal to \$5,000 must elect a form of distribution allowed by the Plan otherwise the amount will be paid in a lump-sum.

Forfeited Accounts

Forfeited balances of terminated participants' nonvested accounts are first used to offset administrative expenses of the Plan then any remaining forfeitures shall be used to reduce employer contributions. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$24,300 and \$9,400, respectively. During 2024, no employer contributions were reduced by forfeited non-vested accounts.

Early Withdrawals

Prior to termination of employment, disability or death, upon written request to the plan administrator, participants may make in-service distributions from their accounts upon attainment of age 59 ½ or, in the event of a serious financial hardship, up to 100% of their vested account balance, as defined in the plan agreement. However, in-service distributions from employer matching contributions are permitted only in the case of a participant's disability.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by its investment advisor and Ascensus Trust Company (Ascensus), the Plan's Custodian. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought, sold and held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in advisory and loan fees. An allowance for credit losses has not been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants in 2025.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. The Plan pays for advisory and loan fees which are recorded as deductions in the accompanying statement of changes in net assets available for benefits.

3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan can access at the measurement date.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

4. PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor reserves the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, each participant becomes 100% vested in all Plan Sponsor contributions.

5. TRANSACTIONS WITH PARTIES-IN-INTEREST

Parties-in-interest are defined under Department of Labor (DOL) Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Ascensus is the custodian of the Plan and also provides recordkeeping services to the Plan under a separate recordkeeping service agreement. These transactions qualify as party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA. In addition, certain officers and employees of the Plan sponsor, who are also plan participants, perform administrative services on behalf of the Plan at no cost to the Plan.

6. TAX STATUS OF THE PLAN

The Plan has adopted a prototype plan sponsored by Ascensus. On June 30, 2020, the IRS stated that the prototype plan adopted by the Plan, as then designed, qualifies under Section 401(k) of the IRC. The Plan has not received a determination letter specific to the Plan itself; however, the plan administrator and the Plan's tax counsel believe that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than

not would not be sustained upon examination by the IRS or the DOL. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

7. PLAN FINANCIAL INFORMATION CERTIFIED BY CUSTODIAN

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Ascensus, the Custodian of the Plan.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

9. SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through September 29, 2025, the date the financial statements were available to be issued.

Plan Amendment

Effective February 21, 2025, the Plan was amended to allow participant loans from Roth deferrals, which were not previously permitted.
