## Independent Auditor's Report

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We were engaged to perform audits of the financial statements of WakeMed Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the years then ended and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023 and for the years then ended stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Disclaimer of Opinion**

We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matter described in the *Basis for Disclaimer of Opinion* section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

### **Basis for Disclaimer of Opinion**

As described in Note 7, because of the unavailability of the Plan's prior records with respect to certain investments, we were unable to perform auditing procedures with respect to individual participant account balances accumulated from inception of the Plan to satisfy ourselves as to the basis on which participants' equity is stated as of December 31, 2024 or the propriety of the distributions to participants who terminated and withdrew from the Plan during the year then ended.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

***Auditor's Responsibilities for the Audits of the Financial Statements***

However, because of the matter described in the *Basis for Disclaimer of Opinion* section of our report, we were not able to obtain sufficient appropriate evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits.

### Note 1 - Plan Description

The following description of WakeMed Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution 403(b) plan covering all employees of WakeMed (the "Company"), except leased employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

Eligible participants may contribute any portion of their salaries and wages to the Plan subject to maximum tax-deferred limitations established by the Internal Revenue Code. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Company may elect to make a qualified matching contribution and nonelective discretionary contribution to the Plan. The company matching contributions to the Plan equal 50 percent of the first 6 percent of compensation deferred by the participant up to 3 percent of a participant's compensation. The Company made a nonelective discretionary contribution of 3 percent of compensation for the years ended December 31, 2024 and 2023 to all employees of the Company.

#### **Benefit Payments**

Upon termination of employment, the participant or, in the case of death, the beneficiary, can elect to receive the participant's account balance in a single lump sum or in various installment annuities. Account balances less than \$5,000 are paid in a single lump sum upon termination. Participants may request that all or a portion of their accounts be distributed in the case of severe financial hardship, as defined in the plan document. The Company must approve any such hardship withdrawals.

#### **Vesting**

Participants are immediately 100 percent vested in employee salary and rollover contributions and any income or loss thereon. Vesting in the Company's contribution portion of their accounts, plus actual earnings thereon, is based on years of service. Participants vest in contributions made by the Company 100 percent after three years of service. Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, death, or permanent disability.

#### **Forfeitures**

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions. At December 31, 2024 and 2023, forfeited account balances totaled approximately \$548,900 and \$6,692,900, respectively. Approximately \$3,221,300 and \$510,100 of forfeitures were used to reduce company matching contributions for the years ended December 31, 2024 and 2023, respectively. Approximately \$6,507,100 and \$1,046,700 of forfeitures were used to reduce company nonelective discretionary contributions for the years ended December 31, 2024 and 2023, respectively.

#### **Participant Notes Receivable**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of 50 percent of their account balances. Notes receivable are collateralized by the participant's account balance and bear interest at a market rate.

### Note 1 - Plan Description (Continued)

#### ***Party-in-interest Transactions***

Certain plan assets are in investment funds managed by Variable Annuity Life Insurance Company, State Street Bank and Trust Company, Fidelity Management Trust Company, MassMutual Ascend Life Insurance Company, and Transamerica Financial Life Insurance Company (collectively, the "Custodians") or their affiliates. The Custodians are service providers of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

#### ***Termination***

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

### Note 2 - Summary of Significant Accounting Policies

#### ***Investment Valuation and Income Recognition***

Investments held by the Plan are stated at fair value except as noted below. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for further discussion of fair value measurements.

The fully benefit-responsive unallocated contracts, consisting of insurance company general accounts and a fixed annuity contract, are valued at contract value. Contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

#### ***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

#### ***Benefit Payments***

Benefits are recorded when paid.

#### ***Administrative Expenses***

Various administrative costs are paid by the Company.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

### Note 2 - Summary of Significant Accounting Policies (Continued)

#### *Risks and Uncertainties*

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

#### *Plan Loans*

Participants may borrow from MassMutual Ascend Life Insurance Company using their annuity contract account balances as collateral for the loan. Collateral is required in an amount equal to 110 percent of the outstanding loan balance. Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of the contract loan limit, Internal Revenue Code Section 72(p) limits, or plan loan limits. Loan terms range from 1 to 5 years or up to 30 years for the purchase of the participant's primary residence. Loans bear interest at a rate determined by Great American but in no event more than 8 percent. Principal and interest are paid ratably by the participant to the insurance company, and each payment will reduce amounts collateralized by the participant's annuity contract account balance. The amount of these outstanding loans was approximately \$300,000 and \$308,000 at December 31, 2024 and 2023, respectively. These loans are not included as assets in the accompanying financial statements.

#### *Subsequent Events*

The financial statements and related disclosures include evaluation of events up through and including September 29, 2025, which is the date the financial statements were available to be issued.

### Note 3 - Certified Information

Fidelity Management Trust Company, Variable Annuity Life Insurance Company, State Street Bank and Trust Company, MassMutual Ascend Life Insurance Company, and Transamerica Financial Life Insurance Company hold certain of the Plan's investments and participant notes receivable and execute certain related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Custodians.

### Note 4 - Tax Status

The Plan, as adopted, is a volume submitter plan, which does not require an application for a determination letter from the Internal Revenue Service (IRS). The volume submitter plan has received a favorable notification letter from the IRS.

### Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

#### *Level 1*

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

**Note 5 - Fair Value Measurements (Continued)**

***Level 2***

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

***Level 3***

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

***Mutual Funds***

Mutual funds are valued at quoted prices reported in active markets.

***Money Market Funds***

Money market funds are valued at quoted prices reported in active markets.

***Pooled Separate Account***

The pooled separate account is valued at net asset value per share (NAV) or its equivalent of the fund, which is based on the fair value of the fund's net underlying assets. There are no redemption restrictions or unfunded commitments on this investment.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 6 - Unallocated Insurance Contracts**

The Plan has benefit-responsive investment contracts with Variable Annuity Life Insurance Company (VALIC) and Transamerica Financial Life Insurance Company (TFLIC). The Plan is also invested in a fixed annuity contract with MassMutual Ascend Life Insurance Company (MassMutual). VALIC, TFLIC, and MassMutual maintain the contributions in general accounts. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuers are contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Interest is credited on contract balances using a single portfolio rate approach. Under this methodology, a single interest rate is applied to all contributions made to the product, regardless of the timing of those contributions. Interest crediting rates are reviewed on a semiannual basis for resetting. When establishing interest crediting rates for this product, VALIC, TFLIC, and MassMutual consider many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer's general account.

### Note 6 - Unallocated Insurance Contracts (Continued)

Certain events limit the ability of the Plan to transact at contract value with the insurance companies. Such events include the following: (i) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (ii) changes to the Plan's prohibition on competing investment options or deletion of equity wash provision, (iii) bankruptcy of the plan sponsor or other plan sponsor events (e.g., divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, (iv) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (v) premature termination of the contract. The plan administrator believes that the occurrence of any such events, which would limit the Plan's ability to transact at contract value with participants, is not probable. There are no events that allow the issuer to terminate the contracts and that require the plan sponsor to settle an amount different than contract value paid either within 90 days or over time.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Such events include (i) an uncured violation of the Plan's investment guidelines, (ii) a breach of material obligation under the contracts, (iii) a material misrepresentation, and (iv) a material amendment to the agreement without the consent of the issuers.

As described in Note 2, because the contracts are fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets attributable to the investment contracts. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

### Note 7 - Transfers in from Custodians

Prior to January 1, 2010, because of the unavailability of the Plan's prior year records with respect to certain investments, the Plan did not include certain insurance contracts with MassMutual Ascend Life Insurance Company in the Plan's net assets available for benefits. For the year ended December 31, 2010, the plan administrator determined these contracts should be included as plan assets and recorded a transfer in of approximately \$10,000,000. For the years ended December 31, 2011 and 2012, the plan administrator identified additional contracts that should be included as plan assets and recorded a transfer in of approximately \$83,000 and \$1,700,000, respectively. No such additional contracts have been identified since 2012.

Due to the unavailability of the Plan's prior year records with respect to investments recorded as transfers in during 2010 through 2012, the extent to which individual participant account balances accumulated from inception until inclusion in the Plan's financial statements may be misstated is not determinable. As a result, the propriety of the related participant balances at December 31, 2024 and 2023 and related participant distributions to participants who terminated and withdrew from the Plan during the years then ended is also not determinable.
