Basis for Opinion

NOTE 1 DESCRIPTION OF PLAN

The following description of Pointe Group Care 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Pointe Group Care, LLC, Eastpointe Rehab Center, LLC, Southpointe Rehab Center, LLC, Baypointe Rehab Center, LLC, Pleasant Bay of Brewster Assisted Living Center, LLC, Pleasant Bay of Brewster Rehab Center, LLC, Salem Rehab Center, LLC, Wilmington Rehab Center, LLC, Seashore Pointe Rehab Center, LLC, Naples Assisted Living Facility, LLC, Naples Rehab Center, LLC, Northbridge Assisted Living Facility, LLC, Northbridge Day Care Center, LLC, Northbridge Rehab Center, LLC, Paddock Ridge Assisted Living Facility, LLC, Pleasant Bay of Brewster Assisted, LLC, Seashore Pointe Service CO, LLC, Venice Assisted Living Facility, LLC, Venice Rehab Center, LLC, and AdviniaCare Newburyport LLC and AdviniaCare Newton Wellesley, LLC, (collectively referred to as the "Sponsor" or "Employer").

The Plan excludes leased employees. Originally effective January 1, 1997, the Plan has been amended throughout the years to comply with tax legislation and was restated January 1, 2009, March 31, 2015, December 1, 2017 and July 1, 2019 pursuant to the provisions on the Pension Protection Act ("PPA"). The Plan is subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Eligibility

To be eligible for the Plan, employees must be 21 and have completed three months of service. Upon completion of the service period, an eligible employee may join the Plan on the first day of the following quarter. Participants with at least one year of service and 1,000 hours are eligible to receive employer matching and discretionary employer contributions.

Contributions

Each year, participants may contribute any percentage of pretax annual compensation, as defined in the Plan, subject to certain IRS limitations. Participants who have attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan.

Contributions (continued)

Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Employer may decide each Plan year whether to make a discretionary non-elective matching contribution to the Plan based on the employees' amount of deferral contributed to the plan. The Employer may also decide each Plan year whether to make a discretionary non-elective profit-sharing contribution on behalf of eligible active participants. For the year ending December 31, 2024, the Sponsor elected to make a matching contribution of 25% up to the first 4% of base compensation deferred upon. No profit-sharing contributions were made for the year ended December 31, 2024.

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the vested balance in the participant's account. The loan interest rates are commensurate with local prevailing rates as determined by the Plan. Principal and interest are paid ratably through payroll deductions.

Participant Accounts

Each participant's account is credited with the participant's contributions, Employer matching contributions, allocations of the Employer's profit-sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual net earnings thereon. Vesting in the Employer's discretionary profit sharing and matching contribution portion of their accounts plus actual earnings thereon is based on years of service. A participant is 20% vested after one year, with a 20% increase in each succeeding year until becoming fully vested after the fifth year of service. However, participants who are employed on or after their 65th birthday become immediately vested in these contributions.

NOTE 1 DESCRIPTION OF PLAN (continued)

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or annual installments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$5,521 and \$3,894, respectively. Forfeited balances are made available to pay administrative expenses, reinstate previously forfeited account balances of former participants who have been reemployed by the Employer, and to reduce the Employer's contributions. For the year ended December 31, 2024, \$39,641 of nonvested accounts were forfeited, and \$38,014 was used to pay administrative expenses resulting in a net increase of \$1,627.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged to the participants account and are recorded as administrative expenses when incurred. The Plan has not established an allowance for credit losses as of December 31, 2024 or 2023, because loans are repaid directly from participants' payroll and are expected to be fully collectible.

Payment of Benefits

Benefit payments are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are included in administrative expenses.

NOTE 3 CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by John Hancock Life Insurance Company (the custodian of the Plan).

NOTE 4 FAIR VALUE MEASUREMENTS

The Plan's financial instruments are reported in accordance with ASC 820, which establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan can access.

Level 2: Inputs to the valuation methodology include a) quoted prices for similar assets or liabilities in active markets, b) quoted prices for identical or similar assets or liabilities in inactive markets, c) inputs other than quoted prices that are observable for the asset or liability or d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual Funds: Mutual funds represent investments with various investment managers. The fair value of these investments is determined by reference to the fund's underlying assets, which are principally marketable equities and fixed income securities. Shares held in mutual funds traded on national securities exchanges are valued at quoted market prices as of December 31, 2024 and 2023.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their employer contributions.

NOTE 6 TAX STATUS

The underlying non-standardized prototype plan has received an opinion letter from the IRS dated September 30, 2014, stating that the form of the Plan is qualified under Section 401 (a) of the Internal Revenue Code ("IRC"), and therefore, the related trust is tax exempt. In accordance with Revenue Procedures 2012-6 and 2011-49, the plan administrator has determined that it is eligible to and has chosen to rely on the current IRS prototype plan opinion letter. The prototype plan has been amended since receiving the opinion letter. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2024.

NOTE 7 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with these investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 8 PARTIES IN INTEREST

Certain plan investments are managed by John Hancock Life Insurance Company, custodian of the Plan and, therefore, these transactions qualify as party-in-interest transactions. The Plan made a direct payment to John Hancock Life Insurance Company of \$96,212.

Additionally, The Plan paid \$31,500 for investment advisory services and third-party administration services which are included in administrative expenses. These services qualify as exempt party-in-interest transactions. Participants' notes receivable also qualifies as party-in-interest transactions.

NOTE 9 SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through September 25, 2025, the date the financial statements were available to be issued.
